PREAMBLE FOR PROCEDURAL AND INTERPRETIVE RULES TAKE RELATING TO GUN REPAIR SHOP EXEMPTIONS

PROGRAM: Law Enforcement

REGULATIONS: Gun Repair Shop Exemptions, Series IV-G (Procedural) and Series IV-H (Interpretive).

AUTHORITY: West Virginia Code, Chapter 20, Article 2, Section 58; Chapter 61, Article 7, Section 12; and Chapter 29A, Article 3.

ACTION: Proposed Rules and Request for Comments

TOPIC: Series 4G establishes procedures for granting gun repair shop operators exemptions from the law prohibiting the discharge of a firearm within five hundred feet of any dwelling house or within four hundred feet of any schoolhouse or church. Series 4H provides guidance to gun repair shop operators concerning safe test firing sites.

DATES: A public hearing will be held on Monday, November 17, 1986 at 3:00 p.m. in the Director's Conference Room 674, 1800 Washington Street East, Charleston, West Virginia. Comments will be received until the close of business on Wednesday, November 19, 1986.

SUMMARY: Under Sections 20-2-58 and 61-7-12 of the West Virginia Code, the Director is authorized to grant exemptions to the operators of gun repair shops which allows the test firing of a firearm under certain circumstances. The Director may grant such exemptions provided that he "shall ensure that any person residing in any dwelling home within five hundred feet of such gun repair shop be given an opportunity to protest the granting of such exemption."

The Department's proposed rulemaking addresses two of the four possible exemptions available under Sections 20-2-58 and 61-7-12 of the West Virginia Code. Under the proposed procedural rules (Series IV-G), the operator of a gun repair shop may be granted an exemption to allow the test firing of firearms (1) within five hundred feet of any dwelling house and (2) within four hundred feet of any school or church. Series IV-G establishes the procedures to be followed and the form to be used in applying for this exemption. The proposed rules also set forth the manner in which objections to a grant of exemption will be addressed. The

proposed interpretive rules (Series IV-H) provide guidance concerning safety requirements to be followed by gun repair shops under a grant of exemption.

The Department is not proposing rules on the other two categories of exemption: (3) the discharge of a firearm "across or in any public road in this State" or (4) the discharge of a firearm "on or near any park or other place where persons gather for purposes of pleasure." We decline to adopt rules for these exemptions for several reasons.

Statutory amendments in 1985 created the four categories of exemptions and provided the Director with the authority to promulgate rules to govern the granting of such exemptions. When creating the exemptions, the Legislature sought to assure that relevant members of the public had the right to protest the granting of an exemption. Members of the public who are allowed to protest can be clearly identified for exemptions granted for test firing within five hundred feet of a dwelling or within four hundred feet of a schoolhouse or church. The statutory amendments do not however provide any guidance for identifying the relevant public for the other two categories of exemption. Therefore, the Department is not establishing procedures for protest in cases where the group upon whom the Legislature intended to convey the right of protest cannot be readily identified.

The Legislature specifically granted the right of protest to "any person residing in any dwelling home within five hundred feet of (a) gun repair shop." Using this as a guide, the Department has extended the right to protest a gun repair shop exemption to: "the principal, school personnel, and the parents of students of any schoolhouse located within four hundred feet of a test firing site" and "any member of a church located within four hundred feet of a test firing site."

Identifying relevant members of the public for the two remaining categories is not easily accomplished. It appears that the Legislature intended to grant the right of protest to individuals who would be affected by an exemption, such as persons residing within five hundred feet of the gun repair shop. The Department is reluctant to use a broader definition of identification due to the administrative unworkability and inherent unfairness in extending the right of protest to any member of the public who may use a public road or who may gather at a place "for purposes of pleasure." The Department does not know of an adequate method for notifying such categories of people of their right to protest. Any method would be either too expensive or fail to reach all of the potential users and, thus, would be inherently unfair.

There exist other reasons for not adopting rules covering these two categories. First, the Department does not know how the Legislature intended the phrase "places where people gather for purposes of pleasure" to be interpreted. Second, the Department

does not believe that it would be proper to issue exemptions that would allow the test firing of firearms across or in public roads. Consequently, today's proposed rulemaking addresses procedures for only two of the four categories contained in Sections 20-2-58 and 61-7-12 of the West Virginia Code.

Gun Repair Shop Exemptions State

Procedural Rules

Section 1. Scope and Authority

- 1.1 Scope and Purpose. The purpose of these rules is to establish the procedures for obtaining a gun repair shop exemption to the law prohibiting the discharge of a firearm within five hundred feet of any dwelling house or within four hundred feet of any schoolhouse or church.
- 1.2 Authority. These rules are promulgated under the authority of the West Virginia Code, Chapter 20, Article 2, Section 58; Chapter 61, Article 7, Section 12; and Chapter 29A, Article 3.
- 1.3 Effective Date. These rules will be effective 30 days after filing.
- 1.4 Filing Date. These rules were filed on ______, 1986.

Section 2. Definitions

- 2.1 Applicant means the operator of a gun repair shop duly licensed under applicable federal and state laws.
- 2.2 Application means an Application for a Gun Repair Shop Exemption in the form prescribed in Appendix A of these rules.
- 2.3 Church means a place of worship other than a dwelling house.
- 2.4 Church Representative means the minister, pastor, priest, rabbi, elder, or other individual duly authorized to represent a church congregation.
- 2.5 Department means the West Virginia Department of Natural Resources.
- 2.6 Director means the Director of the West Virginia Department of Natural Resources.
- 2.7 Division means the Division of Law Enforcement of the West Virginia Department of Natural Resources.
- 2.8 Exemption means an exemption from the law prohibiting the discharge of a firearm within five hundred feet of a dwelling house or within four hundred feet of a schoolhouse or church.
- 2.9 Legal Advertisement means a Class I legal advertisement as defined in Chapter 59, Article 3 of the West Virginia Code.

2.10 Public Notice means an announcement, in the form prescribed in Appendix B of these rules, stating that the operator of a gun repair shop is seeking a grant of exemption from the Department to allow the discharge of firearms on or near the repair shop premises.

Section 3. Application Procedures

3.1 The operator of a gun repair shop seeking an exemption will complete and submit an application to the Division of Law Enforcement, Department of Natural Resources, Room 840, 1800 Washington Street, East, Charleston, West Virginia 25305.

Section 4. Notice Requirements

- 4.1 The applicant will send a public notice by certified mail to:
- 4.1.1 Each head of a household residing within five hundred feet of the test firing site.
- 4.1.2 The principal of any schoolhouse located within four hundred feet of the test firing site.
- 4.1.3 The church representative of any church located within four hundred feet of the test firing site.
- 4.2 Certified mail receipts will be kept by the applicant for inspection by Division personnel until the grant of exemption has been either approved or disapproved by the Department.
- 4.3 The applicant will also publish a legal advertisement in a newspaper of general circulation in the community in which the applicant's business is located. The advertisement will contain the information provided in the public notice. A copy of the advertisement showing the name of the newspaper and the date of publication will be sent with the application submitted to the Department.

Section 5. Objections to a Grant of Exemption

- 5.1 The following individuals may protest the granting of an exemption to an applicant:
- 5.1.1 Any individual who resides within five hundred feet of the test firing site.
- 5.1.2 The principal, school personnel, and the parents of students of any schoolhouse located within four hundred feet of a test firing site.
- 5.1.3 Any member of a church located within four hundred feet of a test firing site.

5.2 Division personnel will investigate in a timely manner all substantive written objections to the granting of an exemption that are received by the Department within thirty days after the receipt of an application.

Section 6. Inspections

6.1 Test firing facilities will be inspected by Division personnel prior to the granting of an exemption and at any time thereafter when deemed necessary.
