The Board in session June 13, 2001 approved for filing proposed legislative rule CSR titled Fees for Services Rendered by the Board.

A brief summary of the rule follows:

This legislative rule outlines the fees for services rendered by the West Virginia Board of Examiners for Registered Professional Nurses (Board).

Currently, the fees for services are intermingled throughout the various rules of the Board. Placing all fees into one rule provides easier access to the information by the public and those being regulated. The only changes in the current fees are for the following:

- 1. The returned check fee is being increased to \$20.00; and
- 2. The fee for making copies of documents is for \$3.00 for the first page and \$.25 for each page thereafter.

The following fees have been added:

- 1. Announcement of Advanced Practice is \$35.00;
- Continuing Education Provider Fee is \$100.00; and
- 3. Continuing Education Provider Maintenance Fee is \$25.00.

Currently, the Board does not charge for any of the services for the above three (3) fees. These application processes utilize a great deal of monetary and staff resources to complete.
