Dear Secretary Manchin:

The West Virginia Board of Examiners for Registered Professional Nurses in session June 29, 2004 approved for filing, the proposed emergency rule CSR §19-12 titled Fee for Services Rendered by the Board and Supplemental Renewal Fee for the Center for Nursing.

A brief summary of the rule follows:

This legislative rule has one (1) emergency portion. The other changes are not for emergency consideration. The emergency portion relates to §19-12-2.7 which results from HB 4143 providing for the establishment of the West Virginia Center for Nursing.

The other changes in the rule are for the purposes of providing the Board with the funds to accomplish their legislative charge to protect the citizens of West Virginia through the accomplishment of their mission and goals.

A statement of circumstances requiring the rule follows:

Pursuant to WV Code §30-7A-7a the Board is required to promulgate rules to provide for the collection of a supplemental fee to be assessed with the license renewal fee to be used for funding the West Virginia Center for Nursing. The Center is to be established on July 1, 2004. The license renewals occur each year between September and December. In order to collect the fee during this renewal season and at the beginning of the establishment of the Center, the fee needs to be established through an emergency rule.

Pursuant to WV Code §30-7-4 the Board has the authority to promulgate rules to establish fees to support the business of the Board. The increase in the fees for endorsement, reinstatement, midwife initial license application and midwife renewal will provide some of the revenue required for the Board to accomplish its legislative mandates, mission and goals.
