

§19-12-1. General

- 1.1. Scope. -- This legislative Rule establishes the fees to be charged by the board for services rendered and the supplemental fee for the West Virginia center for nursing.

- 1.4. Effective Date. -- June 12, 2013

§19-12-2. Schedule of Fees for Services Rendered by the West Virginia Board of Examiners for Registered Professional Nurses and Supplemental Fee for the West Virginia Center for Nursing.

Fees collected by the board are not refundable.

- 2.2. Re-Examination \$70.00
- 2.3. Temporary permit (Endorsement) \$25.00 (Money Order or Cashiers Check
Good for six months from date of issue; Not renewable.)
- 2.4. Endorsement into West Virginia \$100.00 (Money Order or
Cashiers Check)
- 2.5. Verification of Licensure \$30.00 (Money Order or Cashiers Check)
- 2.6. Renewal of License \$ 65.00
*\$10.00 of this fee is designated for the West Virginia Center for Nursing.
\$15.00 shall be deposited directly into a Fund designated for programs
related to the monitoring of nurses with substance use disorders and
qualifying mental health conditions.
- 2.7. Supplemental Renewal Fee for the Center for Nursing \$10.00
- 2.8. Reinstatement of Inactive License \$25.00
- 2.9. Reinstatement of Lapsed License \$115.00
- 2.10. Duplicate License and Name Change \$ 10.00
- 2.11. Transcripts \$5.00
- 2.12. Frameable Certificate (Free to new Graduate Licensee) \$5.00
- 2.13. Insufficient Funds Penalty \$25.00 (Money Order)
