However, accountability, at least for the present, extends so far as our curriculum and does not involve advising students on course selection and career paths (PEP), which up until this point, has remained an exclusive guidance responsibility. Why teachers are now going to be given additional work and responsibility is beyond me? I have several questions that need to be answered before I am comfortable being assigned a role for which I am not trained. 1)When and how would time be set aside for this new guidance activity? It looks as though time would be lost from instruction in order to satisfy this obligation. 2) Will there be additional pay for teachers now that we are taking on additional work and responsibility? 3) What are the additional liability questions, and possible actions, associated with advising students in an area where we have no expertise, or training? 4) Will sufficient training being offered! to teachers so that we may efficiently, and with informed knowledge, advise our students on their career paths? 5) Will this training be offered at our current daily rate? We need fewer offers of "stipends" for additional time required of us in order to fulfill our ever increasing load of responsibilities.6) Has the state BOE figured out a way to extend the day past the normal 24-hour period? Apparently, teachers are going to need an extension.

It's time to stop seeing teachers as endless depositories into which one may dump additional responsibilities simply based on the erroneous assumption that "teachers don't do anything anyway." Many state residents seem to hold the flawed opinion that teachers don't earn their money and should be, therefore, willing to accept additional work in order to continue to justify their existence. I have to admit that this PEP scheme is one of the crazier plans to come skipping down the primrose path in recent memory. When are teacher's supposed to have any time for our own families and our responsibilities to them? Until all of the above questions are satisfactorily answered, I cannot support additional work and responsibilities being summarily assigned to us because some collection of bureaucrats have decided that it seems like a good idea. Double work means double pay. As Shakespeare would have remarked, "What say you?"

By the time we provide students with the required grab and go snack time, a thirty minute lunch, and the required time in each of their core classes, there is no additional time for an extra thirty minutes of physical activity. Though we agree that students need to be physically active, we also see first-hand the need for students to be engaged in learning activities. This additional requirement would take away much-needed time in reading and math instruction, not to mention other important core areas. Approximately 80% of our student body plays a sport after school, and 100% of our student body receives 18 weeks of physical education class. That is enough for the school to require -- at some point, parents need to assume responsibility for their children's well-being.
