RESPONSE TO COMMENTS

On June 5, 2015, the Division of Air Quality (DAQ) commenced a thirty day public comment period and subsequently held a public hearing on July 6, 2015 to accept oral comments on proposed revisions to legislative rule 45CSR39. Written comments were also accepted through 6:00 PM on Monday, July 6, 2015. No commenter submitted written comments regarding proposed revisions to rule 45CSR39, and no commenter provided relevant verbal comment.
