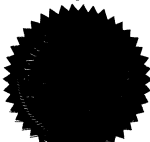
WHEREAS, on February 28, 2018, I issued Executive Order 6-18, creating the Public Employee Insurance Agency Stability Task Force;

WHEREAS, I issue the following Executive Order 8-18 to amend the following two provisions, with all other provisions previously set forth therein.

NOW, THEREFORE, I, JIM JUSTICE, by virtue of the authority vested in me as Governor of the State of West Virginia, do hereby ORDER 6-18 be amended as follows:

3. (b) Thirteen (13) members as the Governor, at his discretion, may appoint, having particular knowledge and expertise of the insurance industry and business.
5. The Task Force shall also elicit public input from West Virginia state employees, their families, and West Virginia public retirees, by coordinating not less than four regional public hearings across the state and other such hearings, committee meetings and subcommittee meetings as the Task Force shall deem necessary.
