"Any independent expenditure in the amount of one thousand dollars or more for any statewide, legislative or multicounty judicial candidate or in the amount of five hundred dollars or more for any county office, single-county judicial candidate, committee supporting or opposing a candidate on the ballot in more than one county, any municipal candidate on a municipal election ballot, which is made after the eleventh day but more than twelve hours before the day of any election shall be reported, on a form prescribed by the Secretary of State within twenty-four hours after the expenditure is made or debt is incurred for a communication" West Virginia Code §3-8-2(b)
