The annual reporting period begins on the last Saturday in March and continues for 6 days. In an election year, the report is called the "first primary" report for candidates who plan to run in the primary election. The first general reporting period begins on the first Saturday in September and continues for 6 days.

Candidates who do not have to file a financial report may instead file a Statement of Waiver. This Statement of Waiver tells the public and press that the candidate is not required to file a financial report.

NOTE: THE STATEMENT OF WAIVER CANNOT BE FILED IN PLACE OF ANY PRE-PRIMARY, POST-PRIMARY, PRE-GENERAL, OR DOST CENERAL ELECTION REPORT
