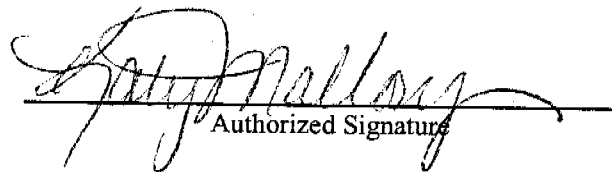

Chairman Russell Isaacs called the meeting to order. He then asked Ms. Mallory to give an overview of the proposed legislative rule changes.

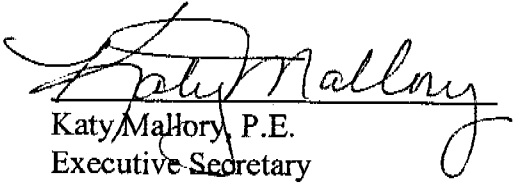

These changes include reducing the average water usage from 4500 gallons per month to 4000 gallons per month and the second change is to replace Appendix A which incorporates 1990 census data with 2000 census data with respect to median household incomes.

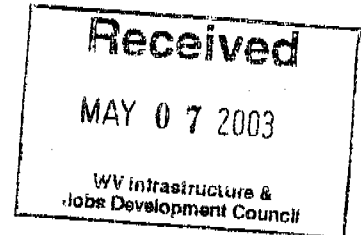

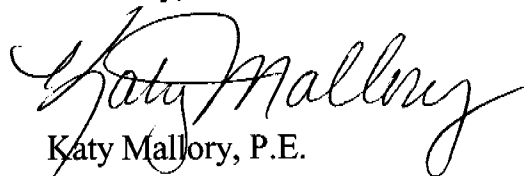
Dear Secretary Manchin:

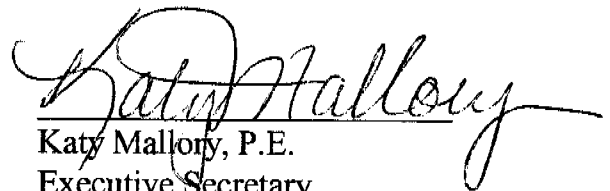

Chairman Russell Isaacs called the meeting to order. He then asked for corrections to the minutes of the May 7, 2003 meeting. Mr. Dwight Calhoun moved the approval of the minutes as amended. Ms. Debbie Legg seconded the motion and the motion carried.

Financial Report

The monthly financial report was presented to the Council for its review.

Projects Recommended to Pursue Funding Sources Other than Infrastructure Fund Assistance:

The following projects were recommended by the Funding Committee to pursue funding sources other than Infrastructure Fund assistance:

Beech Bottom, Village of, 2002W-688, (water project) - Mr. Walt Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Village of Beech Bottom utilize the \$554,355 Federal Special Appropriations grant and pursue a \$637,746 Small Cities Block Grant to fund this \$1,192,101 project. Mr. Bernie Yonkosky moved that the Funding Committee recommendations be approved. Mr. Ivey seconded the motion and the motion carried.

Cairo, Town of, 2003W-748, (water project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Town of Cairo pursue a \$250,000 Small Cities Block Grant to fund this project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

Charleston Sanitary Board, City of, 2002S-704, (sewer project) - Mr. Mike Warwick gave a brief overview of the revised project. The Funding Committee recommendation for this project is the City of Charleston Sanitary Board pursue a \$8,637,662 Clean Water State Revolving Fund loan and a \$875,000 City contribution to fund this \$9,512,662 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Ms. Legg seconded the motion and the motion carried.

Grantsville, Town of, 2003W-747, (water project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Town of Grantsville pursue a \$700,000 Small Cities Block Grant to fund this project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Randy Moore seconded the motion and the motion carried.

Kermit, Town of, 2003S-754, (sewer project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the Town of Kermit pursue a \$617,000 Clean Water State Revolving Fund loan and a \$1,500,000 Small Cities Block Grant to fund this \$2,117,000 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Mike Johnson seconded the motion and the motion carried.

Mannington, City of, 2001W-586, (water treatment plant project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the City of Mannington utilize the \$1,025,000 Rural Utilities Service loan, pursue a \$210,000 Rural Utilities Service grant, a \$1,500,000 Small Cities Block Grant and a \$160,000 Drinking Water Treatment Revolving Fund design loan to fund this \$2,895,000 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

McDowell County Public Service District (Iaeger), 2000W-560, (water project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the McDowell County Public Service District pursue a \$1,500,000 Small Cities Block Grant and \$1,794,500 Rural Utilities Service grant/loan assistance to fund this \$3,294,500 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

Milton, City of, 2003W-745, (water project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the City of Milton pursue a \$1,500,000 Small Cities Block Grant and a \$1,290,986 Drinking Water Treatment Revolving Fund loan to fund this \$2,790,986 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

Sistersville, City of, 2003W-749, (water upgrade project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the City of Sistersville pursue a \$530,000 Small Cities Block Grant to fund this project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried. Mr. Jim Williams inquired as to why 2" line was being used. Mr. Ivey replied that 2" line was being used for house connections.

Wheeling, City of, 2003S-750, (sewer project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the City of Wheeling utilize the \$2,425,000 US Environmental Protection Agency Special Appropriations grant and pursue a \$13,163,000 Clean Water State Revolving Fund, Water Development Authority and/or Private loan(s) to fund this \$15,588,000 project. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

The following project was recommended by the Funding Committee to pursue Infrastructure Funding:

Athens, Town of, 2001S-646, (sewer wastewater treatment plant project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the Town of Athens should utilize the \$2,262,000 Clean Water State Revolving Fund loan and appears eligible for Infrastructure Fund assistance of \$803,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$3,065,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

Cheyman Public Service District, 2003S-746, (Winifrede Hollow sewer extension project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the Cheyman Public Service District pursue a \$1,500,000 Small Cities Block Grant, a \$1,000,000 Kanawha County Commission contribution and appears eligible for Infrastructure Fund assistance of \$2,000,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$4,500,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Ms. Legg seconded the motion and the motion carried.

Delbarton, Town of, 2003S-751, (sewer upgrade project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the Town of Delbarton pursue a \$1,500,000 Small Cities Block Grant, a \$1,500,000 Appalachian Regional Commission grant and appears eligible for Infrastructure Fund assistance of \$2,792,385 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$5,792,385. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Johnson seconded the motion and the motion carried.

Flatwoods-Canoe Run Public Service District, 2003S-744, (sewer upgrade and extension project) - Mr. Warwick gave a brief overview of the project. The Funding Committee recommendation for this project is the Flatwoods-Canoe Run Public Service District pursue a \$1,500,000 Small Cities Block Grant and/or Appalachian Regional Commission and a \$9,360,750 Clean Water State Revolving Fund loan. It also appears the District is eligible (in lieu of the Clean Water State Revolving Fund loan) for an Infrastructure Fund loan of up to \$9,360,750 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$10,860,750. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

Lewis County Commission / Lewis County EDA, 2003W-742, (water extension project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Lewis County Commission utilize the \$581,000 West Virginia American Water Company contribution, pursue the \$1,500,000 Small Cities Block Grant and appears eligible for an Infrastructure Fund loan of \$3,644,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$5,725,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

Lubeck Public Service District, 2002W-669, (Wadesville water extension project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Lubeck Public Service District pursue a \$750,000 Small Cities Block Grant and appears eligible for an Infrastructure Fund loan of \$650,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$1,400,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

Mountain Top Public Service District, 98W-394, (water extension project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Mountain Top Public Service District pursue a \$675,000 Small Cities Block Grant and appears eligible for an Infrastructure Fund loan of \$400,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$1,075,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Calhoun seconded the motion and the motion carried.

Salt Rock Water Public Service District, 2003W-755, (water extension project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Salt Rock Water Public Service District utilize the \$298,000 West Virginia American Water Company contribution, pursue the \$1,500,000 Small Cities Block Grant, \$102,000 Cabell County Commission contribution and a \$500,000 Appalachian Regional Commission grant to fund this \$2,400,000 project. In lieu of the Appalachian Regional Commission grant it appears the District is eligible for Infrastructure Fund assistance of \$500,000 pending final determination of the project's eligibility and readiness to proceed. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion carried.

Valley Falls Public Service District (Phase I), 2002W-684a, (water upgrade project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Valley Falls Public Service District appears eligible for an Infrastructure Fund loan of \$1,765,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$1,765,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

Valley Falls Public Service District (Phase II), 2002W-684b, (water upgrade project) - Mr. Ivey gave a brief overview of the project. The Funding Committee recommendation for this project is the Valley Falls Public Service District appears eligible for an Infrastructure Fund loan of \$1,650,000 pending final determination of the project's eligibility and readiness to proceed. Total project cost is \$1,650,000. Mr. Yonkosky moved that the Funding Committee recommendation be approved. Mr. Moore seconded the motion and the motion

At the June 2, 2003 meeting of the Council for Community and Economic Development it was recommended that the Infrastructure Council approve the following revisions to the original loan of \$3,000,000 approved in April 2000. 1) Revise funding sources, 2) reduce loan amount to \$2,625,000, 3) reduce forgivable portion of loan to \$1,125,000, 4) delete requirement that a minimum of 3 acres, at total cost of \$750,000 must be sold prior to loan closing, 5) and add condition that loan can be closed upon substantial completion with the exception of the Kanawha Stone contract. The amount in dispute to be held in escrow on this contract not to be drawn down until resolved. Ms. Legg moved that the Council for Community and Economic Development recommendation be approved. Mr. David Warner seconded the motion and the motion carried.

**Economic Development
Projects Recommended for
Revised Loan:**

The following project was recommended by the West Virginia Economic Development Council for a revised loan:

Benedum Airport Authority / Mid-Atlantic Aerospace Complex, 99E-023, (land development) - Ms. Legg gave a brief overview. The initial loan of \$3,000,000 was approved by Council on September 11, 1995. At its June 2, 2003 meeting the Council for Community and Economic Development approved a request for the following loan revisions from the Benedum Airport Authority. 1) Transfer of the loan to the Mid-Atlantic Aerospace Complex, 2) delete security of first lien deed of trust on 55 acres, 3) add security of leasehold deed of trust. Issuing a binding commitment is contingent upon receipt of an agreement for a long-term lease of said property between MAAC and the Benedum Airport Authority and contingent upon receipt of verification from the Benedum Airport Authority of their approval of the loan transfer to MAAC. Ms. Legg moved that the revisions be approved. Mr. Warner seconded the motion and the motion carried.

Business Items

Loan Portfolio

Reporting on the WDA Loan Portfolio Report, Mr. Yonkosky stated that a copy of the Report is provided to the Council. Mr. Yonkosky went on to discuss several loans:

Camden-on-Gauley, the Public Service Commission recommended decision is to impose \$1.00/1000 gallon surcharge. The deficiency should be eliminated in two years. In addition the Public Service Commission staff has met with Craigsville Public Service District to discuss take over of Camden-on-Gauley system (118 customers).

Cameron, was proactive and passed a rate ordinance but customer base filed a petition at the Public Service Commission. Under Municipal appeal Cameron put in emergency rate increase. Mr. Yonkosky stated they are doing a good job.

Craigsville, has applied for a rate increase at the Public Service Commission. The decision is due in June 2003. Mr. Rennie Hill questioned Craigsville taking over Camden-on-Gauley. Mr. Yonkosky stated Craigsville is doing a good job and should be current soon. Camden-on-Gauley sends its wastewater to Craigsville for treatment.

Mingo County Public Service District, has slight deficiency as of last week. The water treatment plant is now up and running (not yet substantially complete) and should become current on payments.

War, has not been responsive to requests for a plan to correct their deficiency. If they don't respond within a week a complaint will be filed with the Public Service Commission.

Mr. Calhoun asked if going forward the Deficiency Report could show the total monetary deficiency of each project. Mr. Yonkosky stated that that could be done but would be very time consuming as these numbers are acquired from the Municipal Bond Commission which has an antiquated system and much of it would have to be done manually. It was agreed that a statement of accounts will be provided on delinquent loans.

2003 Financial Audit

Mr. Yonkosky stated that a copy of the list of Opening of Proposals Received for Audit of the West Virginia Infrastructure Fund is provided to the Council. Gibbons & Kawash is recommended to do the Council's audit for the next three years. The cost is \$6,705 per year with the Water Development Authority preparing the financial statements. Mr. Yonkosky moved that the recommendation be approved. Mr. Warner seconded the motion and the motion carried.

Annual Operating Budget Resolution:

Ms. Mallory presented the Annual Operating Budget Resolution to the Council.

RESOLUTION

WHEREAS, the West Virginia Infrastructure and Jobs Development Council (the "Infrastructure Council") is a governmental instrumentality organized and existing under the laws of the State of West Virginia, particularly Article 15A of Chapter 31 of the Code of West Virginia, 1931, as amended (the "Act") for certain purposes set forth in the Act including encouraging and assisting in a cost effective, coordinated approach to water and wastewater system development as well as the effectuation of job creation; and

WHEREAS, the Infrastructure Council prepares an annual operating budge (the "Budget") each State fiscal year (July 1 to June 30).

NOW THEREFORE, BE IT RESOLVED, by the West Virginia Infrastructure and Jobs Development Council as follows:

The Executive Secretary is hereby authorized to draft an annual Budget for operating expenses which include but not limited to personnel services, contractual services, supplies, printing, travel, office equipment, postage and freight, rentals and printing for the 2004 fiscal year (July 1, 2003 to June 30, 2004) in an amount not to exceed \$400,000.00; and

The Chairman is hereby authorized to review and approve said Budget, and

The Chairman is further authorized to review and approve any revisions to the annual Budget as long as the aggregate amount does not exceed \$400,000.00.

ADOPTED by the West Virginia Infrastructure and Jobs Development Council at a meeting held on the 4th day of June 2003.

Mr. Williams moved that the Annual Operating Budget Resolution be adopted. Mr. Calhoun seconded the motion and the motion carried.

Legislative Rules: Public Hearing Minutes

Ms. Mallory gave a brief overview of the meeting. Chairman Isaacs asked for corrections to the minutes of the May 7, 2003 meeting. Mr. Moore moved the approval of the minutes. Mr. Warner seconded the motion and the motion carried.

Legislative Rules: Secretary of State filing

Ms. Mallory recommended that the Legislative Rules be filed as emergency filing at the Secretary of State. Mr. Moore moved the recommendation be approved. Mr. Ivey seconded the motion and the motion carried.

WVEDA Grant Projects

Ms. Mallory stated that a list of the WVEDA grant projects and the current status of each project is provided to the Council for their information and review.

Uniform Bidding Procedures

Ms. Mallory gave a brief overview. HB 3117 passed last session. These minor changes to the Uniform Bidding Procedures confirm with Bill. The Contractors Association is okay with the changes. The changes have also been sent to the Engineering Council. Mr. Warner moved that the revised Uniform Bidding Procedures for Projects Recommended by the WV Infrastructure & Jobs Development Council be adopted. Mr. Williams seconded the motion and the motion carried.

Mr. Williams questioned the recent situation concerning glass-lined tanks vs welded steel tanks. Ms. Mallory explained that recently a utility bid glass lined tank and a welded tank as an alternate. The welded tank was the lowest bid. The utility selected the glass-lined tank after the engineer provided a life cycle analysis of the two tanks. The Council's policy with regard to not selecting the low bidder is that this be justified in an opinion by the Borrower's Counsel. This was not done in this case and the Executive Secretary was unaware that the low bid was not selected until the low bidder filed a complaint in circuit court. The complaint was dismissed by the court. Ms. Mallory contacted the State's Purchasing Division and was advised that the criteria by which an item is to be selected should be in the bid documents. This issue was discussed at the IJDC May 27, 2003 staff meeting. In this case, as it is already proceeding through the courts, and the contract has been awarded the staff felt that all that could be done was being done. In the future, when a preference occurs, the utility should list the criteria by which it will base its selection in the bid documents.

Revenue Bond Committee

Mr. Calhoun stated that the Request for Proposals were sent May 12, 2003 with due date of May 29, 2003. Five proposals were received and will be discussed today as there is a Committee meeting today directly after the Council meeting.

Committee Reports

Reporting on behalf of the Consolidation Committee, Mr. Moore stated that the Committee had not met.

Reporting on behalf of the Funding Committee, Mr. Yonkosky stated that a copy of the Committee's report is provided to the Council.

Reporting on behalf of the Sewer Technical Review Committee, Mr. Johnson stated that a copy of the Committee's report is provided to the Council.

Reporting on behalf of the Water Technical Review Committee, Mr. Ivey stated that a copy of the Committee's report is provided to the Council.

Other Reports

The following Funding Agency reports were presented to the Council indicating projects receiving funding commitments, authorization to bid or loan/grant closings: Clean Water SRF, Drinking Water SRF, Infrastructure Council and Water Development Authority.

Adjournment

There being no further business, Chairman Isaacs adjourned the meeting.

Need for the Proposed Rule Change

The Infrastructure Council coordinates all the funding agencies for water and sewer projects. It is imperative that all the funding agencies remain consistent in the eligibility requirements. The U.S. EPA has made findings against the federal Clean Water State Revolving Fund and the Drinking Water Treatment Revolving Fund recommending the most current census information be used in determining funding eligibility. Delay in converting to the more up to date census information could delay these federal grant awards. The proposed changes would enable all the agencies to utilize the most current information available during the next federal grant application period (July - October 2003), remain consistent and simplify the funding application process for utilities.

The reduction of the customer usage from 4,500 to 4,000 gallons per month will enable utilities to better plan financially for their critically needed infrastructure projects. The Infrastructure Council received a report indicating that the average usage is actually only 4,000 gallons per month. This would reduce the number of utilities in financial trouble due to inaccurate assumptions which result in utility rate increases to the ultimate customer.

§167-1-1. General.

1.1. Scope and Purpose. -- This legislative rule establishes guidelines to be used by the Council in evaluating any request by a project sponsor for funding assistance for the planning, design, acquisition, or construction of water and waste water projects and the funding of all or any part of such projects through the Infrastructure Fund.

1.2. Authority. -- W. Va. Code §§31-15A-4, 31-15A-5 and 31-15A-10.

1.3. Filing Date. -- August 4, 1998.

1.4. Effective Date. -- May 20, 1999.

§167-1-2. Definitions.

2.1. "Act" means the Infrastructure and Jobs Development Act, W. Va. Code §31-15A-1 et seq.

2.2. "Cost" means, as applied to any project to be financed in whole or in part with infrastructure revenues or funds otherwise provided pursuant to the Act, the cost of planning, acquisition, improvement and construction of the project; the cost of preliminary design and analysis, surveys, borings; the cost of environmental, financial, market and engineering feasibility studies, assessments, applications, approvals, submissions or clearances; the cost of preparation of plans and specifications and other engineering services; the cost of acquisition of all land, rights-of-way, property rights, easements, franchise rights and any other interests required for the acquisition, repair, improvement or

construction of the project; the cost of demolishing or removing any buildings or structures on land so acquired, including the cost of acquiring any lands to which buildings or structures may be moved; the cost of excavation, grading, shaping or treatment of earth, demolishing or removing any buildings or structures; the cost of constructing any buildings or other improvements; the cost of all pumps, tanks, vehicles, apparatus and other machinery, furnishings and equipment; loan or origination fees and all finance charges and interest incurred prior to and during the construction and for no more than six months after completion of construction; the cost of legal services and expenses; the cost of all plans, specifications, surveys and estimates of cost; all working capital and other expenses necessary or incident to determining the feasibility or practicability of acquiring, repairing, improving or constructing any project; the cost of placing any project in operation; and all other costs and expenses of any kind or nature incurred or to be incurred by the project sponsor developing the project that are reasonable and necessary for carrying out all works and undertakings necessary or incident to the accomplishment of any project: Provided, That costs shall not include any amounts related to the ongoing operations of the owner or operator, depreciation thereof or any other cost which the Council or the Water Development Authority has not determined to be consistent with the purposes and objectives of the Act.

2.3. "Council" means the West Virginia Infrastructure and Jobs Development Council created pursuant to Section 3 of the Act.

2.4. "Crisis Situation" means a recent incident such as an act of God (drought, freeze, flood, storm or landslide), or an act of man (chemical spill or vandalism), resulting in an outage or a significant decline in quality or quantity of potable water or the treatment of waste water which poses a serious and immediate threat or endangerment to health for which local funds are not available to resolve: Provided, That a crisis situation caused by an act of man shall not include occurrences resulting from the lack of maintenance; negligence; normal replacement of operating parts, pumps, or systems; or upgrades to achieve compliance with existing or new regulatory standards.

2.5. "Division of Environmental Protection" means the Division of Environmental Protection established under W. Va. Code §22-1 et seq. or any successor to all or any substantial part of its powers and duties.

2.6. "Division of Health" means the Division of Health created in W. Va. Code §16-1 et seq. or any successor to all or any substantial part of its powers and duties.

2.7. "Economic Development Authority" means the Economic Development Authority established under W. Va. Code §31-15 et seq. or any successor to all or any substantial part of its powers and duties.

2.8. "Governmental agency" means any county; municipality; watershed improvement district; assessment district; soil conservation district; sanitary district; public service district; drainage district; regional governmental authority and any other state governmental agency, entity, political subdivision or public corporation or agency authorized to acquire, construct or operate water or waste water facilities or infrastructure projects.

2.9. "Housing Development Fund" means the West Virginia Housing Development Fund established under W. Va. Code §31-18 et seq. or

any successor to all or any substantial part of its powers and duties.

2.10. "Infrastructure Fund" means the West Virginia Infrastructure Fund established in accordance with Section nine of the Act.

2.11. "Infrastructure project" means a project in the State which the Council determines is likely to foster and enhance public health, economic growth and development in the area of the State in which the project is developed, for commercial, industrial, community improvement or preservation or other proper purposes. Infrastructure projects include but are not limited to tourism and recreational housing, land, air or water transportation facilities and bridges, industrial or commercial projects and facilities, mail order, warehouses, wholesale and retail sales facilities and other real and personal properties, including facilities owned or leased by this state or any other project sponsor, and includes, without limitation (1) the process of acquiring, holding, operating, planning, financing, demolition, construction, improving, expanding, renovation, leasing or otherwise disposing of the project or any part thereof or interest therein, and (2) preparing land for construction and making, installing or constructing improvements on the land, including water or waste water facilities or any part thereof, steam, gas, telephone and telecommunications and electric lines and installations, roads, bridges, railroad spurs, buildings, docking and shipping facilities, curbs, gutters, sidewalks, and drainage and flood control facilities, whether on or off the site.

2.12. "Infrastructure revenue" means all amounts appropriated by the Legislature; all amounts deposited into the Infrastructure Fund; any amounts received, directly or indirectly, from any source for the use of all or any part of any project completed pursuant to this Act; and any other amounts received by the State Treasurer, the Council or the Water Development Authority for the purposes of the Act.

2.13. "Need of the project sponsors" means there is a public need for a project. The Council shall construe a population increase evidenced by the last two decennial censuses in a county in which a project is proposed, as a factor supporting the conclusion that a need exists for projects in that county.

2.14. "Project" means any waste water facility or water facility project, or any combination thereof, constructed or operated or to be constructed or operated by a project sponsor.

2.15. "Project sponsor" means any person or governmental agency, or any combination thereof, including, but not limited to, any public utility, which intends to plan, acquire, construct, improve or otherwise develop a project or infrastructure project.

2.16. "Public Service Commission" means the Public Service Commission of West Virginia created and established under W. Va. Code §24-1-3 or any successor to all or any substantial part of its powers and duties.

2.17. "Person" means any individual, corporation, partnership, association, limited liability company or any other form of business organization.

2.18. "Public utility" means any person or persons, or association of persons, however associated, whether incorporated or not, including, without limitation, any governmental agency, operating a waste water facility or water facility as a public service, which is regulated by the Public Service Commission as a public utility or which is required to file its tariff with the Public Service Commission.

2.19. "State Development Office" means the West Virginia Development Office established under W. Va. Code §5B-2 et seq. or any successor to all or any substantial part of its powers and duties.

2.20. "State infrastructure agency" means the Division of Health, Division of Environmental Protection, Housing Development Fund, Public Service Commission, State Development Office, Water Development Authority, Economic Development Authority and any other state agency, division, body, authority, commission, instrumentality or entity which now receives or in the future may receive applications for the funding of, and provides funding or technical assistance for, the planning, acquisition, construction or improvement of a project.

2.21. "Waste water facility" means all public facilities, land and equipment used for or in connection with treating, neutralizing, disposing of, stabilizing, cooling, segregating or holding waste water, including, without limitation, facilities for the treatment and disposal of sewage, industrial wastes or other wastes, waste water, and the residue thereof; facilities for the temporary or permanent impoundment of waste water, both surface and underground; and sanitary sewers or other collection systems, whether on the surface or underground, designed to transport waste water together with the equipment and furnishings therefor or thereof and their appurtenances and systems, whether on the surface or underground including force mains and pumping facilities therefor.

2.22. "Water Development Authority" means the West Virginia Water Development Authority established under W. Va. Code §22C-1 et seq. or any successor to all or any substantial part of its powers and duties.

2.23. "Water facility" means all public facilities, land and equipment used for or in connection with the collection and/or storage of water, both surface and underground, transportation of water, storage of water, treatment of water and distribution of water for the purpose of providing potable, sanitary water suitable for human consumption and use.

§167-1-3. Projects.

3.1. Project Review. Prior to applying for or receiving any loan, loan guarantee, grant or other funding assistance for a project from any State infrastructure agency, a project sponsor must submit a preliminary application on the Council's form and must receive the Council's recommendation.

3.1.1. If a project sponsor believes that a project is outside the review of the Council, then the project sponsor shall complete only the appropriate sections of the preliminary application form and shall request an exemption from review.

3.2. Exemption from Review. The Council shall exempt a project from the preliminary application review process:

3.2.1. Any project sponsor which either had received acceptable bids for the project or had all funding in place on July 1, 1994.

3.2.2. Any funding from a State infrastructure agency where the recipient of the funding is designated by state or federal law or regulation.

3.2.3. Any funding from any state agency determined by the Council not to be a State infrastructure agency.

3.2.4. Any funding from the governor's civil contingent fund with regard to projects or infrastructure projects.

3.2.5. Any activity funded by a State infrastructure agency determined by the Council to be outside the scope of the definition of project.

3.2.6. Any action taken by the Economic Development Authority pursuant to the authority established in W. Va. Code §31-15 et seq.

3.2.7. The North Fork Hughes River project described in Section 8(d) of the Act.

3.3. Preliminary Application Filing. A project sponsor may file a preliminary application with the Council, at the offices of the Water Development Authority, at any time: Provided, that the preliminary application will not be formally accepted until such preliminary application is presented to the Council at the next regularly scheduled Council meeting, at which time the thirty-day review period shall begin. The Water Development Authority may, but is not required to, circulate the preliminary application to Council members or Council committees in advance of such meeting.

3.4. Preliminary Application Review. Within thirty days of the Council's formal acceptance of a complete preliminary application from a project sponsor, the Council shall either recommend that the project sponsor seek funding or that the project sponsor not seek funding for the project or request additional information if necessary to make a determination.

3.5. Approval. If the Council determines that the project is consistent with the Act, it shall make a written recommendation for the project financing stating: (i) the loan, loan guarantee or grant, or any combination thereof, for which the project sponsor should apply; (ii) the amount or amounts of said loan, loan guarantees or grant; (iii) the source or sources of such funding and (iv) which State infrastructure agency or agencies should consider funding the project, including funding from the Infrastructure Fund.

3.6. Funding of Project. The Council may provide that if the recommended funding sources have not or cannot dedicate money for the project, the project sponsor shall submit a supplement to its preliminary application to the Council for consideration of alternate funding from another funding source or the Infrastructure Fund.

3.7. Denial. If the Council determines that the project is not eligible for funding assistance from any State infrastructure agency, or that the project is not otherwise an appropriate or prudent

investment of State funds, it shall recommend that the project sponsor not seek funding from any State infrastructure agency.

3.8. Recommendations. The Council shall provide a copy of its recommendation, together with a copy of the preliminary application, if not previously provided, to all State infrastructure agencies which are listed in the recommendation as recommended funding sources.

§167-1-4. Review Guidelines.

4.1. Determination of Eligible Projects. When evaluating any request for funding assistance to plan, acquire, construct, improve or otherwise develop a project, the Council and other State infrastructure agencies shall consider the following:

4.1.1. The public health benefits;

4.1.2. The economic development benefits;

4.1.3. The degree to which the project will correct deficiencies involving compliance of water systems or sewage treatment facilities with State or federal laws, regulations or standards;

4.1.4. The degree to which the project encourages effective and efficient consolidation of water or sewage treatment systems consistent with the comprehensive plan developed pursuant to Section six of the Act;

4.1.5. The cost effectiveness of the project as compared with alternatives which achieve substantially the same public health or economic development benefits, including the consideration of system operation and maintenance requirements and providing maximum feasible fire protection;

4.1.6. The availability of alternative sources of funding which could finance all or a part of the project, and the need for the assistance

of the Council to finance the project or attract other sources of funding;

4.1.7. The applicant's ability to operate and maintain the system if the project is approved;

4.1.8. The degree to which the project achieves other State or regional planning goals;

4.1.9. The estimated date upon which the project could commence if funding were available and the estimated completion date of the project;

4.1.10. Such other considerations as the Council may consider necessary or appropriate to accomplish the purpose and intent of the Act.

4.2. Waste Water Guidelines. When evaluating a request for funding a project which will include the construction, improvement, or development of a waste water facility or system, the Council and other State infrastructure agencies shall consider the following:

4.2.1. The improvement of public health by addressing direct human impact due to system malfunctions or inadequately treated sewage; the severity of individual or public water supply contamination; the degree of impact on public bathing areas; and the severity of safety hazards from deteriorated facilities.

4.2.2. The enhancement of economic development by encouraging directly or indirectly development activity and job creation or retention.

4.2.3. The facilitation of enforcement compliance by reducing existence of overload conditions, damage to fish and aquatic life, loss of boating and recreation opportunity, impact on industrial water supply uses, impact on crop irrigation and degradation of streams used for stock watering.

4.2.4. The adequacy, efficiency and social impact; the extent that reorganization or consolidation of facilities will be accomplished;

whether the population will be directly affected; the ongoing ability of the applicant to operate and maintain the project facilities and system; an increase in the reliability of service; and efficiency of the proposed solution when compared with other alternatives.

4.2.5. The enhancement of the State goal of providing waste water treatment in developing or developable but currently unserved areas.

4.3. Water Guidelines. When evaluating a request for funding of a project which will include the construction, improvement, or development of a water facility or system, the Council and other State infrastructure agencies shall consider the following:

4.3.1. The effect on public health; the elimination of an ongoing public health hazard; the elimination of a periodic or potential public health hazard; and the preventive maintenance related to health hazards.

4.3.2. The enhancement of economic development activity and job creation or retention resulting directly or indirectly from the project; the opportunity to use other State programs; and the degree of local distress in the area where the project is located.

4.3.3. The effect on compliance and improvement in water system design, treatment, service, operation and compliance.

4.3.4. The ongoing ability of the applicant to operate and maintain the project facility and system.

4.3.5. The beneficial environmental and social impacts; beneficial environmental impact only; and beneficial social impact only.

4.3.6. The adequacy and efficiency of the water facility or system; the increase in availability of water, water conservation or improvement in aesthetic water quality; the

increase in the reliability of service; and the efficiency of the proposed solution when compared with other alternatives.

4.3.7. The enhancement of the State goal of providing potable water in developing but currently unserved areas.

§167-1-5. Infrastructure Fund Administration.

5.1. Administration of Infrastructure Fund. The Water Development Authority shall administer amounts in the Infrastructure Fund.

5.2. Sources of Money for Fund. The Infrastructure Fund shall consist of infrastructure revenues; any appropriations, grants, gifts, contributions, loan proceeds or other revenues received by the Infrastructure Fund from any source, public or private; amounts received as payments on any loans made by the Water Development Authority from the Infrastructure Fund to pay for the cost of a project or infrastructure project; insurance proceeds payable to the Water Development Authority or the Infrastructure Fund in connection with any infrastructure project or project; all income earned on moneys held in the Infrastructure Fund; all funds deposited in accordance with the Act; and all proceeds derived from the sale of bonds issued pursuant to W. Va. Code §31-15B et seq.

5.3. Use of Moneys in the Fund. Upon the written recommendation of the Council, and subject to the restrictions set forth in the Act, including but not limited to the restrictions set forth below, the Water Development Authority shall use money in the Infrastructure Fund to make loans, loan guarantees or grants, or any combination thereof, and to provide financial, technical or other assistance as necessary to finance all or part of the costs of infrastructure projects or projects to be undertaken by a project sponsor.

5.4. Council Determination. Prior to the Water Development Authority's making any loan,

loan guarantee, grant or other assistance, the Council shall determine that the loan, loan guarantee, grant or other assistance and the manner in which it will be provided are necessary or appropriate to accomplish the purposes and intent of the Act.

5.5. Eligible Grant Recipients. The Council shall not authorize the Water Development Authority to make grants for any project to any project sponsor (i) which is not a governmental agency or a not-for-profit corporation, or (ii) where the project, if funded, will provide subsidized services to certain users in the service area of the project.

5.6. Grant Requirements. The Water Development Authority may make a grant to a project sponsor for a project if the Council in its sole discretion determines and finds that (1) the level of rates for the users would otherwise be an unreasonable burden given the users' likely ability to pay; or (2) the absence of a sufficient number of users prevents funding of the project except through grants. Prior to awarding any infrastructure grant money to a project sponsor, the Council must determine that no other funding is available for the proposed grant portion of the project.

5.7. Grant Criteria. In determining whether a grant should be offered, and, if so, what proportion of the financial assistance offered should constitute a grant and what portion should constitute a loan or other loan assistance, the Council will consider the ultimate effect that financing a project's costs will have on the rates that users will be required to pay.

5.7.1. In performing this assessment, the Council shall review the mandatory minimum end user utility rate that must be met by the project sponsor before grant assistance may be awarded. This mandatory minimum end user utility rate shall be based upon a uniform statewide percentage of the median household income as determined and published by the United States

Department of Commerce, Bureau of the Census, for the geographic area which the project will serve and upon an average customer usage of ~~4,500~~ 4000 gallons per month. The uniform percentage rate shall be .6% of the median household income. The Council shall base its determination on the median household income for the Bureau of Census established minor civil division (MCD) most closely related to the geographic boundaries of the project sponsor as established by law. The minor civil divisions and the median household incomes extracted from the ~~1990~~ 2000 Bureau of Census report are set forth in Appendix A attached hereto and incorporated herein by reference. If the project sponsor provides service to two or more MCD's but does not serve an entire county or if a municipal project sponsor serves outside its corporate boundaries, then the Council shall compute the minimum end user utility rate in accordance with the formula set forth in Appendix A. When determining median household income of a geographic area of the project to be served, the Council shall also consider any surveys of the income of the households that will be served by the project.

5.7.2. The Council may further consider factors including, but not limited to, the financial condition of the applicant, including revenues, expenses, debt structure, reserve balances, available collateral and financial condition of the project sponsor, and the inability of the project sponsor to secure grant funding from other sources.

5.8. Limit on Grant Amount. Any moneys disbursed from the Infrastructure Fund in the form of grants shall not exceed twenty percent of the total funds available for the funding of projects. The Council may limit individual grant awards to whatever amount it deems desirable to advance the intent and purposes of the Act: Provided, That no project sponsor shall receive infrastructure grant money in an amount in excess of fifty percent of the total cost of the project.

5.9. Terms of Grant. Where a project

sponsor has received infrastructure grant money to fund a project, and such project is thereafter sold then to the extent that proceeds are available, the project sponsor shall reimburse the infrastructure fund the amount of the infrastructure grant. In the alternative, the council may allow repayment of the grant by converting the grant into a loan from the infrastructure fund. The proceeds from the repayment of any such grant or grant which has been converted to a loan shall retain their character as proceeds available for grants. The amount of repayment may be reduced by the applicable share of accumulated depreciation of the project or the applicable share of accumulated accelerated depreciation of the project as determined by the Council. The infrastructure council shall review any agreement between the project sponsor and the person or entity purchasing the project to determine whether the agreement was structured so that no proceeds would become available for the repayment of the grant funds. If the infrastructure council finds that the transaction was structured by the parties to intentionally preclude the availability of proceeds for the repayment of the infrastructure grant funds, then the council may require the project sponsor to repay the full amount of any infrastructure grant. The Council shall prepare a report listing those projects which received infrastructure grant money and are sold. The report shall include a description of the terms by which the infrastructure grant will be repaid. The report shall be provided on or before the tenth day of January each year to the Joint Committee on Government and Finance.

5.10. Loans. The Council shall authorize the Water Development Authority to make loans or loan assistance from the Infrastructure Fund on a case-by-case basis based on the need of the project sponsor and upon such terms and conditions as the Council shall recommend. No loan or loan assistance will be authorized where the project, if funded, will provide subsidized services to certain users in the service area of the project.

5.11. Limit on Loan Amount. The Council may limit loans to project sponsors to whatever amount it deems desirable to advance the intent and purposes of the Act.

5.12. Limit on Loan Interest Rate. The interest rate on any loan to governmental, quasi-governmental, or not-for-profit project sponsors for projects made pursuant to the Act shall not exceed three percent per annum. Loans made to for profit entities shall bear interest at the current market rates which shall be the equivalent of the prime rate published as such in the Wall Street Journal, or similar publication, on the date of the loan commitment.

5.13. Financial Assistance from the Fund. Each loan, loan guarantee, grant or other assistance made or provided by the Water Development Authority shall be evidenced by a loan, loan guarantee, grant or assistance agreement between the Water Development Authority and the project sponsor to which the loan, loan guarantee, grant or assistance shall be made or provided, which agreement shall include, without limitation and to the extent applicable, the following provisions:

5.13.1. The estimated cost of the infrastructure project or project, the amount of the loan, loan guarantee or grant or the nature of the assistance, and in the case of a loan or loan guarantee, the terms of repayment and the security therefore, if any;

5.13.2. The specific purposes for which the loan or grant proceeds shall be expended or the benefits to accrue from such loan guarantee or other assistance, and the conditions and procedure for disbursing loan or grant proceeds;

5.13.3. The duties and obligations imposed upon the project sponsor regarding the acquisition, construction, improvement or operation of the project or infrastructure project; and

5.13.4. The agreement of the project sponsor to comply with all applicable federal and state laws, and all rules and regulations issued or imposed by the Council or other state, federal or local bodies regarding the acquisition, construction, improvement or operation of the infrastructure project or project and granting the Water Development Authority the right to appoint a receiver for the project if the project sponsor should default on any terms of the agreement.

5.13.5. Each project sponsor who receives assistance from the Infrastructure Fund for a project must certify to the Council that it will construct any building required for public use with a roof sloped sufficiently to allow for the proper drainage of water.

5.13.6. Funding assistance made from the proceeds of any general obligation bonds and revenue bonds issued after the fifteenth day of March, one thousand nine hundred ninety-eight, after transfers required to make the State match for the water and wastewater revolving loan programs pursuant to article two, chapter twenty-two-c and article thirteen-c, chapter sixteen of the Code, shall be provided by the Council on a pro rata basis divided equally among the congressional districts of the State as delineated in accordance with section three, article two, chapter one of the Code. Infrastructure projects shall not be subject to pro rata distribution.

5.14. Advance Funding Assistance. If the Council determines that the engineering studies and requirements for the pre-application process would impose an undue hardship on a project sponsor, the Council may provide funding assistance to the project sponsor to defray the expenses of such process from moneys available in the Infrastructure Fund: Provided, That such funding assistance is limited to an amount equal to five thousand dollars or fifty percent of the total pre-application cost, whichever amount is greater. If the project is ultimately approved for a loan by the Council, the amount of such funding assistance shall be included in the total amount of

the loan to be repaid by the project sponsor. If the project is not ultimately approved by the Council, the amount of such funding assistance shall be considered a grant by the Council, and the total amount of the assistance shall be forgiven. In no event may the amount of advance funding assistance provided to all project sponsors exceed, in the aggregate, one hundred thousand dollars annually, as determined on a State fiscal year basis.

5.15. Crisis Situation Funding Assistance. The Water Development Authority, upon recommendation of the Council or designated committees of Council, shall make funding available to provide assistance to restore or safeguard water or waste water treatment service following a crisis situation which is an immediate threat or endangerment to the public health, provided, that the project sponsor must notify the Council as soon as reasonably possible following the incident and make application for funding in writing within 30 days of the incident.

5.16. Other Assistance. The Authority, at the discretion of the Council, may provide other forms and methods of assistance in addition to loans and grants, including, but not limited to, bond and loan guarantees and the purchase of insurance for the bonds.

Chairman Russell Isaacs called the meeting to order. He then asked Ms. Mallory to give an overview of the proposed legislative rule changes.

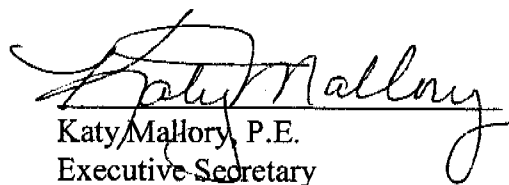

Study Shows Residential Sales Decreasing; Legislative Rule Change Being Planned

A recent study completed for the West Virginia Infrastructure and Jobs Development Council (IJDC) by certified public accountant Michael Griffith of the firm Griffith and Associates reveals that West Virginia's public water systems have been experiencing decreases in residential sales over the past five years. Mr. Griffith presented the findings of his report during the April 2, 2003 IJDC session held in the Erickson Alumni Center on the campus of West Virginia State College. A total of 28 utilities from across the state, including West Virginia American Water Company, were

included in the study. Results show that most water utilities are now experiencing average residential sales of less than the 4,500 gallons per month per customer. That figure has been the traditional benchmark used by the IJDC and the Public Service Commission when conducting rate analyses. Mr. Griffith attributes the decreased residential consumption to more concerted efforts by consumers to reduce their consumption and also to newer and more efficient plumbing fixtures. He also cited the state's aging population as a possible factor since less children are likely to be a part of the average household. Mr. Griffith recommended that 4,000 gallons now be used as the average household usage instead of the current standard of 4,500 gallons. This change he feels would help alleviate future financial problems for utilities.

Acting in part upon these findings, IJDC members have scheduled a public hearing for May 1, 2003 to discuss changes for Legislative Rule 167-1-5. In addition to changing the average usage language contained in Legislative Rule 167-1-5 (4,500 to 4,000 gal-

lons), references to the 1990 census data would be replaced with 2000 data. Also, Appendix A of the rule, containing tabulated 1990 census and rate information for municipalities and counties, would be replaced with 2000 data.

The 42-day period for public comment on this proposed rule change began on April 3rd and will conclude May 15th. The IJDC is expected to approve the revised rule during the June 4th meeting and issue a Council resolution. The revised rule and resolution will then be filed with the Secretary of State's Office for emergency rule consideration. Approval by the Legislative Rule Making Committee would likely take place in mid-July.

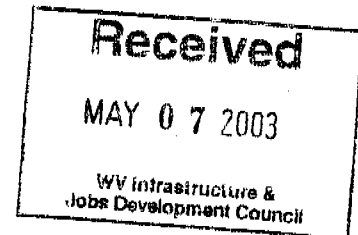

of Berkeley County PSD's facilities management plan and will allow for an interconnection and new booster station at Route 45; main replacements on Gregory Drive and Botany Drive; and for a hydrogeologic study. The existing customer rates will remain unchanged. The 1.5 percent median household income per 4,500 gallons (MHI) was determined to be \$29.70.

The Town of Franklin is planning a number of improvements to its water treatment plant and distribution system with project 98W-379. This project includes the installation of two new storage tanks and pump stations. IJDC members recommended that the Town of Grant seek a \$1,050,000 grant from the Small Cities Block Grant (SCBG) program; a \$1,761,300 loan from the Drinking Water Treatment Revolving Fund (DWTRF); and a grant from the Army Corps of Engineers (COE) or possibly an additional DWTRF loan to finance this \$3,231,300 project. The existing of \$21.63 per 4,500 gallons is expected to increase to \$30.75. The 1.5 percent MHI was shown to be \$27.87.

Silverton PSD is planning to provide wastewater service for the first time with project 2003S-726. This project includes the construction of a collection sys-

tem with manholes, pumping stations, and other appurtenances. A total of 255 new customers will be served by the \$3,550,000 project. Recommended funding consists of \$1,550,000 from the Clean Water State Revolving Fund (CWSRF); a \$500,000 Appalachian Regional Commission (ARC) grant; and a \$1,500,000 COE grant. The proposed rate per 4,500 gallons is \$52.35. The 1.5 percent MHI was listed at \$25.89.

Projects Recommended To Pursue Infrastructure Fund Assistance

The Kanawha County Rural Development Authority was recommended to seek \$257,500 of assistance from either the IJDC or the COE for project 2002W-709. This \$881,000 project will extend water service to 67 new customers in the Upper Fisher's Branch area of Kanawha County. Water for these residents will be supplied by West Virginia American Water Company (WVAWC). This project requires the construction of a new storage tank and a new booster station and the installation of seven fire hydrants. The other recommended funding sources include a \$134,000 contribution from WVAWC and a \$100,000 contribution from the Kanawha County Commission. The rate per 4,500 gallons will be \$36.23. The 1.5 percent MHI income for the area was stated at \$24.57.

The Town of Wardensville was recommended to pursue an Infrastructure Fund loan of \$147,943 and a grant of \$443,827 from the Army COE for project 2000S-523. The

SCBG program was listed as an alternative source for this \$591,770 project that has been designed to protect the municipal wastewater plant from flooding and erosion. The existing rate per 4,500 is \$24.15. The proposed rate has been set at \$26.57. The 1.5% MHI was determined to be \$15.20.

The Weston Sanitary Board is planning several improvements to its wastewater collection system with project 2003S-725. IJDC members recommended that the Weston Sanitary Board pursue a \$450,000 Infrastructure Fund loan and a total of \$1,350,000 from the Army COE to fund this \$1,800,000 project. The existing rate per 4,500 gallons is \$38.43 and the proposed rate was listed at \$39.13. The 1.5 percent MHI for Weston was projected at \$17.92.

Projects Recommended for Infrastructure Fund Binding Commitment

The **Parkersburg Utility Board** received an IJDC binding commitment for a \$926,000 loan for wastewater project 2001S-631b. This \$3,926,000 project calls for the rehabilitation of 19,000 linear feet of sanitary sewers and the replacement of another 7,000 feet. A number of other system improvements are included in this project. A \$3,000,000 loan from either the WDA or the CWSRF program was also recommended. The existing rate of \$25.00 per 4,500 gallons will remain unchanged. The 1.5 percent MHI was listed at \$25.58.

A binding commitment for an \$1,850,000 IJDC loan was issued to **Silverton PSD** for water project 99W-510. This \$4,930,000 project will extend service to 298 new customers in northern Jackson County. A total of \$3,080,000 in grant and loan dollars has been committed to this project by the USDA Rural Utilities Service (RUS). The existing rate of \$26.70 will be increasing to \$34.71 per 4,500 gallons. The 1.5 percent MHI for Silverton PSD was listed at \$26.90.

Walton Public Service District received a binding commitment for a \$100,000 IJDC loan for project 2000W-549. This \$1,000,000 project will extend service to 55 new customers. A total of \$500,000 in grants and loans from RUS has been committed to this project as has an ARC grant of \$400,000. The existing rate was listed at \$24.30. The proposed rate was stated at \$27.90.

The 1.5 percent MHI for **Walton PSD** was shown to be \$20.63.

Flatwoods-Canoe Run Public Service District is planning to add 129 new water customers with project 2002W-665. IJDC members issued a binding commitment for a \$1,476,975 loan for this \$2,976,975 project. A \$1,500,000 committed SCBG grant rounds out the funding for this project that will extend service to the Poplar Ridge area of Braxton County. The existing rate is \$26.59 and the proposed rate was listed at \$27.26. The 1.5 percent median household income was stated at \$24.66.

Prichard Public Service District in Wayne County received a binding commitment for an IJDC loan of \$877,000 and an IJDC grant of \$300,000 for project 2000S-572. This project also received classification by IJDC members as an "emergency project." This status, as defined in State Code 31-15A-2 will enable to project to be completed faster and meet deadlines that are "essential for immediate economic development." A new manufacturing firm is locating in the Prichard Industrial Park and timely completion of this project is critical to the area's economy. This \$3,315,000 project calls for the construction of a new 100,000 gpd wastewater treatment plant that will serve 225 new customers. Other funding sources include an ARC grant of \$1,000,000; and a committed U.S. Economic Development Administration (EDA) grant of \$1,138,000. The proposed rate was listed at \$35.14. The 1.5 percent MHI was calculated to be \$26.03.
