\$42-14-1. General.

1.1. Scope. -- This legislative rule establishes the prevailing wage for building, highway and heavy construction for the successive year.

1.2. Authority. -- W. Va. Code §21-5A-5

1.3. Filing Date. -- January 6, 1994

1.4. Effective Date. -- January 6, 1994

ED. NOTE: As permitted by West Virginia Code §29A-2-7(g) this rule is omitted from duplication in this publication. The rule establishes the wage rates for various construction related positions for each county in West Virginia. West Virginia Code §21-5A-5 requires that these wages be reviewed and determined each year by the Commissioner of Labor and filed with the Secretary of State on January 1, of each year. A copy of this rule or parts of this rule are available from the Secretary of State or the West Virginia Department Division of Labor.


