ADOPTION OF NBS HANDBOOK 130, 1987

§42-16-1. General.

1.1. Scope. -- The National Bureau of Standards (NBS) Handbook 130, 1987 Edition, adopts Uniform Laws and Regulations to achieve, to the maximum extent possible, standardization in weights and measures laws and regulations among the various States and local jurisdictions in order to facilitate trade between the States, permit fair competition among businesses, and provide uniform and sufficient protection to all consumers in weights and measures issues.

1.2. Authority. -- W. Va. Code §47-1-19

1.3. Filing Date. -- April 1, 1988

1.4. Effective Date. -- April 1, 1988

§42-16-2. Incorporation By Reference.

The National Bureau of Standards Handbook 130, 1987 Edition, is hereby incorporated by reference as legislative rules and regulations governing inspectors and county and city sealers in the performance of their duties in accordance with chapter 47, article 1, section 19 of the West Virginia Code.
