SUMMARY OF THE MODIFICATIONS TO THE
REGULATIONS GOVERNING MEAT INSPECTION

The modifications made in this proposed rule are as a result of review and comment by the Legislative Rule Making Review Committee.

Section 4 was revised listing in section 4.1 a reference to the definitions used in the WV code and listing in section 4.2 the terms adopted as changed from the federal code.

Section 5 was changed to specify the dates of the references that are adopted.

Section 6 was changed to specify which licenses are referenced in this section. Section 6.2 was deleted as this section is in the code. Section 6.3 became 6.2. Section 6.4 was deleted as this provision was unnecessary to the implementation of these rules.

Section 7 was revised to delete the word "certificate" in the title and the section as no certificates are issued. References to "official inspection marks" and "inspection legends" were changed where needed to be used according to the existing definitions.

Section 9 was deleted and the former section 10 was renumbered to section 9.

All other modifications were minor technical changes in format and nomenclature suggested and adopted by the committee.
