

§91-18-1. General

1.1 Scope - This rule further defines the word "purchased" as it relates to the issuance of temporary registration plates by motor vehicle dealers pursuant to West Virginia Code §17A-6-15.

1.2 Authority - West Virginia Code §17A-6-15.

§91-18-2. Application and Enforcement

2.1 Application - This rule applies to licensed West Virginia motor vehicle dealers.

2.2 Enforcement - Enforcement of this rule is vested with the Commissioner of Motor Vehicles or lawful designee.

§91-18-3. Temporary Plate Issuance Authorization

3.1 The provisions of Departmental Legislative Rule Series 6, Section 91-6-4.10 relating to the word "purchased" shall also include vehicles delivered by a licensed West Virginia motor vehicle dealer.
