# WEST VIRGINIA ADMINISTRATIVE REGULATIONS

## Department of Natural Resources Chapter 20-1 Series IV (1979) (1980)

Subject: 1979 Hunting and Trapping Regulations

By virtue of the authority granted to the Director and Commissioners of the Department of Natural Resources by Article 1, Chapter 20 of the Code of West Virginia, the following hunting and trapping regulations are hereby promulgated and shall become effective at 12:01 a. m. on ~~March 1, 1979~~; March 1, 1980 and shall remain in effect unless otherwise amended or new regulations are issued.

All seasons, unless otherwise noted, are statewide and subject to change. The opening and closing dates shall be inclusive, except as noted under exceptions. All time periods shall be prevailing time except as otherwise noted. All seasons shall close on previous Saturday if last day falls on Sunday. Sunday hunting is illegal with the exception of raccoon as noted. Should opening dates fall on Sunday the season will open on the following Monday.

1.01. Possession limit--means game which is in any way under the control of the hunter after the second day of the season except raccoon. The daily bag limit of raccoon may be possessed for each day the season is open until the season limit is reached.

Example, the total of all game in a car, trunk, home freezer, commercial food locker, or any other storage method or place.

1.02. Aggregate--means the total bag or possession limit of any similar kind of game animals or birds. Example: the possession limit for squirrels is 24 after the third day. This could be eight gray squirrels, eight fox squirrels, and eight black squirrels; or any combination of 24 squirrels, but not more than a total of six per day, nor more than a total of 24 in possession.

1.03. Protected--no open season. Hunting at any time shall be illegal for protected wildlife.

1.04. Prevailing Time--prevailing time shall be either Eastern Standard Time or Daylight Saving Time and shall be that time proclaimed by the Governor of the State.

1.05. Concurrent Hunting--hunting of other species during deer gun season.

1.06. Big Game--shall be black bear, deer, elk, wild turkey, and wild boar.

## SECTION 2. GENERAL HUNTING RULES

2.01. Hunting with a gun or bow is limited to open fields during the closed season on game birds and game animals.

2.02. Hunting and trapping are forbidden on: (1) All State Parks and Game Refuges; (2) Harpers Ferry National Monument;

(3) All safety zones on State Forests and Public Hunting and Fishing Areas. All refuges are appropriately marked with official Department signs.

2.03. It shall be unlawful to use any poisons, chemicals, or explosives in taking any furbearing animal, game animal, game bird or protected song and insectivorous bird, provided that woodchuck or groundhogs may be controlled on private land by the landowner, his children or a bonafide resident tenant during the period of April 1 through September 30, provided further, that whenever protected birds are committing serious depredation of crops, property, or other interest, the director may authorize the killing of the offending bird.

2.04. No warming or other fires permitted on lands belonging to others without written permission of owners.

2.05. It is illegal to smoke any wildlife from dens, trees, rocks, or any other cover except as otherwise provided by law or regulation. Groundhogs may be controlled on private lands by the landowner.

2.06. Redwinged blackbirds, grackles and pigeons may be controlled by chemicals registered with the West Virginia Department of Agriculture and the Environmental Protection Agency when prescribed and authorized by the director.

2.07. It shall be illegal to discharge a firearm or shoot an

arrow from aircraft, motor-driven watercraft, motor vehicle, any land conveyance or from or across any public road.

### SECTION 3. HUNTING SEASONS

3.01. Deer Firearms season - Bucks only - ~~November 19, 1979 - December 1, 1979~~ - First Monday preceding Thanksgiving for 13 consecutive days in the following counties: Barbour, Berkeley, Boone, Braxton, Brooke, Cabell, Calhoun, Clay, Doddridge, Fayette, (~~N. of New River~~), Gilmer, Grant, Greenbrier, Hampshire, Hancock, Hardy, Harrison, Jackson, Jefferson, Kanawha (~~N. of U.S. 60~~), Lewis, Lincoln, Marion, Marshall, Mason, Mercer, Mineral, Monongalia, Monroe, Morgan, Nicholas, Ohio, Pendleton, Pleasants, Pocahontas, Preston, Putnam (~~N. of U.S. 60~~), Raleigh, Randolph, Ritchie, Roane, Summers, Taylor, Tucker, Tyler, Upshur, Wayne, Webster, Wetzel, Wirt, and Wood.

~~Deer - Firearms season - Bucks only - November 19, 1979 - November 24, 1979 - In the following counties: Boone, Cabell, Fayette (S. of New River), Kanawha (S. of U.S. 60), Lincoln, Logan, Mercer, Mingo, Putnam (S. of U.S. 60), Raleigh, Summers, Wayne and Wyoming. No open season for deer in McDowell County. No buck-only firearm deer season in McDowell, Logan, Wyoming and Mingo Counties.~~

(A) No person may legally take under any condition more than 3 deer per calendar year: One by bow during the archery season; one by gun or bow during the bucks-only season; or one by muzzle-loader if not taken by gun during the regular firearms season; and one

by either bow or gun during the special antlerless season.

(B) After a person has killed a legal deer by either bow or firearm during the regular bow or firearms seasons, he may not participate further in hunting with either a bow or firearm in his possession the remainder of the day. Such a person may, however, pursue his second legal deer any day following, provided it falls within the regular bow or gun season and the established season for the weapon in possession or use, and provided the first deer has been legally checked at an official checking station or by a conservation officer.

(C) Only deer having one or both antlers 3 inches or more in length above the hair will be legal game during bucks-only and muzzle-loading hunting seasons.

(D) No person shall hunt deer with a shotgun using ammunition loaded with more than one solid ball, nor with any rifle using rimfire ammunition of less than .25 caliber. However, this section shall not prohibit any person legally licensed to hunt with a .22 caliber pistol or revolver from humanely killing any deer that has been lawfully wounded or downed by a firearm.

(E) Any rifle using center-fire ammunition or muzzle-loading rifle .44 caliber or larger is legal for deer hunting.

(F) No person shall hunt deer between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise, or kill or wound any deer while the deer is in any stream, lake or pond.

3.02. Concurrent Hunting During Deer Firearms Season:

(A) All hunting, except for deer, shall be prohibited during the first 3 days of bucks-only deer season in all counties having a bucks-only deer season, provided that hunting for waterfowl shall be permitted on lakes, rivers, and waterways during the open waterfowl season.

(B) Small game hunting permitted beginning the fourth day after the opening date of the bucks-only season.

(C) Shot smaller than #4 and slugs may be carried with a shotgun prior to killing a deer during the concurrent hunting period.

(D) A combination rifle-shotgun (over-under, etc.) is legal for deer hunting and during the concurrent small game period.

(E) After killing a legal deer; a successful hunter shall not be afield with any type shotgun with solid ball ammunition or, if using a combination rifle-shotgun he shall not have rifle ammunition in his possession.

(F) It shall be unlawful to hunt small game with any center-fire rifle or rifle larger than .22 caliber rimfire, or shotguns using solid ball ammunition in counties not open to firearm deer hunting.

(G) No small game hunting during antlerless deer season in counties or parts of counties having an antlerless deer season.

(H) ~~No concurrent hunting on state public hunting and fishing areas and state forests during deer muzzleloading season.~~

3.03. Black Bear - (Adult Animals Only) - Firearms season -  
November-9,-1979 --November-10,-1979 and December-10,-1979 --  
December-28,-1979. First Monday following the bucks firearms hunting  
season and 20 consecutive days thereafter. Bear season is open  
(county-wide) only in the following counties: Grant, Pendleton,  
Pocahontas, Randolph, Tucker and that portion of Webster east of  
Route 20 from Webster Springs southwest to the Nicholas County line  
and that section east and south of State Route 15 from Webster Springs  
to the Randolph County line, that portion of Hardy County lying east of  
U. S. Route 220, that portion of Monroe County lying east of U.S.  
Route 219, and that portion of Hampshire County lying south of U.S.  
Route 50. Bear season is also open in that portion of Greenbrier  
County lying north of U.S. 60 from the Fayette County line to its inter-  
section with County Route 9, north of County Route 9 between U.S. 60  
and U.S. 219, and east of U.S. 219 from County Route 9 to its inter-  
section with the Monroe County line.

Two exceptions to this are: Cranberry Closed Area (known as  
the Back Country) lying in Pocahontas, Greenbrier and Webster  
Counties and the Spruce Knob Closed Area lying in Pendleton and  
Randolph Counties are closed to all bear hunting.

The Cranberry Closed Area is bounded as follows: Starting at  
Dyer on Forest Service Route #86, the boundary proceeds along  
Forest Service Route #86 east to the intersection with Forest Service

Route #216; then the boundary follows Forest Service Route #216 to its intersection with Mountain Lick Run. The line then follows Mountain Lick Run to its intersection with the U.S.F.S. boundary and then follows the U.S.F.S. boundary to its intersection with State Route #29/4; then along State Route #29/4 and #39/4 to Forest Service Trail #236. The boundary follows Forest Service Trail #236 north-westward to the Nicholas County line and then proceeds north following the Nicholas County line to Forest Service Route #76; it then follows Forest Service Route #76 north to Forest Service Route #101. The boundary then follows Forest Service Route #101 north to Dyer.

The Spruce Knob Closed Area is bounded as follows:

Starting at the intersection of U.S. Route #33 and the Spruce Knob National Recreation Area boundary about 3 miles west of the Mouth of Seneca, the boundary follows U.S. Route #33 east to the intersection of U.S. Route #33 and State Route #33/3 and then follows the Spruce Knob Recreation Area boundary south to Forest Service Route #55; the line then follows Forest Service Route #55 north to Forest Service Route #1; then proceeds west on Forest Service Route #1 to State Route #29. The boundary then follows State Route #29 north to State Route #29/4 north to the Spruce Knob National Recreation boundary; then follows the Spruce Knob National Recreation boundary north to U.S. Route #33.

(A) No person may legally take more than one bear per calendar year.

(B) Nonresidents shall not train dogs in the state at any time except during the legal small game hunting season.

(C) Residents in counties which have a legal bear hunting season may train their bear hunting dogs between August 24 and February 28, only, provided that except during the firearms bear season, they have no firearms, bow or implement with which the bear could be taken in their possession or under their control.

(D) Bear season will be closed in counties having an antlerless deer season while that season is open.

3.04 ~~Fall Wild Turkey - October 13, -1979 - November 10, -1979; December 10, -1979 - December 15, -1979.~~ Season shall be for twenty-nine consecutive days starting with the Saturday nearest October 15, and for six consecutive days commencing on Monday following the second Saturday in December. Only in the following counties: Berkeley, Grant, Greenbrier, Hampshire, Hardy, Mineral, Monroe, Morgan, Nicholas (East of State Route #20), Pendleton, Pocahontas, Randolph, Tucker and Webster.

~~Fall Wild Turkey - October 13, -1979 - October 27, -1979;~~  
Season shall be for 15 consecutive days starting with the Saturday nearest October 15; Only in Preston County.

(A) Electronic calling devices prohibited during fall turkey season.

(B) Spring Turkey Regulations (Bearded Turkeys Only) - ~~April 23, -1979 -- May 12, -1979.~~ Fourth Monday in April and twenty consecutive days thereafter.

(a) Shooting hours--One-half hour before sunrise to 11:00 a. m.

(b) No hunters allowed in the woods after 12:00 noon.

(c) Electronic calling devices prohibited during spring turkey season.

(d) Dogs prohibited during spring season.

3.05. Raccoon hunting - Open 6:00 p. m. - ~~October 13, -1979 - January 31, -1980~~ - First Saturday in November through last day of January at 5:00 a. m. prevailing time.

(a) Legal only from 6:00 p. m. to 5:00 a. m. daily.

(b) Raccoon hunting may be continued until 5:00 a. m. on Sunday morning.

3.06. Squirrels - Gray, Black, Albino and Fox - ~~October 13, 1979 -- January 5, -1980~~ - Saturday nearest October 15 through first Saturday in January.

3.07. Ruffed Grouse (native pheasant) - ~~October 13, -1979 - February 29, -1980~~ - Saturday nearest October 15 through last day

in February.

3.08. Bobwhite Quail - ~~November 3, 1979 - February 29, 1980~~ -  
First Saturday in November through last day in February.

3.09. Ring-necked Pheasant (Cocks Only) - ~~November 3, 1979 -~~  
~~January 5, 1980~~ - First Saturday in November through first Saturday  
in January.

3.10. Cottontail Rabbit - ~~November 3, 1979 - February 29, 1980~~ -  
First Saturday in November through last day of February.

3.11. Snowshoe or Varying Hare - ~~November 3, 1979 -~~  
~~February 29, 1980~~ - First Saturday in November through last day of  
February.

3.12. Red Fox, Gray Fox - ~~October 20, 1979 - February 29,~~  
~~1980~~; First Saturday in November through last day of January.

3.13. Bobcat - ~~October 20, 1979 - February 29, 1980~~ - First  
Saturday in November through last day of January.

3.14. Skunk, Opossum, Woodchuck or Groundhog, Weasel -  
Continuous open season.

3.15. Mountain Lion, Elk, and Otter - No open season.  
These species are totally protected.

3.16. Song and Insectivorous Birds, Hawks, and Owls - No  
open season, protected. (English sparrow, European starling,  
crow - open season year-round).

3.17. Gallinules, Sora, Virginia Rails, Mourning Doves, Woodcock, Snipe, Ducks and Geese - to be filed separately.

3.18. Wild Boar - ~~November 5, 1979~~ - ~~November 7, 1979~~ - First Monday in November for three consecutive days in those areas designated by the director.

(A) All persons participating, in any manner, in the special boar season must possess a valid Class P license.

(B) ~~Applicants applying for this license must be West Virginia residents and at least 12 years of age on or before November 5, 1979.~~ Applicants applying for this license must be West Virginia residents and at least 12 years of age.

(C) Class P licenses are nontransferrable.

(D) Bonafied Resident West Virginia landowners, their resident children and bonafied resident tenants may hunt on their own land within the boar hunting area without a Class P License.

(E) Wild boar may be legally taken with bow and arrow or any weapon using ammunition legal for the taking of deer.

(F) A field tag must be completed and attached to the animal within one (1) hour or in any case prior to its removal from the site where it was killed.

(G) All boar killed must be taken to one of the official boar checking stations within 24 hours. Only personnel from the Wildlife Resources Division will be permitted to examine and tag

gun during any season for which firearms are legal except during the muzzle-loading season.

5.02. Unlawful to hunt on Sunday with a bow except for legal aquatic life.

5.03. For bow and arrow fishing, a resident is required to have a fishing license; a nonresident is required to have a nonresident bow or gun hunting license or nonresident bow-only hunting license.

5.04. Unlawful to have bow in woods during closed season on game animals and non-migratory game birds.

#### SECTION 6. BOW AND ARROW HUNTING SEASONS

6.01. Deer - Bow and Arrow --~~October 13, - 1979 - December 31, - 1979.~~ --~~Deer of either sex may be hunted with a bow, except that bucks only may be hunted statewide with a bow November 19, - 1979 through December 1, - 1979 inclusive.~~ Saturday nearest October 15 until December 31. Deer of either sex may be hunted statewide with a bow, except that bucks only may be hunted statewide with a bow during the bucks-only season.

6.02. Bear - Bow and Arrow - ~~October 13, - 1979 - December 31, - 1979.~~ Saturday nearest October 15 until December 31.

(A) Adult bear only.

(B) Bow hunting for black bear is restricted to those counties or parts of counties open to gun hunting.

the boar.

(II) The use of dogs during any phase of hunting is prohibited.

(I) No person shall hunt wild boar between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise.

(J) The use of baits is prohibited.

#### SECTION 4. HUNTING BAG AND POSSESSION LIMITS

4.01. Deer - One per day, 3 per calendar year. One deer may be taken by bow during archery season; one by bow or gun during the bucks-only season (or one by muzzleloader if one has not already been taken during the bucks-only season); and one by either bow or gun during the special antlerless season.

4.02. Black Bear - Only one adult bear by means of gun or bow.

4.03. Wild Turkey - ~~One turkey of either sex in fall season; one bearded turkey in spring season.~~ Two turkeys per year only one of which may be taken in fall season. No person may legally take more than two turkeys per calendar year. Two bearded turkeys may be taken in the spring or one bearded turkey in the spring and one of either sex in the fall. In the spring only one bird may be taken per day.

4.04. Raccoon - the bag limit during any 11-hour period beginning at 6:00 p.m. and ending at 5:00 a.m. is two raccoons for

one person or group of persons as a party and 20 per season.

4.05. Squirrels - Gray, Black, Albino, and Fox - Six in aggregate of all species per day. Possession limit is 24 after third day.

4.06. Ruffed Grouse (Native Pheasant) - Four per day. Possession limit is 16 after third day.

4.07. Bobwhite Quail - Seven per day, 21 in possession after second day.

4.08. Ring-necked Pheasant - Two per day, two per season.

4.09. Cottontail Rabbit - Five per day, possession limit 20 after third day.

4.10. Snowshoe or Varying Hare - Two per day, possession limit 8 after third day.

4.11. Red or Gray Fox (Combined) - Twenty-five per day and 25 per season.

4.12. Bobcat - Two per day and two per season.

4.13. Skunk, Opossum, Woodchuck or Groundhog, Weasel - No daily or season limit.

4.14. Mourning Doves, Ducks, Geese, Woodcock, Snipe, Gallinules, Virginia and Sora Rails - to be filed separately.

4.15. Wild Boar - One per day, one per season.

#### SECTION 5. GENERAL BOW AND ARROW HUNTING REGULATIONS

5.01. A long bow or compound bow may be substituted for a

(C) The use of dogs while bow hunting for black bear shall be unlawful except during the legal firearms season.

6.03. Small game and Turkey - Bow seasons coincide with small game firearms season and turkey firearms season respectively.

#### SECTION 7. GENERAL TRAPPING REGULATIONS

7.01. No traps shall be set before 8:00 a.m. ~~October-29, 1979,~~ on first day of season or either set or left set after 12:00 noon ~~February-29, -1980;~~ on last day of season.

7.02. All traps must be checked and tended each calendar day.

7.03. No nonresident may trap in West Virginia.

7.04. Should any person unintentionally trap and kill more than the limit fixed by regulation as a season bag limit, he shall within 24 hours thereafter deliver said animals to a conservation officer.

7.05. Each trapper shall present beaver, bobcat, and fisher pelts to a game checking station or representative of the Department of Natural Resources within 30 days after the close of trapping season. A tag provided by the department shall be affixed to each beaver, bobcat, and fisher pelt and remain attached to the skin until such skin has been sold, tanned, or mounted.

7.06. Foot snares are legal when (a) the snare loop does not exceed  $6\frac{1}{2}$  inches in diameter and (b) the snare loop is at ground level and horizontal to ground level.

7.07. All traps used for taking wildlife shall be marked with a durable plate or tag attached to the trap, trap chain or set bearing the owner's name and address.

7.08. IT SHALL BE UNLAWFUL:

(1) To have in possession an untagged beaver, bobcat, or fisher hide or parts thereof, between ~~March-30,-1979~~ and October-29,-1979, the last day of March and the first Saturday in November.

(2) To use or set deadfalls for taking wildlife.

(3) To set or use traps with an open jaw spread of more than  $6\frac{1}{2}$  inches: Except traps with an open jaw spread of more than  $6\frac{1}{2}$  inches may be used underwater for beaver.

(4) To set or maintain any trap or trapping device in human foot trails and/or livestock paths.

(5) To use conibear or mohawk type traps for terrestrial trapping: Provided that conibear or mohawk type traps may be used in underwater sets.

(6) To set or maintain neck or body-gripping snares or spring pole snares: Provided that neck and body-gripping snares can be used in underwater sets.

(7) To use exposed baits in the form of animal or bird carcasses or part thereof to lure an animal to a trap set: Provided that animal or bird carcasses or parts thereof that are completely covered and concealed from sight, may be used as a lure.

(8) To trap except on one's own lands without first having obtained the written permission of the landowner as required by law.

(9) To use steel jaw traps with any teeth on or attached to them.

(10) To set or maintain any trap, trap set or snare upon any tree, post or other natural or man-made object at any point more than 3 lineal feet from the surface of the earth (whether such surface is water, soil or rock) measured at a right angle from the surface to the trap or trap set: Provided that nothing herein shall apply to traps or trap sets set or maintained on natural earthen mounds, such as ant hills or muskrat houses constructed without human assistance.

#### SECTION 8. TRAPPING SEASONS

8.01. Raccoon Trapping - ~~October-29,-1979-- January-31,~~  
1980; First Saturday in November until last day of January.

8.02. Mink Trapping - ~~October-29,-1979-- February 29,-1980;~~  
First Saturday in November until last day of February.

8.03. Muskrat Trapping - ~~October-29,-1979-- February 29,~~  
1980; First Saturday in November until last day of February.

8.04. Fisher Trapping - ~~October 29, 1979 -- February 29,~~  
1980; First Saturday in November until last day of January.

8.05 Beaver Trapping - ~~October 29, 1979 -- February 29, 1980~~  
First Saturday in November until last day of February.

8.06. Red Fox and Gray Fox - ~~October 29, 1979 -- February 29,~~  
1980; First Saturday in November until last day of January.

8.07. Bobcat - ~~October 29, 1979 -- February 29, 1980;~~  
First Saturday in November until last day of January.

#### SECTION 9. TRAPPING AND POSSESSION LIMITS

9.01. Raccoon - Daily (any 24-hour period) and seasonal  
bag limits for raccoon trapping shall be the same as for hunting.

9.02. Mink - No limit.

9.03. Muskrat - No limit.

9.04. Fisher - Daily limit one; season limit one.

9.05. Beaver - Daily limit (15); season limit (15).

9.06. Bobcat - Daily limit (2); season limit (2).

9.07. Gray Fox and Red Fox (Combined) - Daily limit (25);  
season limit (25).

#### SECTION 10. PUBLIC HUNTING AND FISHING AREAS AND STATE FORESTS

10.01. Rules and regulations governing hunting and trapping  
on state-owned and leased lands shall be as follows:

(A) Public Hunting and Fishing Areas - Hunting and

trapping as on adjacent lands except as follows:

(1) Trapping permit required on all areas. Permit is available from District Game Biologist.

(2) McClintic Wildlife Station - Waterfowl hunting only in accordance with the special rules set up for the area.

(3) A camping permit and fee are required on all public hunting and fishing areas. (See regulations posted on each area.)

(4) Camping is lawful only in designated areas.

(B) State Forests - Appropriate legal hunting and trapping licenses are the only license requirements for hunting in State Forests.

#### SECTION 11. SPECIAL MUZZLE LOADING DEER HUNTING SEASON

11.01. Season - ~~December 3, 4, 5, 1970~~; That Monday following the last Saturday in deer gun season through the following Wednesday.

11.02. Bag limit and possession limit - ~~one deer per season, provided that the hunter has not killed a deer during the 1970 bucks---~~  
~~only season.~~ One legal antlered deer per season, provided that the hunter has not killed a deer during the immediately preceding  
bucks-only season.

11.03. General

- (a) Only deer having one or both antlers 3 inches or more in length above the hairline will be legal game.
- (b) Only flintlock rifles with a minimum caliber of .44 may be used. Only iron sights may be used.
- (c) Weapons may be either rifled or smooth bore.
- (d) A single shot weapon that has been converted to a muzzle-loader using a plug shall not be used.
- (e) ~~Any person who has previously killed a deer during the 1979 bucks-only season will not be permitted to hunt.~~ Any person who has previously killed a deer during the immediately preceding bucks-only season will not be permitted to hunt.
- (f) Only state-owned or leased public hunting and fishing areas will be open for the muzzle-loading deer season.
- (g) ~~No concurrent hunting will be permitted on the state-owned or leased areas during this special season.~~
- (h) Percussion, flintlock and other weapons employing obsolete ignition systems will be considered unloaded when uncapped or when the priming charge is removed from the pan.

# WEST VIRGINIA ADMINISTRATIVE REGULATIONS

## Department of Natural Resources Chapter 20-1 Series IV (1979) (1980)

Subject: 1979 Hunting and Trapping Regulations

By virtue of the authority granted to the Director and Commissioners of the Department of Natural Resources by Article 1, Chapter 20 of the Code of West Virginia, the following hunting and trapping regulations are hereby promulgated and shall become effective at 12:01 a.m. on ~~March 1, 1979~~; March 1, 1980 and shall remain in effect unless otherwise amended or new regulations are issued.

All seasons, unless otherwise noted, are statewide and subject to change. The opening and closing dates shall be inclusive, except as noted under exceptions. All time periods shall be prevailing time except as otherwise noted. All seasons shall close on previous Saturday if last day falls on Sunday. Sunday hunting is illegal with the exception of raccoon as noted. Should opening dates fall on Sunday the season will open on the following Monday.

1.01. Possession limit--means game which is in any way under the control of the hunter after the second day of the season except raccoon. The daily bag limit of raccoon may be possessed for each day the season is open until the season limit is reached.

Example, the total of all game in a car, trunk, home freezer, commercial food locker, or any other storage method or place.

1.02. Aggregate--means the total bag or possession limit of any similar kind of game animals or birds. Example: the possession limit for squirrels is 24 after the third day. This could be eight gray squirrels, eight fox squirrels, and eight black squirrels; or any combination of 24 squirrels, but not more than a total of six per day, nor more than a total of 24 in possession.

1.03. Protected--no open season. Hunting at any time shall be illegal for protected wildlife.

1.04. Prevailing Time--prevailing time shall be either Eastern Standard Time or Daylight Saving Time and shall be that time proclaimed by the Governor of the State.

1.05. Concurrent Hunting--hunting of other species during deer gun season.

1.06. Big Game--shall be black bear, deer, elk, wild turkey, and wild boar.

## SECTION 2. GENERAL HUNTING RULES

2.01. Hunting with a gun or bow is limited to open fields during the closed season on game birds and game animals.

2.02. Hunting and trapping are forbidden on: (1) All State Parks and Game Refuges; (2) Harpers Ferry National Monument;

(3) All safety zones on State Forests and Public Hunting and Fishing Areas. All refuges are appropriately marked with official Department signs.

2.03. It shall be unlawful to use any poisons, chemicals, or explosives in taking any furbearing animal, game animal, game bird or protected song and insectivorous bird, provided that woodchuck or groundhogs may be controlled on private land by the landowner, his children or a bonafide resident tenant during the period of April 1 through September 30, provided further, that whenever protected birds are committing serious depredation of crops, property, or other interest, the director may authorize the killing of the offending bird.

2.04. No warming or other fires permitted on lands belonging to others without written permission of owners.

2.05. It is illegal to smoke any wildlife from dens, trees, rocks, or any other cover except as otherwise provided by law or regulation. Groundhogs may be controlled on private lands by the landowner.

2.06. Redwinged blackbirds, grackles and pigeons may be controlled by chemicals registered with the West Virginia Department of Agriculture and the Environmental Protection Agency when prescribed and authorized by the director.

2.07. It shall be illegal to discharge a firearm or shoot an

arrow from aircraft, motor-driven watercraft, motor vehicle, any land conveyance or from or across any public road.

### SECTION 3. HUNTING SEASONS

3.01. Deer Firearms season - Bucks only - ~~November 19, 1979 - December 1, 1979~~ - First Monday preceding Thanksgiving for 13 consecutive days in the following counties: Barbour, Berkeley, Boone, Braxton, Brooke, Cabell, Calhoun, Clay, Doddridge, Fayette, (~~N. of New River~~), Gilmer, Grant, Greenbrier, Hampshire, Hancock, Hardy, Harrison, Jackson, Jefferson, Kanawha (~~N. of U.S. 60~~), Lewis, Lincoln, Marion, Marshall, Mason, Mercer, Mineral, Monongalia, Monroe, Morgan, Nicholas, Ohio, Pendleton, Pleasants, Pocahontas, Preston, Putnam (~~N. of U.S. 60~~), Raleigh, Randolph, Ritchie, Roane, Summers, Taylor, Tucker, Tyler, Upshur, Wayne, Webster, Wetzel, Wirt, and Wood.

~~Deer - Firearms season - Bucks only - November 19, 1979 - November 24, 1979 - In the following counties: - Boone, - Cabell, - Fayette (S. of New River), - Kanawha (S. of U.S. 60), - Lincoln, - Logan, - Mercer, - Mingo, - Putnam (S. of U.S. 60), - Raleigh, - Summers, - Wayne and Wyoming. No open season for deer in McDowell County. No buck-only firearm deer season in McDowell, Logan, Wyoming and Mingo Counties.~~

(A) No person may legally take under any condition more than 3 deer per calendar year: One by bow during the archery season; one by gun or bow during the bucks-only season; or one by muzzle-loader if not taken by gun during the regular firearms season; and one

by either bow or gun during the special antlerless season.

(B) After a person has killed a legal deer by either bow or firearm during the regular bow or firearms seasons, he may not participate further in hunting with either a bow or firearm in his possession the remainder of the day. Such a person may, however, pursue his second legal deer any day following, provided it falls within the regular bow or gun season and the established season for the weapon in possession or use, and provided the first deer has been legally checked at an official checking station or by a conservation officer.

(C) Only deer having one or both antlers 3 inches or more in length above the hair will be legal game during bucks-only and muzzle-loading hunting seasons.

(D) No person shall hunt deer with a shotgun using ammunition loaded with more than one solid ball, nor with any rifle using rimfire ammunition of less than .25 caliber. However, this section shall not prohibit any person legally licensed to hunt with a .22 caliber pistol or revolver from humanely killing any deer that has been lawfully wounded or downed by a firearm.

(E) Any rifle using center-fire ammunition or muzzle-loading rifle .44 caliber or larger is legal for deer hunting.

(F) No person shall hunt deer between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise, or kill or wound any deer while the deer is in any stream, lake or pond.

3.02. Concurrent Hunting During Deer Firearms Season:

(A) All hunting, except for deer, shall be prohibited during the first 3 days of bucks-only deer season in all counties having a bucks-only deer season, provided that hunting for waterfowl shall be permitted on lakes, rivers, and waterways during the open waterfowl season.

(B) Small game hunting permitted beginning the fourth day after the opening date of the bucks-only season.

(C) Shot smaller than #4 and slugs may be carried with a shotgun prior to killing a deer during the concurrent hunting period.

(D) A combination rifle-shotgun (over-under, etc.) is legal for deer hunting and during the concurrent small game period.

(E) After killing a legal deer, a successful hunter shall not be afield with any type shotgun with solid ball ammunition or, if using a combination rifle-shotgun he shall not have rifle ammunition in his possession.

(F) It shall be unlawful to hunt small game with any center-fire rifle or rifle larger than .22 caliber rimfire, or shotguns using solid ball ammunition in counties not open to firearm deer hunting.

(G) No small game hunting during antlerless deer season in counties or parts of counties having an antlerless deer season.

(H) ~~No concurrent hunting on state public hunting and fishing areas and state forests during deer muzzleloading season.~~

3.03. Black Bear - (Adult Animals Only) - Firearms season -  
~~November-9,-1979 --November-10,-1979 and-December-10,-1979 -~~  
~~December-28,-1979.~~ First Monday following the bucks firearms hunting  
season and 20 consecutive days thereafter. Bear season is open  
(county-wide) only in the following counties: Grant, Pendleton,  
Pocahontas, Randolph, Tucker and that portion of Webster east of  
Route 20 from Webster Springs southwest to the Nicholas County line  
and that section east and south of State Route 15 from Webster Springs  
to the Randolph County line, that portion of Hardy County lying east of  
U. S. Route 220, that portion of Monroe County lying east of U.S.  
Route 219, and that portion of Hampshire County lying south of U.S.  
Route 50. Bear season is also open in that portion of Greenbrier  
County lying north of U.S. 60 from the Fayette County line to its inter-

Two exceptions to this are: Cranberry Closed Area (known as

The Cranberry Closed Area is bounded as follows: Starting at

Route #216; then the boundary follows Forest Service Route #216 to its intersection with Mountain Lick Run. The line then follows Mountain Lick Run to its intersection with the U.S.F.S. boundary and then follows the U.S.F.S. boundary to its intersection with State Route #29/4; then along State Route #29/4 and #39/4 to Forest Service Trail #236. The boundary follows Forest Service Trail #236 northward to the Nicholas County line and then proceeds north following the Nicholas County line to Forest Service Route #76; it then follows Forest Service Route #76 north to Forest Service Route #101. The boundary then follows Forest Service Route #101 north to Dyer.

The Spruce Knob Closed Area is bounded as follows:

Starting at the intersection of U.S. Route #33 and the Spruce Knob National Recreation Area boundary about 3 miles west of the Mouth of Seneca, the boundary follows U.S. Route #33 east to the intersection of U.S. Route #33 and State Route #33/3 and then follows the Spruce Knob Recreation Area boundary south to Forest Service Route #55; the line then follows Forest Service Route #55 north to Forest Service Route #1; then proceeds west on Forest Service Route #1 to State Route #29. The boundary then follows State Route #29 north to State Route #29/4 north to the Spruce Knob National Recreation boundary; then follows the Spruce Knob National Recreation boundary north to U.S. Route #33.

(A) No person may legally take more than one bear per calendar year.

(B) Nonresidents shall not train dogs in the state at any time except during the legal small game hunting season.

(C) Residents in counties which have a legal bear hunting season may train their bear hunting dogs between August 24 and February 28, only, provided that except during the firearms bear season, they have no firearms, bow or implement with which the bear could be taken in their possession or under their control.

(D) Bear season will be closed in counties having an antlerless deer season while that season is open.

3.04 ~~Fall Wild Turkey - October 13, -1979 -- November 10, -1979; December 10, -1979 -- December 15, -1979.~~ Season shall be for twenty-nine consecutive days starting with the Saturday nearest October 15, and for six consecutive days commencing on Monday following the second Saturday in December. Only in the following counties: Berkeley, Grant, Greenbrier, Hampshire, Hardy, Mineral, Monroe, Morgan, Nicholas (East of State Route #20), Pendleton, Pocahontas, Randolph, Tucker and Webster.

Season shall be for 15 consecutive days starting with the Saturday nearest October 15; Only in Preston County.

(A) Electronic calling devices prohibited during fall turkey season.

(B) Spring Turkey Regulations (Bearded Turkeys Only) - ~~April 23, -1979 -- May 12, -1979.~~ Fourth Monday in April and twenty consecutive days thereafter.

(a) Shooting hours--One-half hour before sunrise to 11:00 a. m.

(b) No hunters allowed in the woods after 12:00 noon.

(c) Electronic calling devices prohibited during spring turkey season.

(d) Dogs prohibited during spring season.

3.05. Raccoon hunting - Open 6:00 p. m. - ~~October 13, -1979 --~~  
~~January 31, -1980~~ - First Saturday in November through last day of  
January at 5:00 a. m. prevailing time.

(a) Legal only from 6:00 p. m. to 5:00 a. m. daily.

(b) Raccoon hunting may be continued until 5:00 a. m. on Sunday morning.

3.06. Squirrels - Gray, Black, Albino and Fox - ~~October 13,~~  
~~1979 -- January 5, -1980~~ - Saturday nearest October 15 through first  
Saturday in January.

3.07. Ruffed Grouse (native pheasant) - ~~October 13, -1979 -~~  
~~February 29, -1980~~ - Saturday nearest October 15 through last day

in February.

3.08. Bobwhite Quail - ~~November 3, 1979 - February 29, 1980~~ -  
First Saturday in November through last day in February.

3.09. Ring-necked Pheasant (Cocks Only) - ~~November 3, 1979 -~~  
~~January 5, 1980~~ - First Saturday in November through first Saturday  
in January.

3.10. Cottontail Rabbit - ~~November 3, 1979 - February 29, 1980~~ -  
First Saturday in November through last day of February.

3.11. Snowshoe or Varying Hare - ~~November 3, 1979 -~~  
~~February 29, 1980~~ - First Saturday in November through last day of  
February.

3.12. Red Fox, Gray Fox - ~~October 20, 1979 - February 29,~~  
1980; First Saturday in November through last day of January.

3.14. Skunk, Opossum, Woodchuck or Groundhog, Weasel -

3.15. Mountain Lion, Elk, and Otter - No open season.  
These species are totally protected.

3.16. Song and Insectivorous Birds, Hawks, and Owls - No  
open season, protected. (English sparrow, European starling,  
crow - open season year-round).

3.17. Gallinules, Sora, Virginia Rails, Mourning Doves, Woodcock, Snipe, Ducks and Geese - to be filed separately.

3.18. Wild Boar - ~~November 5, 1979 - November 7, 1979~~ - First Monday in November for three consecutive days in those areas designated by the director.

(A) All persons participating, in any manner, in the special boar season must possess a valid Class P license.

(B) ~~Applicants applying for this license must be West Virginia residents and at least 12 years of age on or before November 6, 1979.~~ Applicants applying for this license must be West Virginia residents and at least 12 years of age.

(C) Class P licenses are nontransferrable.

(D) Bonafied Resident West Virginia landowners, their resident children and bonafied resident tenants may hunt on their own land within the boar hunting area without a Class P License.

(E) Wild boar may be legally taken with bow and arrow or any weapon using ammunition legal for the taking of deer.

(F) A field tag must be completed and attached to the animal within one (1) hour or in any case prior to its removal from the site where it was killed.

(G) All boar killed must be taken to one of the official boar checking stations within 24 hours. Only personnel from the Wildlife Resources Division will be permitted to examine and tag

the boar.

(II) The use of dogs during any phase of hunting is prohibited.

(I) No person shall hunt wild boar between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise.

(J) The use of baits is prohibited.

#### SECTION 4. HUNTING BAG AND POSSESSION LIMITS

4.01. Deer - One per day, 3 per calendar year. One deer may be taken by bow during archery season; one by bow or gun during the bucks-only season (or one by muzzleloader if one has not already been taken during the bucks-only season); and one by either bow or gun during the special antlerless season.

4.02. Black Bear - Only one adult bear by means of gun or bow.

4.03. Wild Turkey - ~~One turkey of either sex in fall season; one bearded turkey in spring season.~~ Two turkeys per year only one of which may be taken in fall season. No person may legally take more than two turkeys per calendar year. Two bearded turkeys may be taken in the spring or one bearded turkey in the spring and one of either sex in the fall. In the spring only one bird may be taken per day.

4.04. Raccoon - the bag limit during any 11-hour period beginning at 6:00 p.m. and ending at 5:00 a.m. is two raccoons for

one person or group of persons as a party and 20 per season.

4.05. Squirrels - Gray, Black, Albino, and Fox - Six in aggregate of all species per day. Possession limit is 24 after third day.

4.06. Ruffed Grouse (Native Pheasant) - Four per day. Possession limit is 16 after third day.

4.07. Bobwhite Quail - Seven per day, 21 in possession after second day.

4.08. Ring-necked Pheasant - Two per day, two per season.

4.09. Cottontail Rabbit - Five per day, possession limit 20 after third day.

4.10. Snowshoe or Varying Hare - Two per day, possession limit 8 after third day.

4.11. Red or Gray Fox (Combined) - Twenty-five per day and 25 per season.

4.12. Bobcat - Two per day and two per season.

4.13. Skunk, Opossum, Woodchuck or Groundhog, Weasel - No daily or season limit.

4.14. Mourning Doves, Ducks, Geese, Woodcock, Snipe, Gallinules, Virginia and Sora Rails - to be filed separately.

4.15. Wild Boar - One per day, one per season.

#### SECTION 5. GENERAL BOW AND ARROW HUNTING REGULATIONS

5.01. A long bow or compound bow may be substituted for a

gun during any season for which firearms are legal except during the muzzle-loading season.

5.02. Unlawful to hunt on Sunday with a bow except for legal aquatic life.

5.03. For bow and arrow fishing, a resident is required to have a fishing license; a nonresident is required to have a nonresident bow or gun hunting license or nonresident bow-only hunting license.

5.04. Unlawful to have bow in woods during closed season on game animals and non-migratory game birds.

#### SECTION 6. BOW AND ARROW HUNTING SEASONS

6.01. ~~Deer - Bow and Arrow --October-13,-1979--December-31,-1979.--Deer-of either sex may be hunted with a bow,- except that-~~  
~~bucks-only may be hunted statewide with a bow November-19,-1979~~  
~~through December-1,-1979-inclusive. Saturday nearest October 15~~  
until December 31. Deer of either sex may be hunted statewide with  
a bow, except that bucks only may be hunted statewide with a bow  
during the bucks-only season.

6.02. ~~Bear - Bow and Arrow - October-13,-1979 -- December~~  
~~31,-1979. Saturday nearest October 15 until December 31.~~

(A) Adult bear only.

(B) Bow hunting for black bear is restricted to those counties or parts of counties open to gun hunting.

(C) The use of dogs while bow hunting for black bear shall be unlawful except during the legal firearms season.

6.03. Small game and Turkey - Bow seasons coincide with small game firearms season and turkey firearms season respectively.

#### SECTION 7. GENERAL TRAPPING REGULATIONS

7.01. No traps shall be set before 8:00 a.m. ~~October-29, 1979,~~ on first day of season or either set or left set after 12:00 noon ~~February-29, -1980;~~ on last day of season.

7.02. All traps must be checked and tended each calendar day.

7.03. No nonresident may trap in West Virginia.

7.04. Should any person unintentionally trap and kill more than the limit fixed by regulation as a season bag limit, he shall within 24 hours thereafter deliver said animals to a conservation officer.

7.05. Each trapper shall present beaver, bobcat, and fisher pelts to a game checking station or representative of the Department of Natural Resources within 30 days after the close of trapping season. A tag provided by the department shall be affixed to each beaver, bobcat, and fisher pelt and remain attached to the skin until such skin has been sold, tanned, or mounted.

7.06. Foot snares are legal when (a) the snare loop does not exceed  $6\frac{1}{2}$  inches in diameter and (b) the snare loop is at ground level and horizontal to ground level.

7.07. All traps used for taking wildlife shall be marked with a durable plate or tag attached to the trap, trap chain or set bearing the owner's name and address.

7.08. IT SHALL BE UNLAWFUL:

(1) To have in possession an untagged beaver, bobcat, or fisher hide or parts thereof, between ~~March 30, 1979~~ and ~~October 29, 1979~~, the last day of March and the first Saturday in November.

(2) To use or set deadfalls for taking wildlife.

(3) To set or use traps with an open jaw spread of more than  $6\frac{1}{2}$  inches: Except traps with an open jaw spread of more than  $6\frac{1}{2}$  inches may be used underwater for beaver.

(4) To set or maintain any trap or trapping device in human foot trails and/or livestock paths.

(5) To use conibear or mohawk type traps for terrestrial trapping: Provided that conibear or mohawk type traps may be used in underwater sets.

(6) To set or maintain neck or body-gripping snares or spring pole snares: Provided that neck and body-gripping snares can be used in underwater sets.

(7) To use exposed baits in the form of animal or bird carcasses or part thereof to lure an animal to a trap set: Provided that animal or bird carcasses or parts thereof that are completely covered and concealed from sight, may be used as a lure.

(8) To trap except on one's own lands without first having obtained the written permission of the landowner as required by law.

(9) To use steel jaw traps with any teeth on or attached to them.

(10) To set or maintain any trap, trap set or snare upon any tree, post or other natural or man-made object at any point more than 3 lineal feet from the surface of the earth (whether such surface is water, soil or rock) measured at a right angle from the surface to the trap or trap set: Provided that nothing herein shall apply to traps or trap sets set or maintained on natural earthen mounds, such as ant hills or muskrat houses constructed without human assistance.

9.01. Raccoon - Daily (any 24-hour period) and seasonal  
bag limits for raccoon trapping shall be the same as for hunting.

9.02. Mink - No limit.

9.03. Muskrat - No limit.

9.04. Fisher - Daily limit one; season limit one.

9.05. Beaver - Daily limit (15); season limit (15).

9.06. Bobcat - Daily limit (2); season limit (2).

9.07. Gray Fox and Red Fox (Combined) - Daily limit (25);  
season limit (25).

#### SECTION 10. PUBLIC HUNTING AND FISHING AREAS AND STATE FORESTS

10.01. Rules and regulations governing hunting and trapping  
on state-owned and leased lands shall be as follows:

(A) Public Hunting and Fishing Areas - Hunting and

trapping as on adjacent lands except as follows:

(1) Trapping permit required on all areas. Permit is available from District Game Biologist.

(2) McClintic Wildlife Station - Waterfowl hunting only in accordance with the special rules set up for the area.

(3) A camping permit and fee are required on all public hunting and fishing areas. (See regulations posted on each area.)

(4) Camping is lawful only in designated areas.

(B) State Forests - Appropriate legal hunting and trapping licenses are the only license requirements for hunting in State Forests.

#### SECTION 11. SPECIAL MUZZLE LOADING DEER HUNTING SEASON

11.01. Season - ~~December 3, 4, 5, 1970;~~ That Monday following the last Saturday in deer gun season through the following Wednesday.

11.02. Bag limit and possession limit - ~~one deer per season;~~ provided that the hunter has not killed a deer during the 1970 bucks-only season. One legal antlered deer per season, provided that the hunter has not killed a deer during the immediately preceding bucks-only season.

11.03. General

- (a) Only deer having one or both antlers 3 inches or more in length above the hairline will be legal game.
- (b) Only flintlock rifles with a minimum caliber of .44 may be used. Only iron sights may be used.
- (c) Weapons may be either rifled or smooth bore.
- (d) A single shot weapon that has been converted to a muzzle-loader using a plug shall not be used.
- (e) ~~Any person who has previously killed a deer during the 1979 bucks-only season will not be permitted to hunt.~~ Any person who has previously killed a deer during the immediately preceding bucks-only season will not be permitted to hunt.
- (f) Only state-owned or leased public hunting and fishing areas will be open for the muzzle-loading deer season.
- (g) ~~No concurrent hunting will be permitted on the state-owned or leased areas during this special season.~~
- (h) Percussion, flintlock and other weapons employing obsolete ignition systems will be considered unloaded when uncapped or when the priming charge is removed from the pan.

Subject: 1978, 1979 Hunting and Trapping Regulations THIS DATE 3.2.79

By virtue of the authority granted to the Director and Commissioners of the Department of Natural Resources by Article 1, Chapter 20 of the Code of West Virginia, the following hunting and trapping regulations are hereby promulgated and shall become effective at 12:01 a.m. on ~~March 1, 1978~~, March 1, 1979 and shall remain in effect unless otherwise amended or new regulations are issued.

All seasons, unless otherwise noted, are statewide and subject to change. The opening and closing dates shall be inclusive, except as noted under exceptions. All time periods shall be prevailing time except as otherwise noted.

SECTION 1. DEFINITION OF TERMS USED

1.01. Possession limit--means game which is in any way under the control of the hunter after the second day of the season except raccoon. The daily bag limit of raccoon may be possessed for each day the season is open until the season limit is reached. Example: the total of all game in a car, trunk, home freezer,

commercial food locker, or any other storage method or place.

1.02. Aggregate--means the total bag or possession limit of any similar kind of game animals or birds. Example: the possession limit for squirrels is 24 after the third day. This could be eight gray squirrels, eight fox squirrels, and eight black squirrels; or any combination of 24 squirrels, but not more than a total of six per day, nor more than a total of 24 in possession.

1.03. Protected--no open season. Hunting at any time shall be illegal for protected wildlife.

1.04. Prevailing Time--prevailing time shall be either Eastern Standard Time or Daylight Saving Time and shall be that time proclaimed by the Governor of the State.

1.05. Concurrent Hunting--hunting of other species during deer gun season.

1.06. Big Game--shall be black bear, deer, elk, wild turkey and wild boar.

## SECTION 2. GENERAL HUNTING RULES

2.01. Hunting with a gun or bow is limited to open fields during the closed season on game birds and game animals.

2.02. Hunting and trapping are forbidden on: (1) All State Parks and Game Refuges; (2) Harpers Ferry National Monument; (3) All safety zones on State Forests and Public Hunting and Fishing Areas. All refuges are appropriately marked with official Depart-

ment signs.

2.03. It shall be unlawful to use any poisons, chemicals, or explosives in taking any furbearing animal, game animal, game bird or protected song and insectivorous bird, provided that woodchuck or groundhogs may be controlled on private land by the landowner, his children or a bonafide resident tenant during the period of April 1 through September 30, provided further, that whenever protected birds are committing serious depredation of crops, property, or other interest, the director may authorize the killing of the offending bird.

2.04. No warming or other fires permitted on lands belonging to others without written permission of owners.

2.05. It is illegal to smoke any wildlife from dens, trees, rocks, or any other cover except as otherwise provided by law or regulation. Groundhogs may be controlled on private lands by the landowner.

2.06. Redwinged blackbirds, grackles and pigeons may be controlled by chemicals registered with the West Virginia Department of Agriculture and the Environmental Protection Agency when prescribed and authorized by the director.

2.07. It shall be illegal to discharge a firearm or shoot an arrow from aircraft, motor-driven watercraft, motor vehicle, any land conveyance or from or across any public road.

SECTION 3. HUNTING SEASONS

3.01. Deer - Firearms season - Bucks only - ~~November 20, -1978 -~~  
~~December 2, -1978;~~ November 19, 1979 - December 1, 1979. In the  
following counties: Barbour, Berkeley, Braxton, Brooke, Calhoun,  
Clay, Doddridge, Fayette, (N. of New River), Gilmer, Grant, Green-  
brier, Hampshire, Hancock, Hardy, Harrison, Jackson, Jefferson,  
Kanawha (N. of U.S. 60), Lewis, Marion, Marshall, Mason, Mineral,  
Monongalia, Monroe, Morgan, Nicholas, Ohio, Pendleton, Pleasants,  
Pocahontas, Preston, Putnam (N. of U.S. 60), Randolph, Ritchie,  
Roane, Taylor, Tucker, Tyler, Upshur, Webster, Wetzel, Wirt, and  
Wood.

Deer - Firearms season - Bucks only - ~~November 20, -1978 -~~  
~~November 25, -1978;~~ November 19, 1979 - November 24, 1979 - In the  
following counties: Boone, Cabell, Fayette (S. of New River), Kanawha  
(S. of U.S. 60), Lincoln, Logan, Mercer, Mingo, Putnam (S. of U.S. 60),  
Raleigh, Summers, Wayne and Wyoming. No open season for deer in  
McDowell County.

(A) No person may legally take under any condition more  
than 3 deer per calendar year: One by bow during the archery season;  
one by gun or bow during the bucks only season; or one by muzzleloader  
if not taken by gun during the regular firearms season; and one by  
either bow or gun during the special antlerless season.

(B) After a person has killed a legal deer by either bow or

firearm during the regular bow or firearms seasons, he may not participate further in hunting with either a bow or firearm in his possession the remainder of the day. Such a person may, however, pursue his second legal deer any day following, provided it falls within the regular bow or gun season and the established season for the weapon in possession or use, and provided the first deer has been legally checked at an official checking station or by a conservation officer.

(C) Only deer having one or both antlers 3 inches or more in length above the hair will be legal game during bucks-only and muzzle-loading hunting seasons.

(D) No person shall hunt deer with a shotgun using ammunition loaded with more than one solid ball, nor with any rifle using rim-fire ammunition of less than .25 caliber. However, this section shall not prohibit any person legally licensed to hunt with a .22 caliber pistol or revolver from humanely killing any deer that has been lawfully wounded or downed by a firearm.

(E) Any rifle using center-fire ammunition or muzzle-loading rifle is legal for deer hunting.

(F) No person shall hunt deer between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise, or kill or wound any deer while the deer is in any stream, lake or pond.

3.02. Concurrent Hunting During Deer Firearms Season:

(A) All hunting, except for deer, shall be prohibited during the first 3 days of antlered deer season in all territories having an antlered deer season, provided that hunting for waterfowl shall be permitted on lakes, rivers, and waterways during the open waterfowl season.

(B) Small game hunting permitted beginning the fourth day after the opening date of the bucks-only season.

(C) Shot smaller than #4 and slugs may be carried with a shotgun prior to killing a deer during the concurrent hunting period.

(D) A combination rifle-shotgun (over-under, etc.) is legal for deer hunting and during the concurrent small game period.

(E) After killing a legal deer, a successful hunter shall not be afield with any type shotgun with solid ball ammunition or, if using a combination rifle-shotgun he shall not have rifle ammunition in his possession.

(F) It shall be unlawful to hunt small game with any center-fire rifle or rifle larger than .22 caliber rimfire, or shotguns using solid ball ammunition in counties no open to firearm deer hunting.

(G) No small game hunting during antlerless deer season in counties or parts of counties having an antlerless deer season.

(H) No concurrent hunting on state public hunting and fishing areas and state forests during deer muzzleloading season.

3.03. Black Bear - (Adult Animals Only) - Firearms season -  
~~November 6, 1978 - November 11, 1978; and December 18, 1978 -~~  
~~December 30, 1978; December 10, 1979 - December 29, 1979.~~  
Bear season is open (county-wide) only in the following counties:  
Grant, Greenbrier, Hampshire, Hardy, Monroe, Pendleton,  
Pocahontas, Randolph, Tucker and that portion of Webster east of  
Route 20 from Webster Springs southwest to the Nicholas County  
line and that section east and south of State Route 15 from Webster  
Springs to the Randolph County line, that portion of Hardy County  
lying east of U.S. Route 220, that portion of Monroe County lying  
east of U.S. Route 219, and that portion of Hampshire County lying  
south of U.S. Route 50. Bear season is also open in that portion  
of Greenbrier County lying north of U.S. 60 from the Fayette County  
line to its intersection with County Route 9, north of County Route 9  
between U.S. 60 and U.S. 219 and east of U.S. 219 from County

Two exceptions to this are: Cranberry Closed Area (known as the

The Cranberry Closed Area is bounded as follows: Starting at

its intersection with Mountain Lick Run.

The line then follows Mountain Lick Run to its intersection with the U.S.F.S. boundary and then follows the U.S.F.S. boundary to its intersection with State Route #29/4; then along State Route #29/4 and #39/4 to Forest Service Trail #236. The boundary follows Forest Service Trail #236 northwestward to the Nicholas County line and then proceeds north following the Nicholas County line to Forest Service Route #76; it then follows Forest Service Route #76 north to Forest Service Route #101. The boundary then follows Forest Service Route #101 north to Dyer.

The Spruce Knob Closed Area is bounded as follows:

Starting at the intersection of U.S. Route #33 and the Spruce Knob National Recreation Area boundary about 8 miles west of the Mouth of Seneca, the boundary follows U.S. Route #33 east to the intersection of U.S. Route #33 and State Route #33/3 and then follows the Spruce Knob Recreation Area boundary south to Forest Service Route #55; the line then follows Forest Service Route #55 north to Forest Service Route #1; then proceeds west on Forest Service Route #1 to State Route #29. The boundary then follows State Route #29 north to State Route #29/4 north to the Spruce Knob National Recreation boundary; then follows the Spruce Knob National Recreation boundary north to U.S. Route #33.

(A) No person may legally take more than one bear per calendar year.

(B) Nonresidents shall not train dogs in the state at any time except during the legal small game hunting season.

(C) Residents in counties which have a legal bear hunting season may train their bear hunting dogs between August 24 and February 28, only, provided that except during the firearms bear season, they have no firearms, bow or implement with which the bear could be taken in their possession or under their control.

3.04. Fall Wild Turkey - ~~October 14, -1978 - November 11, 1978;~~ October 13, 1979 - November 10, 1979 and ~~December 11, -1978 - December 16, -1978;~~ December 10, 1979 - December 15, 1979. Only in the following counties: Berkeley, Grant, Greenbrier, Hampshire, Hardy, Mineral, Monroe, Morgan, Nicholas (East of State Route #20), Pendleton, Pocahontas, Randolph, Tucker and Webster.

Fall Wild Turkey - ~~October 14, -1978 - October 28, -1978;~~ October 13, 1979 - October 27, 1979 - Only in Preston County.

Spring Turkey Season (Bearded turkeys only) - ~~April 24, -1978 - May 13, -1978;~~ April 23, 1979 - May 12, 1979.

(A) Spring Turkey Regulations:

(a) Shooting hours--One-half hour before sunrise to 11:00 a.m.

(b) No hunters allowed in the woods after 12:00 noon.

(c) Electronic calling devices prohibited during spring turkey season.

(d) Dogs prohibited during spring season.

3.05. Raccoon hunting - Open 6:00 p.m. - ~~October 14, 1978~~ - ~~February 28, 1979~~; October 13, 1979 - January 31, 1980 at 5:00 a.m. prevailing time.

(a) Legal only from 6:00 p.m. to 5:00 a.m. daily.

(b) Raccoon hunting may be continued until 5:00 a.m. on Sunday morning.

3.06. Squirrels - Gray, Black, Albino, and Fox - ~~October 14, 1978~~ - ~~January 6, 1979~~; October 13, 1979 - January 5, 1980.

3.07. Ruffed Grouse (Native Pheasant) - ~~October 14, 1978~~ - ~~February 28, 1979~~; October 13, 1979 - February 29, 1980.

3.08. Bobwhite Quail - ~~November 4, 1978~~ - ~~February 28, 1979~~; November 3, 1979 - February 29, 1980.

3.09. Ring-necked Pheasant (Cocks Only) - ~~November 4, 1978~~ - ~~January 6, 1979~~; November 3, 1979 - January 5, 1980.

3.10. Cottontail Rabbit - ~~November 4, 1978~~ - ~~February 28, 1979~~; November 3, 1979 - February 29, 1980.

3.11. Snowshoe or Varying Hare - ~~November 4, 1978~~ - ~~February 28, 1979~~; November 3, 1979 - February 29, 1980.

3.12. Red Fox, Gray Fox - ~~October 30, 1978~~ - ~~February 28, 1979~~; October 29, 1979 - February 29, 1980.

3.13. Bobcat - ~~October 30, 1978~~ - ~~February 28, 1979~~ - October 29, 1979 - February 29, 1980.

3.14. Skunk, Opossum, Woodchuck or Groundhog, Weasel -  
Continuous open season.

3.15. Mountain Lion, Elk, and Otter - No open season.  
These species are totally protected.

3.16. Song and Insectivorous Birds, Hawks and Owls - No  
open season, protected. (English sparrow, European starling, crow,  
open season year-round).

3.17. Gallinules, Sora, Virginia Rails, Mourning Doves,  
Woodcock, Snipe, Ducks and Geese - to be filed separately.

3.18. Wild boar - November 5, 1979 - November 7, 1979.

(A) All persons participating, in any manner, in the  
special boar season must possess a valid Class P license.

(B) Applicants applying for this license must be  
West Virginia residents and at least 12 years of age on or before  
November 5, 1979.

(C) Class P licenses are nontransferrable.

(D) Bonafied Resident West Virginia landowners,  
their resident children and bonafied resident tenants may hunt on  
their own land within the boar hunting area without a Class P License.

(E) Wild boar may be legally taken with bow and  
arrow or any weapon using ammunition legal for the taking of deer.

(F) A field tag must be completed and attached to  
the animal within one (1) hour or in any case prior to its removal  
from the site where it was killed.

(G) All boar killed must be taken to one of the official boar checking stations within 24 hours. Only personnel from the Wildlife Resources Division will be permitted to examine and tag the boar.

(H) The use of dogs during any phase of hunting is prohibited.

(I) No person shall hunt wild boar between  $\frac{1}{2}$  hour after sunset and  $\frac{1}{2}$  hour before sunrise.

(J) The use of baits is prohibited.

#### SECTION 4. HUNTING BAG AND POSSESSION LIMITS

4.01. Deer - One per day, 3 per calendar year. ~~Two with gun (one must be taken during the special antlerless season) and one with bow (taken during any legal season).~~ One deer may be taken by bow during archery season; one by bow or gun during the bucks-only season (or one by muzzleloader if one has not already been taken during bucks-only season); and one by either bow or gun during the special antlerless season.

4.02. Black Bear - Only one adult bear by means of gun or bow.

4.03. Wild Turkey - One turkey of either sex in fall season; one bearded turkey in spring season.

4.04. Raccoon - the bag limit during any 11-hour period beginning at 6:00 p.m. and ending at 5:00 a.m. is two raccoons for

one person or group of persons as a party and 20 per season.

4.05. Squirrels - Gray, Black, Albino, and Fox - Six in aggregate of all species per day. Possession limit is 24 after third day.

4.06. Ruffed Grouse (Native Pheasant) - Four per day. Possession limit is 16 after third day.

4.07. Bobwhite Quail - Seven per day, 21 in possession after second day.

4.08. Ring-necked Pheasant - Two per day, two per season.

4.09. Cottontail Rabbit - Five per day, possession limit 20 after third day.

4.10. Snowshoe or Varying Hare - Two per day, possession limit 8 after third day.

4.11. Red or Gray Fox (Combined) - Twenty-five per day and 25 per season.

4.12. Bobcat - Two per day and two per season.

4.13. Skunk, Opossum, Woodchuck or Groundhog, Weasel - No daily or season limit.

4.14. Mourning Doves, Ducks, Geese, Woodcock, Snipe, Gallinules, Virginia and Sora Rails - to be filed separately.

4.15. Wild Boar - One per day, one per season.

#### SECTION 5. GENERAL BOW AND ARROW HUNTING REGULATIONS

5.01. A long bow or compound bow may be substituted for a

gun during any season for which firearms are legal except during the muzzle-loading season.

5.02. Unlawful to hunt on Sunday with a bow except for legal aquatic life.

5.03. For bow and arrow fishing, a resident is required to have a fishing license; a nonresident is required to have a nonresident bow or gun hunting license or nonresident bow-only hunting license.

5.04. Unlawful to have bow in woods during closed season on game animals and non-migratory game birds.

#### SECTION 6. BOW AND ARROW HUNTING SEASONS

6.01. Deer - Bow and Arrow - ~~October 14, 1978 - December 30, 1978;~~ October 13, 1979 - December 31, 1979. Deer of either sex may be hunted statewide with a bow, except that bucks only may be hunted statewide with a bow ~~November 20, 1978 - December 2, 1978;~~ November 19, 1979 through December 1, 1979 inclusive.

6.02. Bear - Bow and Arrow - ~~October 14, 1978 - December 30, 1978;~~ October 13, 1979 - December 31, 1979.

(A) Adult Bear only.

(B) Bow hunting for black bear is restricted to those counties and parts of counties open to gun hunting.

(C) The use of dogs while bow hunting for black bear shall be unlawful except during the legal firearms season.

6.03. Small game and turkey - Bow seasons coincide with

small game firearms season and turkey firearms season respectively.

SECTION 7. GENERAL TRAPPING REGULATIONS

7.01. No traps shall be set before 8:00 a.m. ~~October 30, 1978~~  
October 29, 1979 or either set or left set after 12:00 noon ~~February 28,~~  
1979, February 29, 1980.

7.02. All traps must be checked and tended each calendar day.

7.03. No nonresident may trap in West Virginia.

7.04. Should any person unintentionally trap and kill more  
~~beavers or fishers~~ than the limit fixed by regulation as a season bag  
limit, he shall within 24 hours thereafter deliver said ~~beaver or fisher~~  
animals to a conservation officer.

7.05. Each trapper shall present beaver, bobcat and fisher  
pelts to a game checking station or representative of the Department  
of Natural Resources within 30 days after the close of trapping season.  
A tag provided by the Department shall be affixed to each beaver,  
bobcat and fisher pelt and remain attached to the skin until such skin  
has been sold, tanned or mounted.

7.07. IT SHALL BE UNLAWFUL:

(1) To have in possession an untagged beaver, bobcat,  
or fisher hide or parts thereof, between ~~March 30, 1978 and October 20,~~

1978; March 30, 1979 and October 29, 1979.

- (2) To use or set deadfalls for taking wildlife.
- (3) To set or use traps with an open jaw spread of more than  $6\frac{1}{2}$  inches: Except traps with an open jaw spread of more than  $6\frac{1}{2}$  inches may be used underwater for beaver.
- (4) To set or maintain any trap or trapping device in human foot trails and/or livestock paths.
- (5) To use conibear or mohawk type traps for terrestrial trapping: Provided that conibear or mohawk type traps may be used in underwater sets.
- (6) To set or maintain neck or body-gripping snares or spring pole snares: Provided that neck and body-gripping snares can be used in underwater sets.
- (7) To use exposed baits in the form of animal or bird carcasses or part thereof to lure an animal to a trap set: Provided that animal or bird carcasses or parts thereof that are completely covered and concealed from sight, may be used as a lure.
- (8) To trap except on one's own lands without first having obtained the written permission of the landowner as required by law.
- (9) To use steel jaw traps with any teeth on or attached to them.
- (10) To set or maintain any trap, trap set or snare upon

any tree, post or other natural or man-made object at any point more than 3 lineal feet from the surface of the earth (whether such surface is water, soil or rock) measured at a right angle from the surface to the trap or trap set: Provided that nothing herein shall apply to traps or trap sets set or maintained on natural earthen mounds, such as ant hills or muskrat houses constructed without human assistance.

SECTION 11. SPECIAL MUZZLE LOADING DEER HUNTING SEASON

11.01. Season - ~~December 4, - 5, - 6, - 1978; December 3, 4, 5,~~  
1979.

11.02. Bag limit and possession limit - one deer per season, provided that the hunter has not killed a deer ~~with a firearm in 1978;~~  
during the 1979 bucks-only season.

11.03. General

- (a) Only deer having one or both antlers 3 inches or more in length above the hairline will be legal game.
- (b) Only flintlock rifles with a minimum caliber of .44 may be used. Only iron sights may be used.
- (c) Weapons may be either rifled or smooth bore.
- (d) A single shot weapon that has been converted to a muzzle-loader using a plug shall not be used.
- (e) Any person who has previously killed a deer ~~with a firearm in 1978~~ during the 1979 bucks-only season will not be permitted to hunt.
- (f) Only state-owned or leased public hunting and fishing areas and state forests will be open for

the muzzle-loading deer season.

- (g) No concurrent hunting will be permitted on the state-owned or leased areas during this special season.
- (h) Percussion, flintlock and other weapons employing obsolete ignition systems will be considered unloaded when uncapped or when the priming charge is removed from the pan.
