Enclosed are two copies of a supplement to Administrative Regulations, Series IV, Section 4:03, Chapter 20 of the Code of West Virginia, covering the 1971-72 wild turkey season. This regulation should read as follows:

4:03 - Wild Turkey - October 16, 1971 - November 20, 1971 - Only in the following counties: Berkeley, Grant, Greenbrier, Hampshire, Hardy, Mineral, Monroe, Morgan, Nicholas (east of State Route #20), Pendleton, Pocahontas, Randolph, Tucker and Webster.

October 16, 1971 - October 30, 1971 - Only in the following counties: Barbour, Braxton, Calhoun, Doddridge, Gilmer, Harrison, Lewis, Marion, Monongalia, Nicholas (between U. S. Route #19 and State Route #20), Preston, Ritchie, Taylor, Tyler, Upshur and Wetzel Counties.
