
NOTICE OF PUBLIC HEARING

SECTION 1. General

1.01. Scope

These legislative regulations establish the requirements relating to open dumping of solid waste, open dumps, and the installation, establishment, construction, modification, operation or abandonment of any facility for the processing, recycling or disposal of solid waste.

1.02. Authority

These regulations are issued under the authority of the Director pursuant to Chapter 20, Article 5F, Section 4 of the Code of West Virginia of 1931, as amended.

1.03. Applicability

These regulations shall apply to any person who owns, operates or is responsible for disposal, processing or recycling of solid waste.

1.04. Enforcement

The enforcement of these legislative regulations is vested with the Director of the West Virginia Department of Natural Resources or his authorized representative.

SECTION 2. Definitions

The terms "approved solid waste facility", "open dump", "sludge", "solid waste", "solid waste disposal", and "solid waste facility" shall have the same meaning as that given in Chapter 20, Article 5F and are hereby reproduced for convenience. Unless the context clearly requires a different meaning as used in Series XVIII, the terms:

2.01. "The Act" means the "Solid Waste Management Act", Chapter 20, Article 5F of the Code of West Virginia.

2.02. "Approved solid waste facility" means a solid waste facility or practice which has a valid permit under the Act.

2.03. "Class A sanitary landfill" means any solid waste facility for the disposal of solid waste on land which receives or is expected to receive an average daily quantity of mixed solid waste equal to or exceeding one hundred (100) tons each working day, or serves or is expected to serve a population equal to or exceeding forty thousand (40,000) persons.

2.04. "Class B sanitary landfill" means any solid waste facility for the disposal of solid waste on land which receives or is expected to receive an average daily quantity of mixed solid waste of less than one hundred (100) tons each working day, and serves or is expected to serve a population of less than forty thousand (40,000) persons.

2.05. "Clean Water Act" means the Federal Water Pollution Control Act, Public Law 92-500, as amended 33 U.S.C. 1251, et seq.

- 2.06. "Construction/demolition landfill" means any solid waste facility for the disposal of only construction/demolition waste on land.
- 2.07. "Construction/demolition waste" means waste building materials, grubbing waste and rubble resulting from construction, remodeling, repair and demolition operations on houses, commercial buildings and other structures and pavements, and may include certain dredging materials.
- 2.08. "Cover material" means soil or other material, approved by the Division, and used in a controlled manner to cover solid waste at solid waste disposal facilities.
- 2.09. "Department" means the West Virginia Department of Natural Resources.
- 2.10. "Director" means the director of the West Virginia Department of Natural Resources or his authorized representative.
- 2.11. "Disease vector" means any insect, rodent or other organism capable of transmitting, directly or indirectly, infectious diseases or pathogenic organisms from one person or animal to another.
- 2.12. "Division" means the division of water resources of the West Virginia Department of Natural Resources.
- 2.13. "Endangered Species Act" means the Federal Endangered Species Act, as amended, 16 U.S.C. 1536.
- 2.14. "Incinerator" means any solid waste facility, including any equipment, machine, device, structure or part of a structure used to burn solid waste.
- 2.15. "Leachate" means any liquid produced or emanating from any solid waste facility.

2.16. "Lower explosive limit" means the lowest percent by volume of a mixture of explosive gases which will propagate a flame in air at twenty five degrees centigrade (25°C) and atmospheric pressure.

2.17. "Open dump" means any solid waste disposal which does not have a permit under the Act, or is in violation of state law, or where solid waste is disposed in a manner that does not protect the environment.

2.18. "Permit" means a written document issued by the division giving the permit holder permission to install, establish, construct, modify, operate or abandon an approved solid waste facility on a specific tract or parcel of land.

2.19. "Persistent violation" means any violation of the Act, these regulations, any permit term or condition, or any order of the department or division which is identified during two or more consecutive inspections performed by the division, or which may, in the opinion of the Chief, cause a threat to the environment, health or safety.

2.20. "Recycling facility" means any solid waste facility for salvaging, separating or removing of any material from solid waste for the purpose of reuse or sale of the material, at which no land disposal of solid waste occurs, and at which solid wastes are not biologically, chemically or thermally transformed.

2.21. "Resource recovery facility" means any solid waste facility at which solid wastes are mechanically, biologically, chemically or thermally transformed for the purpose of separating, removing or creating any material or energy for reuse or sale, at which land disposal of solid waste does not occur. Resource recovery facilities shall include composting plants, incinerators equipped with integral

or separate heat recovery systems, and other such solid waste facilities not herein specified.

2.22. "Schedule of compliance" means a list of activities approved or ordered by the division or department, which may include dates or specified times for completion of each or all activities which, when completed, will result in a site, facility or practice which is environmentally sound and conforms to the requirements of the Act, these regulations, or permit terms and conditions.

2.23. "Sludge" means any solid, semisolid, residue or precipitate, separated from or created by a municipal, commercial or industrial waste treatment plant, water supply treatment plant or air pollution control facility or any other such waste having similar origin.

2.24. "Solid waste" means any garbage, paper, litter, refuse, cans, bottles, sludge from a waste treatment plant, water supply treatment plant or air pollution control facility, other discarded material, including carcasses of any dead animal or any other offensive or unsightly matter, solid, liquid, semi-solid or contained liquid or gaseous material resulting from industrial, commercial, mining, agricultural operations or from community activities but does not include solid or dissolved material in sewage, or solid or dissolved materials in irrigation return flows or industrial discharges which are point sources and have permits under article five-a, chapter twenty of the Code, or source, special nuclear or by product material as defined by the Atomic Energy Act of 1954, as amended, or a hazardous waste either identified or listed under article five-e, chapter twenty of the Code or refuse, slurry and over burden regulated under article six, chapter twenty of the Code.

- 2.25. "Solid waste disposal" means the practice of disposing solid waste including placing, depositing, dumping or throwing or causing to be placed, deposited, dumped or thrown any solid waste.
- 2.26. "Solid waste disposal facility" means any solid waste facility installed, established, constructed, modified or operated for the purpose of solid waste disposal.
- 2.27. "Solid waste facility" means any system, facility, land contiguous land, improvements on the land, structures or other appurtenances or methods used for processing, recycling or disposing of solid waste, including landfills, transfer stations, resource recovery facilities and other such facilities not herein specified.
- 2.28. "Solid waste processing or recycling facility" means any solid waste facility installed, established, constructed, modified or operated for the purpose of physical, chemical or biological processing or recycling of solid waste including recycling facilities, resource recovery facilities, transfer stations and other such solid waste facilities not herein specified.
- 2.29. "State Water Pollution Control Act" means article five-a, chapter 20 of the Code of West Virginia, as amended.
- 2.30. "Transfer station" means any fixed or mobile solid waste processing or recycling facility with mechanical equipment or structures used for temporary accumulation or storage, compaction or consolidation of solid waste prior to transportation of solid waste to another solid waste facility. The term transfer station shall not include individual solid waste route collection vehicles or equipment.
- 2.31. "Water Resources Board" means the state water resources board.

2.32. "100-Year flood" means a flood of a magnitude equalled or exceeded once in 100 years on the average over a significantly long period.

2.33. "Chief", "person", "persons", "applicant", "water", "waters", "water resources", "sewage", "point source", and "code" mean the same as defined in section 2, article five-a, chapter twenty of the Code.

### SECTION 3. Solid Waste Facilities

#### 3.01. Requirement

Solid waste shall be disposed only at approved acceptable solid waste disposal facilities as described in subsection 3.02 of these regulations. Solid waste shall be processed or recycled only at approved acceptable solid waste processing or recycling facilities as described in subsection 3.03 of these regulations.

#### 3.02. Acceptable Solid Waste Disposal Facilities

Final disposal of solid waste shall occur only at approved solid waste facilities. Acceptable approved solid waste disposal facilities shall include the following, or any combination thereof:

- (a) Class A Sanitary Landfill;
- (b) Class B Sanitary Landfill;
- (c) Class C Sanitary Landfill (Reserved);
- (d) Construction/Demolition Landfill;
- (e) Incinerator;
- (f) Other solid waste disposal facility approved in writing by the department.

3.03. Acceptable Solid Waste Processing or Recycling Facilities

Processing and recycling of solid waste shall occur only at approved solid waste facilities. Acceptable approved solid waste processing and recycling facilities shall include the following, or any combination thereof:

- (a) Transfer Station;
- (b) Recycling Facility;
- (c) Resource Recovery Facility;
- (d) Other solid waste processing or recycling facility approved in writing by the department.

SECTION 4. Permits

4.01. Requirement

A permit shall be obtained from the division prior to installation, establishment, construction, modification, operation or abandonment of any solid waste facility.

4.02. Single Permit

Permits issued pursuant to these regulations shall meet the requirements established under the State Water Pollution Control Act and applicable regulations which are in effect pursuant to that act, so that only one permit shall be required for any solid waste facility. Such permit shall meet the requirements of the Act, these regulations, the State Water Pollution Control Act and regulations pursuant to it.

4.03. Permit Term

All permits issued pursuant to these regulations shall have a fixed term not to exceed five (5) years from the date of issuance. The division may administratively extend any permit expiration date for a period of up to one year.

4.04. Permit Application

Application for a solid waste facility permit shall be submitted to the division on forms and in the manner prescribed by the department. The division shall review each permit application within sixty (60) days of its receipt to determine if it is administratively complete.

4.05. Permit Application Fees

(a) Application for a solid waste facility permit shall be accompanied by a nonrefundable application fee in accordance with the following schedule of fees:

(b) Refiling Incomplete Application. A fee equal to one half on the application fee listed in subsection 4.05(a) shall accompany a permit application refiled due to incompleteness.

4.06. Public Participation in Permit Application Process

(a) Public notice and opportunity for public comment shall be provided by the applicant prior to division action on a permit for any solid waste facility. Public participation in the permit application process shall be provided in the form and manner prescribed by the department. The applicant shall maintain a public participation file consisting of the public notice, all written comments received and any resolution of adverse public comment.

The public participation file shall be submitted to the division before action is taken by the division on the application.

(b) The division may conduct a public hearing concerning any application for a solid waste facility permit. Persons may request such public hearing by submitting a written request for a public hearing to the division in a form and manner prescribed by the department.

4.07. Permit Denial

(a) The Chief may deny an application for a solid waste facility permit if:

- (1) The application does not clearly identify all measures to be provided at the solid waste facility to comply, or does not comply with the Act, these regulations, or other specific requirements established by the Director under the Act;
- (2) The application does not clearly identify all measures to be provided at the solid waste facility to minimize environmental impact, health and safety hazards;
- (3) The application contains false or misleading information;
- (4) The Chief determines that the site soils, geologic, hydrologic, or other site conditions are unacceptable;
- (5) The Chief determines that the proposed measures and practices included in the application will not meet the requirements of the Act, these regulations, the State Water Pollution Control Act or its applicable regulations.

4.08. Transfer of Permit

(a) Any permit issued by the division after the effective date of these regulations may be transferred to another person if:

- (1) The permittee notifies the division on forms and in a manner prescribed by the department at least forty-five (45) days prior to the proposed transfer date provided in subsection (2) of this section;
- (2) The notification shall include a written agreement between the person and permittee containing a specific date for transfer and a description of permit responsibility, coverage and liability between them;
- (3) The division does not notify the permittee and person that a new application for permit is required; and
- (4) The division approves the transfer of the permit in writing.

(b) The division may refuse to transfer any permit and require that an application for a solid waste facility permit be submitted prior to any transfer of permit responsibility, coverage and liability.

SECTION 5: Existing Approved Solid Waste Facilities

5.01. Existing Permits

(a) All existing permits of the Department of Health for solid waste facilities under section nine, article one, chapter sixteen of the Code shall continue in full force and effect until a permit is issued for that approved solid waste facility under the Act. All such existing permits of the Department of Health shall expire within five (5) years of the effective date of the Act (June 10, 1983).

(b) Within four (4) years of the effective date of the Act (June 10, 1987), all persons holding such Department of Health permits shall apply to the division for a permit under the Act.

(c) The Chief may require persons holding such existing Health Department permits to apply for a permit prior to four (4) years from the effective date of the Act if persistent violations of the Act, any permit term or condition, orders or these regulations exists at that facility.

## SECTION 6. Compliance

### 6.01. Requirement

All solid waste facilities shall be installed, established, constructed, modified, operated and abandoned in accordance with the Act, these regulations, permit terms and conditions, and any orders of the division or department.

### 6.02. Compliance Orders

If the Director of Chief, upon inspection or investigation by an authorized representative or through other means observes, discovers or learns of a violation of the Act, these regulations, the State Water Pollution Control Act or its regulations, or any permit or order issued under the Act, he may issue an order requiring compliance within a specified time.

### 6.03. Permit Suspension or Revocation

#### (a) Suspension

A solid waste facility permit may be suspended by order of the division or department for any of the following reasons:

- (1) Violation of the Act, these regulations or any order of the division or department;
- (2) Interference with a representative of the department in the performance of his duties;
- (3) Failure to adhere to the terms and conditions of the permit or any order of the division or department;
- (4) The permittee's failure in the application or during the permit issuance process to fully disclose all relevant facts, or the permittee's misrepresentation of any relevant facts at any time.

(b) Revocation

A solid waste facility permit may be revoked by order of the division or department for any of the following reasons:

- (1) Any deficiency at the solid waste facility constituting a imminent pollution, health or safety hazard;
- (2) Persistent violation of these regulations, permit terms and conditions, or orders of the division or department;
- (3) The permittee's failure in the application or during the permit issuance process to fully disclose all relevant facts, or the permittee's misrepresentation of any relevant facts at any time.

(c) Effect of Permit Suspension or Revocation

- (1) Suspension. All solid waste processing, recycling or disposal activities and receipt of any solid waste at the solid waste facility shall cease immediately upon receipt of an order of suspension. Receipt of solid waste and

operations at the solid waste facility may recommence only after expiration of the order of suspension, or upon revocation of the order of suspension by the division.

- (2) Revocation. All solid waste processing, recycling or disposal activities and receipt of any solid waste at the solid waste facility shall cease within fifteen (15) days of receipt of an order of permit revocation. The solid waste facility owner shall submit an application for a permit to abandon the facility within the time specified in an order of revocation.
- (3) Environmental Monitoring and Control. Environmental monitoring and control activities specified in an order of permit suspension or revocation shall continue at the solid waste facility for the duration of such order or until the division approves their cessation.

## SECTION 7. Open Dumps

### 7.01. Prohibition

- (a) Creation, contribution of solid waste to, or operation of an open dump is prohibited unless such open dump is under a compliance schedule approved by the division.
- (b) No landowner shall allow an open dump to exist on his property unless such open dump is under a compliance schedule approved by the division.
- (c) Subsections 7.01(a) and (b) shall not prevent a person from disposing of solid waste from his own household upon his own private, rented or leased property as long as such solid waste disposal does

not create a public nuisance, hazard to health, or violate the terms of section fifteen, article five-a, chapter twenty or any other provision of the Code.

7.02. Minimum Performance Standards

(a) General

Solid waste facilities which do not comply with the standards established in this subsection are open dumps.

(b) Valid Permit

Solid waste facilities shall have a valid permit from the division.

(c) State Law

Solid waste facilities shall comply with state law.

(d) Site and Operating Standards

Solid waste facilities or solid waste disposal which does not comply with the following standards are solid waste which is disposed in a manner that does not protect the environment, and shall be classified as open dumps.

- (1) Solid waste facilities shall minimize disease vectors by application of cover material at the end of each operating day or other approved frequency and in such a manner as to impede disease vector access to the waste, or other techniques appropriate to protect public health and approved in writing by the division.
- (2) Solid waste facilities shall not contribute or cause discharge of pollutants to the waters of the State in violation of the State Water Pollution Control Act or regulations pursuant to that act. Solid waste facilities

shall not cause a discharge of dredged or fill material to the waters of the State in violation of the requirements of Section 404 of the Clean Water Act, as amended.

- (3) Solid waste facilities shall not engage in open or uncontrolled burning of solid wastes. This requirement shall not apply to infrequent burning of agricultural or silvicultural wastes in the field, land-clearing debris, diseased trees, or debris from emergency clean-up operations. Solid waste facilities shall not violate applicable requirements of the regulations of the State Air Pollution Control Commission or division of forestry which are in effect concerning burning of solid wastes.
- (4) Groundwater (Reserved)
- (5) The concentration of explosive gases generated by solid waste facilities shall not exceed twenty-five percent (25%) of the lower explosive limit for the gases in facility structures, excluding gas control or recovery structures; nor one-hundred percent (100%) of the lower explosive limit for the gases at the property boundary.
- (6) Solid waste facilities shall limit public access to minimize potential health and safety hazards.
- (7) Solid waste facilities in floodplains shall not restrict the flow of the 100-year flood, reduce the temporary water storage capacity of the 100-year floodplain, or result in the carrying away of solid waste by waters of the 100-year flood.

- (8) Solid waste facilities shall not cause or contribute to the taking of any endangered or threatened species of plant, fish or wildlife; nor cause or contribute to the destruction or adverse modification or a critical habitat of endangered or threatened species of plants, fish or wildlife as identified by the Endangered Species Act or regulations pursuant to it.
- (9) Solid waste facilities shall not receive solid waste which may be designated as hazardous or infectious waste under the provision of the State Hazardous Waste Management Act, Chapter 20, Article 5E of the Code of West Virginia or regulations pursuant to that act.
- (10) Solid waste facilities shall employ methods to minimize bird attraction when any part of the facility is within five thousand feet (5000 feet) of any airport runway.

#### 7.03. Schedules of Compliance for Open Dumps

- (a) Schedules of compliance for open dumps shall contain a sequence of enforceable actions, with specific times or dates for completion of each action.
- (b) Time schedules of compliance for open dumps shall not exceed a total time period for all compliance actions of three (3) years from the date of issuance of the compliance schedule by the division or department.

### SECTION 8. Permits By Rule

#### 8.01. Applicability

- (a) Recycling facilities existing on the effective date of these regulations shall be considered to have a valid permit from the

department if the requirements of subsection 8.02 and 8.03 of this section are fulfilled.

(b) Recycling facilities which are developed after the effective date of these regulations shall be considered to have a valid permit from the department upon fulfilling the requirements of subsection 8.02 and 8.03 of this section.

8.02. Notification of Activity

(a) Existing Qualifying Recycling Facilities

(1) Notification. Any existing recycling facility which qualifies for a permit by rule shall notify the division of its existence within ninety (90) days of the effective date of these regulations.

(2) Certification. Within six (6) months of the effective date of subsection 8.03 of this section existing qualifying recycling facilities shall certify to the division in writing that the provisions of that subsection have been fulfilled.

(b) New Qualifying Recycling Facilities

(1) Notification. Any new recycling facility which qualifies for a permit by rule shall notify the division of its existence prior to installation, establishment, construction, modification or operation of the recycling facility.

(2) Certification. Any new recycling facility which qualifies for a permit by rule and is established prior to the promulgation of subsection 8.03 of this section shall certify to the division in writing, within six (6) months of the effective date of that subsection, that the requirements under subsection 8.03 have been fulfilled.

(3) Certification. Any new recycling facility which qualifies for a permit by rule and is established after the effective date of subsection 8.03 shall certify to the division in writing that the requirements of that subsection have been fulfilled prior to installation, establishment, construction, modification or operation of the recycling facility.

(c) Form of Notification and Certification.

Notification and certification required by this section shall be made to the division on forms and in the manner prescribed by the department.

8.03. Recycling Facility Standards (Reserved).

SECTION 9. Permit Review By The Director

9.01. Ability to Review Permit Issuance

The Director may review issuance of a solid waste facility permit.

9.02. Commencement of Review of Permit Issuance

The Director may commence review of the issuance of a solid waste facility permit only after receipt of one or both of the following within thirty (30) days of issuance of such permit by the division:

(a) A written request for review of the permit issued, submitted by the Chief;

(b) Separate written request for review of the permit issued by a minimum of twenty (20) persons residing within ten (10) miles of the proposed solid waste facility location.

9.03. Basis of Permit Review By The Director

The Director, in reviewing a permit issued, may use any information available to him concerning such solid waste facility permit including, but not limited to:

- (a) Information in the application for a solid waste facility permit;
- (b) Public comment;
- (c) Other information supplied by the applicant for such permit;
- (d) Information from any division of the Department of Natural Resources;
- (e) Other information not herein specified;
- (f) Information acquired at a public hearing. A public hearing may be conducted by the department during review of issuance of a permit by the Director. A physical record of a public hearing shall be made part of the department's order of permit review required in subsection 9.05 of these regulations.

9.04. Basis of Denial of A Permit By the Director

The Director may deny issuance of a solid waste facility permit when he determines that issuance of such permit:

- (a) Would adversely affect natural resources under his supervision;
- (b) Would cause irreparable damage to the environment near the proposed solid waste facility;
- (c) Would result in endangerment of property of others;
- (d) Would result in permanent aesthetic degradation on or near the proposed solid waste facility;
- (e) Is significantly adverse to the sentiment of the public in the area of the proposed solid waste facility location.

9.05. Order of Permit Review

- (a) Requirement

The Director shall issue an order of permit review upon completion of his review of the permit issued. The Director may, upon completion of permit review, deny issuance of such permit,

concur with issuance of such permit or remand the permit issued to the division for further consideration with specific instructions concerning any issue included in subsection 9.04 of these regulations.

(b) Contents

The order of permit review shall include, at a minimum, a description of all sources of information used in review of the permit issued, a description of the action ordered by the Director, and all reasons for ordering such action.

SECTION 10. General Administration and Enforcement

10.01. General Supervision

(a) The department and division shall exercise general supervision over the administration and enforcement of the Act, these regulations, existing permits and any permits and orders issued pursuant to the Act and these regulations.

(b) Whenever necessary to carry out the objectives of the Act and these regulations the division may require any person responsible for an open dump, solid waste facility or other place where solid waste is present to:

- (1) Establish and maintain such records;
- (2) Make such reports;
- (3) Install, use and maintain such monitoring equipment, facilities or methods;
- (4) Take and analyze samples of soils, water, wastes or air at such locations and intervals, and in such manner as the division shall prescribe; or
- (5) Provide such other information as the division may reasonably require.

(c) Whenever necessary to carry out the objectives of the Act and these regulations an authorized representative of the division:

- (1) Shall have the right to enter upon or through any premises in which solid waste is present or any records required to be maintained under subsection 10.01(b) of this section are located;
- (2) May, at reasonable times, have access to and copy any records required to be maintained under subsection 10.01(b) of this section;
- (3) May inspect any monitoring equipment, facilities or methods required under subsection 10.01(b) of this section;
- (4) May inspect any open dump, solid waste facility or other place where solid waste is present; and
- (5) May sample any soils, water, wastes or air at any open dump, solid waste facility or other place where solid waste is present.

10.02. Permit Administration and Enforcement

(a) The division may require prior submission of plans, specifications and other data pertaining to installation, establishment, construction, modification, operation or abandonment of a solid waste facility or solid waste disposal in connection with issuance, suspension or revocation of such permits as are required by the Act and these regulations.

(b) The division shall make periodic inspections at every approved solid waste facility to implement and enforce the provisions of the Act, these regulations and any permits or orders issued pursuant to the Act and these regulations.

10.03. Enforcement

(a) If the division has reasonable cause to believe that a potential for environmental, aesthetic or property value degradation, or hazards to health or safety exist at any open dump, solid waste facility or other place where solid waste is present the division may require any person responsible for such open dump, solid waste facility or place to conduct such tests and to furnish such information as may be reasonably required to determine whether such open dump, solid waste facility or place where solid waste is present is, or may be causing such degradation or hazard; and the division may conduct any test or tests deemed necessary or useful by the division in making an investigation or determination.

(b) The department or division may perform or require a person, by order, to perform any and all acts necessary to carry out the provisions of the Act and these regulations.

SECTION 11. Appeals

11.01. Appeals to the Water Resources Board

Any person having an interest which is or may be affected, or who is aggrieved by any order of the division or department, issuance or denial of any permit, or any permit terms or conditions may appeal such action to the Water Resources Board in the same manner as appeals are taken under section fifteen, article five-a, chapter twenty of the Code.


