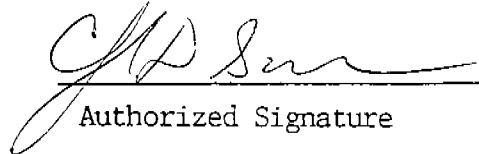

§ 24-5-1. General.

- 2.2. Reciprocity or Endorsement Application - \$200.00
- 2.3. Osteopathic Physician Corporation Application Fee - \$500.00
- 2.4. Osteopathic Physician Corporation Registration - \$250.00
- 2.5. Osteopathic Physician Endorsement or Written Licensure Verification - \$25.00
- 2.6. Osteopathic Physician State Board Scores - \$10.00
- 2.7. Late renewal fee - \$50.00
- 2.8. Osteopathic Physician Duplicate Wallet License - \$10.00
- 2.9. Osteopathic Physician Wall Certificate - \$20.00
- 2.10. Osteopathic Physician Educational Training Permit - \$50.00
- 2.11. Osteopathic Physician Biennial Renewal - \$200.00
