

§99-2-1. General.

- 1.1. Scope. -- This legislative rule establishes the ranks and duties of officers within the membership of the division.

§99-2-2. Organizational Structure.

2.1 The ranks within the membership of the division shall be Director, Deputy Director, Capitol Police Officer, Lieutenant, Capitol Police Officer, Sergeant, and Capitol Police Officer.

3.1. The duties of the "Director" shall be those as described under West Virginia Division of Personnel Class Specifications 8950.

3.2. The duties of the "Deputy Director" shall be those as described under West Virginia Division of Personnel Class Specifications 8951.

3.3. The duties of the "Capitol Police Officer, Lieutenant" shall be those as described under West Virginia Division of Personnel Class Specifications 8954.

3.4. The duties of the "Capitol Police Officer, Sergeant" shall be those as described under West Virginia Division of Personnel Class Specifications 8953.

3.5. The duties of the "Capitol Police Officer" shall be those as described under West Virginia Division of Personnel Class Specifications 8952.
