

**§17-1-1. General.**

1.1. Scope. — ~~These~~ This legislative ~~rules~~ rule establishes the fees for applications, examinations, temporary permits, license renewals and registers for psychologists and school psychologists.

1.2. Authority. — W. Va. Code §§30-21-6

1.3. Filing Date. — ~~June 30, 1993~~

1.4. Effective Date. — ~~June 30, 1993~~

**§17-1-2. Summary Of Fees.**

The following fees were approved by the Board ~~May 1, 1993~~ June 14, 1997:

2.1. Application fee (whether by standard procedure, reciprocity or verification by American Board of ~~Examiners in Professional Psychology diploma~~): ~~Seventy-five dollars (\$75.00)~~

2.2. Temporary permits: ~~Seventy-five dollars (\$75.00)~~

2.3. Biannual license renewal fee ~~(every two (2) years):~~ ~~One hundred dollars (\$100.00)~~ Two hundred fifty dollars (\$250.00) ~~except for Non-practicing and/or non-resident psychologists fifty dollars (\$50.00); School Psychologist, triannual renewal fee, fifty (\$50.00) And for those with Licenses which have been placed on inactive status for whom there is No (\$0.00) renewal fee.~~

2.4. Registers: Ten dollars (\$10.00)

2.5. Copies of licensure law and legislative rules: Ten dollars (\$10.00) each.

2.6. Examination fee: The fee for the Examination for Professional Practice in Psychology ~~will~~ shall cover the fee established by the ~~American Association of State Psychology Boards plus Association of State and Provincial Psychology Boards~~ and shall include forty dollars (\$40.00) for administrative costs. ~~The fee must be paid~~ An applicant for licensure shall pay the fee to the Board at least thirty (30) days prior to the date of the examination.

2.7. Oral examination fee for each examination: ~~One hundred twenty five dollars (\$125.00)~~ Two hundred fifty dollars (\$250.00).

2.8. Annual supervision fee: Fifty dollars (\$50.00)

2.9. All of the above fees contained in this section are nonrefundable.

Amendment to Rule: West Virginia Board of Examiners of Psychologists  
Fees (17CSR1)

Subsections 2.3 and 2.7 of the proposed rule be amended to reduce both the license renewal fee for psychologists and the oral examination fee from \$250 to \$175.
