16 Be it enacted by the Legislature of West Virginia:

A BILL to amend and reenact section nineteen (twenty-three)(six), article two, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to authorizing the racing commission to promulgate legislative rules for the purpose of regulating greyhound racing (Rule 628).

Be it enacted by the Legislature of West Virginia:

That section nineteen (twenty-three)(six), article two, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 2. EXECUTIVE AGENCY AUTHORIZATION TO PROMULGATE LEGISLATIVE RULES.
