Title: Corporation Recordation in County Clerk's Office

Section 1. General

1.1 Scope - This is an interpretation of WV Code 31-1-28(b) relating to filing corporation documents in the county clerk's office.

Section 2. Filing in County Clerk's Office

WV Code 31-1-28(b) requires that a corporation file its certificate, or a duly certified copy thereof in the office of the clerk of the county commission. The "certificate" is interpreted by the Secretary of State to include the certificate of incorporation, together with the duplicate original of the articles of incorporation, or a duly certified copy thereof. Failure to file all documents as interpreted by this rule shall be considered as a violation of WV Code 31-1-28.
