SERIES 15
FILING FEE FOR CREDIT SERVICE ORGANIZATIONS

§153-15-1. General.

1.1. Scope. -- This rule provides for the establishment of a filing fee for every registration statement filed with the Secretary of State by a Credit Service Organization.

1.2. Authority. -- W.Va. Code §46A-6C-5(e)

1.3. Filing Date. --

1.4. Effective Date. --

§153-15-2. Filing Fee.

2.1. Any organization required to file a registration statement with the Secretary of State's office, pursuant to the provisions of West Virginia Code 46A-6C-1 et seq., shall pay a fee of 50 (fifty) dollars. A registration statement is not complete without this fee accompanying it. A registration statement is invalid, if the check used to pay the fee is returned, due to a lack of funds, effective the day the returned check is received by the Secretary of State.
