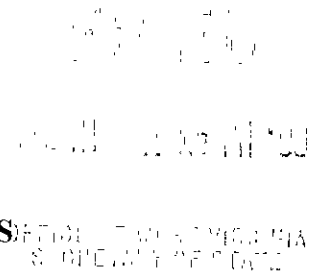

FILING FEES FOR CREDIT SERVICE ORGANIZATIONS

§153-15-1. General.

1.1. Scope. -- This rule provides for the establishment of a filing fee for every registration statement filed with the Secretary of State by ~~a Credit Service Organization~~ an organization required by law to file with the Secretary of State for which filing fees are not otherwise established.

1.2. Authority. -- W.Va. Code §46A-6C-5(e), W.Va. Code §46A-6GH-8(d).

§153-15-2. Filing Fee for Credit Service Organizations.

2.1. Any organization required to file a registration statement as a Credit Service Organization with the Secretary of State's office, pursuant to the provisions of West Virginia Code 46A-6C-1 et seq., shall pay a fee of ~~50 (fifty)~~ fifty (50) dollars.

2.2. A registration statement is not complete without this fee accompanying it. A registration statement is invalid, if the check used to pay the fee is returned, due to a lack of funds, effective the day the returned check is received by the Secretary of State.

§153-15-3. Filing Fee for Purchasers of Future Payments.

3.1. Any organization required to file a registration statement as a Purchaser of Future Payments with the Secretary of State's office, pursuant to the provisions of West Virginia Code 46A-6GH-1 et seq., shall pay a fee of fifty (50) dollars.

3.2. A registration statement is not complete without this fee accompanying it. A registration statement is invalid, if the check used to pay the fee is returned, due to a lack of funds, effective the day the returned check is received by the Secretary of State.
