SUMMARY OF FACTS AND CIRCUMSTANCES

FACTS

The National Voter Registration Act of 1993 required all states to implement voter registration at public assistance agencies and through state-funded programs whose primary purpose was to serve persons with disabilities. S. B. 520, passed in 1994, established these requirements as state law and provided for a rule-making process to identify the agencies required to provide these services beginning January 1, 1995.

CIRCUMSTANCES

Although West Virginia Code §3-2-13 requires the emergency rule be filed by October 1, 1994, designating the agencies to provide voter registration, the Secretary of State has worked with the various agencies of state government to identify the appropriate programs and office sites since July. Only in early November was the office able to complete the identification of the agencies which must provide these services in order to meet the requirements of the federal and state law.

The National Voter Registration Act requires that applicants of public assistance agencies and agencies serving the disabled provide voter registration on site beginning January 1, 1995. Without this designation, agencies may not comply with the federal law and voters may be disenfranchised and the state may be liable for court costs if compliants of noncompliance are filed.

AGENCIES DESIGNATED TO PROVIDE VOTER REGISTRATION SERVICES

§153-28-1. General.

- 1.1. Scope To designate those agencies and programs required to provide voter registration according to the provisions of the West Virginia Code §3-2-13.
 - 1.2. Authority West Virginia Code §§3-1A-6, 3-2-13
 - 1.3. Filing Date -
 - 1.4. Effective Date -

§153-28-2. Definitions.

For the purposes of this rule:

- 2.1. "Designated agency" means a department, division or office of state or local government, or a program supported by state funds which is designated by this rule to provide voter registration services according to the provisions of West Virginia Code §3-2-13 beginning January 1, 1995.
- 2.2. "Public assistance" agency means a designated agency which receives applications for assistance as defined in §9-1-2(e) for which an income means test is applied for determination of eligibility for assistance or benefits specified in West Virginia Code §3-2-13(b)(1).
- 2.3. "Disabilities services" agency means those designated agencies primarily engaged in providing services to persons with disabilities.
- 2.4. "County marriage license offices" shall mean those sections or divisions of the offices of the clerk of the county commission and/or those employees assigned to provide or receive marriage license applications, and shall not include those sections, divisions or employees delivering other services of the clerk's office.

§153-28-3. Designated Public Assistance Agencies.

The following public assistance agencies are designated as to provide voter registration services to applicants for services through the appropriate programs identified in this section:

- 3.1. Programs administered by the West Virginia Department of Health and Human Resources:
 - 3.1.1. under the Office of Income Maintenance:
 - a. the Aid to Families with Dependent Children (AFDC);
 - b. the Food Stamp program;
 - c. the Transportation Remuneration and Incentive Program (TRIP);
 - d. the Emergency Assistance Program;
 - e. the Low Income Energy Assistance Program (LIEAP);
 - f. the Medicaid program; and
 - 3.1.2. under the Nutrition Services Section, Bureau of Public Health:
 - a. the Women, Infants and Children program (WIC); and
 - 3.1.3. under the Social Services Division:
 - a. the Homeless program.

§153-28-4. Designated Disabilities Services Agencies.

The following disabilities agencies are designated to provide voter registration services to applicants for services through the appropriate programs identified in this section:

- 4.1. Programs administered by the West Virginia Division of Health and Human Resources:
 - 4.1.1. under the Office of Aging:
 - a. the Aging program;
 - b. the Geriatrics and Long-term Care program;

- c. the Medicaid Waiver program; and
- 4.1.2. the Commission for the Hearing Impaired; and
- 4.1.3. under the Infant and Child Health section:
 - a. the Early Intervention program;
 - b. the Handicapped Children program;
 - c. the Pediatric Health Services/EPSDT program; and
- 4.1.4. the Behavioral Health Services program.
- 4.2. Programs administered by the West Virginia Department of Education and the Arts:
 - 4.2.1. the Blind and Handicapped Division of the Library Commission; and
 - 4.2.2. the Division of Rehabilitation Services.
 - 4.3. Programs administered by the West Virginia State Board of Education:
 - 4.3.1. the West Virginia School for the Deaf and Blind.
 - 4.4. Programs administered by the West Virginia Department of Public Safety:
 - 4.4.1. the Division of Veteran Affairs.

§153-28-5. Designated Armed Services Recruitment Offices.

The following armed services recruitment offices are designated to provide voter registration services, which at the direction of the Federal Voting Assistance Program of the Department of Defense will be organized, supervised and directed by that program:

- 5.1. the United States Army Recruiting program;
- 5.2. the United States Air Force Recruiting program;
- 5.3. the United States Coast Guard Recruiting program;
- 5.4. the United States Marine Corps Recruiting program; and
- 5.5. the United States Navy Recruiting program.

§153-28-6. Designated County Marriage License Offices.

The county marriage license office within the office of the clerk of the county commission of each county of the state is designated to provide voter registration services.
