

Brief Summary of Proposed Rule Change, Series 6: Schedule of Fees

June 30, 2000

Purpose of rule change is to eliminate fee as set in this rule for veterinary medical corporation application fee, as it is set in the practice act, to create a fee to be paid for a background check on a CAET candidate, as we were not aware when the rules for CAET were created, that a fee would be charged to the Board for this criminal investigation. Additionally, we are now, as are all states, being charged with determining a candidate is eligible for the North American Veterinary License Exam (NAVLE). This will be time consuming. Other states polled indicate they will be charging a fee for this. Using the fee as determined by Virginia, we are adopting the same fee charge.
