10 A BILL to amend article nine, chapter sixty-four of the  
11 code of West Virginia, one thousand nine hundred  
12 thirty-one, as amended, by adding thereto a new  
13 section, designated section twenty-nine, relating to  
14 authorizing the board of veterinary medicine to  
15 promulgate a legislative rule relating to a schedule  
16 of fees.

17 **Be it enacted by the Legislature of West Virginia:**

18 That article nine, chapter sixty-four of the code of  
19 West Virginia, one thousand nine hundred thirty-one, as  
20 amended, be amended by adding thereto a new section,  
21 designated section twenty-nine, to read as follows:

22 **ARTICLE 9. AUTHORIZATION FOR MISCELLANEOUS AGENCIES AND**  
23 **BOARDS TO PROMULGATE LEGISLATIVE RULES.**

1 **§64-9-29. Board of veterinary medicine.**

2       The legislative rule filed in the state register on  
3 the third day of August, one thousand nine hundred  
4 ninety-eight, under the authority of section four, article  
5 ten, chapter thirty, of this code, modified by the board of  
6 veterinary medicine to meet the objections of the  
7 legislative rule-making review committee and refiled in the  
8 state register on the twenty-seventh day of October, one  
9 thousand nine hundred ninety-eight, relating to the board  
10 of veterinary medicine (schedule of fees, 26 CSR 6), is  
11 authorized.

13       NOTE: The purpose of this bill is to authorize the  
14 Board Of Veterinary Medicine to promulgate a legislative  
15 rule relating to a Schedule Of Fees.

16

17       This section is new; therefore, strike-throughs and  
18 underscoring have been omitted.
