- 2.1 Application and examination fee \$ 95.00
- 2.3 License fee..... \$ 5.00
- 2.4 Duplicate license..... \$ 5.00
- 2.5 Annual renewal fee..... \$100.00
- 2.6 Non-practicing veterinarian renewal fee:
Veterinarians outside state of W. Va.;
Veterinarians not operating in private practice
of veterinary medicine, including veterinarians
performing governmental work;
Veterinarians on inactive list..... \$ 50.00
- 2.7 Veterinarians wishing to change status from inactive
status must pay difference of renewal fee listed in
subsection 2.5 and 2.6 above..... \$ 50.00
- 2.6 Temporary permit..... \$ 25.00
- 2.7 Temporary permit renewal fee..... \$ 25.00
- 2.8 Endorsement into West Virginia...application fee plus
license fee plus \$10.00 a month until the end of current
licensing year.

A BILL to amend article nine, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section twenty-nine, relating to authorizing the board of veterinary medicine to promulgate legislative rules relating to a schedule of fees.

Be it enacted by the Legislature of West Virginia:

That article nine, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, designated section twenty-nine, to read as follows:

ARTICLE 9. AUTHORIZATION FOR MISCELLANEOUS AGENCIES AND BOARDS
TO PROMULGATE LEGISLATIVE RULES.

§64-9-29. Board of veterinary medicine.

1 The legislative rules filed in the state register on the
2 nineteenth day of August, one thousand nine hundred ninety-one,
3 modified by the board of veterinary medicine to meet the
4 objections of the legislative rule-making review committee and
5 refiled in the state register on the second day of January, one
6 thousand nine hundred ninety-two, relating to the board of
7 veterinary medicine (schedule of fees), are authorized.

9 NOTE: The purpose of this bill is to authorize the Board of
10 Veterinary Medicine to promulgate legislative rules relating to a
11 schedule of fees.
