TITLE: CERTIFICATE DEFINITIONS

SECTION 1. GENERAL

- 1.1 Scope- The Jurisdiction Committee of the Joint Commission is fulfilling a requirement set forth by the Legislature to develop a consistent plan for certificate programs.
- 1.2 Authority- West Virginia Code §18-2B-2(b)
- 1.3 Filing Date- September 1, 1995
- 1.4 Effective Date-

SECTION 2. COLLEGIATE CERTIFICATE PROGRAM

- 2.1 An educational certificate program offered by institutions of higher education containing specific academic requirements and technical competencies appropriate to meet current workplace objectives. Programs will consist of no less than 32 college credit hours, which may be the first year of an associate degree program.

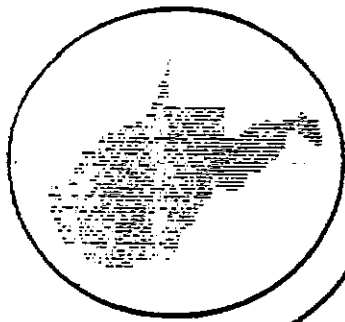
SECTION 3. TECHNICAL CERTIFICATE PROGRAM

- 3.1 An adult full time vocational-technical education program offered by local boards of education which contain specific academic requirements and technical competencies appropriate to meet current workplace objectives. Some or all of the technical certificate programs may be considered for articulation with community college programs leading to a two-year associate degree.

SECTION 4. OCCUPATIONAL CERTIFICATE PROGRAM

- 4.1 A full time vocational education program offered by local boards of education leading to a certificate of competence. Occupational certificate programs are freestanding and designed to meet current workplace objectives and/or employment opportunities. Programs are available for both adult and secondary students.
