

Title: Rule confirming existing practices and establishing additional, new procedures in relation to providing public notice of date, time, place and purpose of meetings of West Virginia Water Development Board.

Section 1. General

1.1 Scope - This procedural rule confirms the existing practices of the West Virginia Water Development Authority to provide public notice of the date, time, place and purpose of meetings of the West Virginia Water Development Board and establishes additional, new procedures in relation thereto.

1.2 Authority - W.Va. Code 20-5C-6(5) and W.Va. Code 6-9A-3.

Section 2. Confirmation of Existing Practice of Public Notification of Meetings and Establishment of Additional, New Procedures

In keeping with its existing practice of providing public notice of all meetings of the West Virginia Water Development Board, the West Virginia Water Development Authority shall continue to provide reasonable public notice of meetings by filing with the office of the Secretary of State for each meeting to be held a notice stating the date, time, place and purpose, unless provided otherwise herein. For purposes of this rule, a notice filed at least forty-eight hours prior to the meeting is deemed reasonable notice.

Section 3.           Emergency Meetings

Pursuant to W.Va. Code 6-9A-3, this rule does not apply to emergency meetings.

Section 4.           Continued Meetings

For purposes of this rule, the announcement of continuation at a meeting otherwise noticed hereunder shall be deemed reasonable notice of the reconvening of the continued meeting.

Section 5.           Additional Notice

Nothing in this rule shall prohibit the West Virginia Water Development Authority from providing additional notice for any particular meeting which it deems desirable or necessary, including the existing practice of causing the notice to be filed with the office of the Secretary of State in time to be included in an appropriate issue of the state register.

PUBLIC HEARING  
PROCEDURAL RULE  
WATER DEVELOPMENT AUTHORITY

On July 18, 1986, at 9 a.m., a public hearing was held in the Water Development Authority's office, 1201 Dunbar Avenue, Dunbar, West Virginia, by the Water Development Board. The proposed procedural rule confirms existing practices and establishes additional, new procedures in relation to providing public notice of date, time, place and purpose of meetings of the Water Development Board. An attendance list is attached.

Mr. Robert L. Bailey, Chairman of the Water Development Board, opened the public hearing by stating the hearing was being held in compliance with Chapter 20, Article 5C, Section 6 (1), of the West Virginia Code, which states that the West Virginia Water Development Authority has the power and capacity to adopt, and from time to time, amend and repeal bylaws necessary and proper for the regulation of its affairs and the conduct of its business and rules and regulations to implement and make effective its powers and duties, such rules and regulations to be promulgated in accordance with the provisions of Chapter 29A of the West Virginia Code. The hearing was also held in compliance with Chapter 6, Article 9A, Section 3, of the West Virginia Code, which requires proceedings to be open and public notice of meetings. He further stated that the hearing was being held in regard to adoption of a procedural rule.

The Chairman then outlined the ground rules of the hearing:

Statements, both written and oral, will be received during the hearing. Anyone wishing to make an oral statement should so indicate upon registering into the hearing.

If an oral statement is to be made from a written statement, it should be a summary of the written statement. Any such oral statement should not exceed five minutes. All other oral statements are also to be held to five minutes and are to be germane to the issue before the hearing. The Chairman reserves the right to decline receipt of comments not germane to the issue; namely, a procedural rule of the West Virginia Water Development Authority confirming existing practices and establishing additional, new procedures in relation to providing public notice of date, time, place and purpose of meetings of the West Virginia Water Development Board. It is the intention of the Board that anyone wishing to be heard under these guidelines will be heard; thus the five-minute limitation on statements is necessary.

The Chairman noted that, as provided by statute, copies of the proposed rule have been available to interested persons since public notice on June 17, 1986.

At this point, Mr. Edgar N. Henry, Director of the West Virginia Water Development Authority, reviewed the proposed rule. Under Section 1.2, Authority, he explained the reference to W. Va. Code 20-5C-6 (5) would be corrected to 20-5C-6 (1), which authorizes the adoption of rules governing the conduct of Water Development Authority business.

Chairman Bailey asked for both written and oral statements. There were none.

There being no further discussion, Chairman Bailey adjourned the hearing at 9:10 a.m.

During the Water Development Board's meeting immediately following the public hearing, Vice Chairman Averil L. Ramsey moved the adoption of the proposed rule as corrected and approval of its filing with the Office of the Secretary of State. Board Member Patrick C. Graney III seconded the motion, which was unanimously approved.
