DISTRIBUTION LIST

1. PURPOSE AND SCOPE: This regulation contains the distribution formula for directives published by The Adjutant General's Department. It should also be used as a guide for addressing official correspondence and publications to the commands and activities of the WVARNG.
2. RESPONSIBILITIES: DCSPA has proponent responsibility for this regulation and recommendations for changes will be submitted to him. Individuals preparing official correspondence will insure the proper distribution code is used. Publications are to be distributed on a need-to-know basis. In the event the formulas contained herein do not meet a distribution requirement, use of a modified or "Special" distribution formula (para 3b and 4, below) may be used.
3. DISTRIBUTION FORMULA:
  - a. Detailed breakdown with quantities furnished is indicated in Annexes A and B of this regulation.
  - b. Each addressee listed under a symbol in this regulation is identified by a number. When, in connection with the need-to-know distribution policy, it is desirable to omit certain addressees, the deletion may be indicated as in the following example: A (less 8, 12 and 13).
  - c. Special distribution may be used as appropriate to include using the routine distribution formula and then adding or minusing certain items; i.e., Distribution A, plus First U.S. Army or Distribution A (less item 12). The correct mailing addresses must be furnished for addressees not included in the normal distribution formulas.
4. CLASSIFIED PUBLICATION: Special care will be used in publishing and distributing classified information. The security control officer will determine the distribution of classified documents and maintain records of distribution IAW governing regulations.
5. USPFO: Distribution for publications issued by the USPFO-WV are specified in their SOP.
