**Dear Secretary Tennant:** 

The West Virginia Board of Examiners for Registered Professional Nurses (Board) in session July 27, 2012 approved the proposed rule WV 19 CSR 12 Fees for Services Rendered by the Board and Supplemental Fee for the Center for Nursing. This letter serves to notify your office of the agency approval and to provide the required brief summary for the proposed changes.

The Board regulates over 30,000 registered professional nurses. The last fee increase for Board operations was in 1992 when the annual renewal fee increased from \$15.00 to \$25.00. In 2005, a fee increase of \$10.00 to support the West Virginia Center for Nursing was approved raising the annual renewal fee to \$35.00 with the Board continuing to receive \$25.00 of this amount. The increase proposed at this time provides for a total of a \$30.00 increase in the annual renewal fee resulting in an annual renewal fee of \$65.00. The fee increase will be divided providing \$15.00 to Board operations and \$15.00 deposited directly into a fund for nurse health programs.

The nurse health programs are monitoring programs that will assist in public protection by providing monitoring and recovery support for nurses with substance use disorders and qualifying mental health conditions. The program is similar to that which already exists for the West Virginia Board of Medicine for monitoring physicians with similar diagnoses. The monitoring program also includes further educating all nurses about the disease of addiction, how to identify addiction in one's self and others, the importance of, and how to, seek assistance, and initiating support groups across the state all in an effort to reduce the occurrence of the disease of addiction and how to provide support for those in recovery.

Registered Professional Nurses (RN) have been notified of this change and the Comment Period through a news magazine sent to all actively licensed RN's in March and early June 2012 as well as a web site notification.

I am responding to the proposed legislative rule title number 19 series 12 cite authority 30-7-4, 30-7-8a, 30-1-4 titled Fees Increase.

I would first like to commend the entire board and staff for the hard work put forth on the drafting of multiple regulatory legislative rules. The West Virginia Nurses Association (WVNA)would like to congratulate the board for their dynamic ability to address these tough public safety issues. I am writing in support of the FEES RULE, 19CSR12. I realize that our current fees are low and have not been raised in recent memory – not in the entire time I have held a WV license (13 years). Our licensing fees support the work of the Board of Nursing, which is vital not only for public safety but also for continuity of the nursing profession in this state.

#### To Whom It May Concern:

It is of no surprise that a license fee increase is necessary to support the administration cost increases. Despite the claim of many legislators, inflation is quite real as it can easily be spotted in the grocery store and in the scrub shop. Unfortunately, many of West Virginia's nurses have not seen a reflection of the increased dollar signs on their direct deposit slips. We have nursing schools pumping out nurses much faster than many markets can absorb. The combination of a shoddy economy, increased regulations at the federal level and the push for ACOs, unknown future Meaningful Use requirements, Value-Based Purchasing, etc. helps to keep GN hiring low and wages stagnant. Many of WV's nurses are un or under-employed and there's a proposal to increase licensing fees by a whopping 90%!?! Perhaps the goal is \$50 for a renewal fee and we're being shocked by \$65 so that \$50 doesn't seem so bad.

"Approximately 15% of nurses have a Substance Use Disorder." (West Virginia Nurse) As I understand this statement, 85% of WV's registered nurses will have to pay for the 15% that have a substance abuse disorder??? How about we just call this a "Registered Nurse tax." As an individual that has many mistakes in his past, I am not one to judge the actions of another. However, I've never asked for another to pay for my poor judgement and situations.

There were several hundred nurses asking for jobs at nurse unity day; I was there. Unfortunately, there are many more nurses than jobs at this time. I have received over 150 applications for 15 GN positions. It seems to me that this is the perfect opportunity to move to allow those with substance abuse disorders to clean *themselves* up while moving to baccalaureate or graduate level nursing as being the minimum for entry to practice and grandfather those that are already RN's without the proposed education level.

This opportunity may not rise again. Those that can no longer function safely have no business caring for our patients. Rehabilitation does not happen overnight. Let them move aside for the younger nurses that have not had the chance to use their talents nor had an opportunity to repay their tax payer-backed student loans.

Thank you for allowing and giving the opportunity for West Virginia's Professional Registered Nurses voice their opinions and concerns.

Thank you for providing comments to the proposed changes to West Virginia Code of State Rules Title 19 Series 12 Fees for Services Rendered by the Board and Supplemental Fee for the Center for Nursing by the West Virginia Board of Examiners for Registered Professional Nurses (Board). In response to your concerns about and opposition to the fee increase, the Board wants to share that the agency has not had a renewal fee increase since 1992. All efforts have been made over the years to minimize operational costs. The Board has now exhausted all avenues to minimize costs and finds it necessary to increase fees in order to successfully meet its legislative mandate of public protection.

West Virginia has a current substance misuse epidemic. A portion of the proposed fee increase will be to further fund the Board's monitoring program and establish a non-disciplinary nurse health program, West Virginia Restore (WV Restore). WV Restore is an alternative program is for nurses with substance use disorders and qualifying mental health conditions. It is not a treatment program. The Board will not be paying for treatment. The nurse health program includes preventive education for all nurses and employers regarding recognizing these issues in themselves and others, and will provide an ongoing monitoring and recovery program for nurses who are able to return to practice after meeting the program requirements. The related law is identical to that of the Physician Health Program (PHP) through the Board of Medicine. That program has documented significant success in addressing this issue among the medical community.

The majority of complaints received by the Board relate to substance use and misuse by registered professional nurses. Prevention and early intervention will assist nurses in getting the help they need before there is any patient harm, there is an addiction, or their workplace is affected. Essentially, the Board is implementing a program intended to save lives. The Board will be seeking the proposed fee increases.

Hello, my name is Amanda Barnett (WV License # 66786). I recently received the West Virginia Nurse newsletter in the mail and was reading about the fee increases for our license renewal. My concerns are about the possible fee increase for the processing of a paper renewal. When I first renewed my license in 2006 I believe, I did attempt to renew online. However, because of an address discrepancy, your system would not allow me to do so. Allow me to explain. I physically live in Rome Township, Lawrence County, Ohio. However, my address is Crown City, Ohio although we do not live in Crown City. Crown City is actually in Gallia County, Ohio. The way it was explained to us, there had to be a cut off with the postal service so...the street directly across from us has addresses that are Proctorville, Ohio yet everyone on our street has a Crown City, Ohio address. When I entered my Crown City address and then entered the county as Lawrence—it showed a discrepancy obviously and would not let me renew. If there is some way that you could change this in your system so that it lets people enter whatever county they want and not show a discrepancy? —that would be great. I did not want to just leave Gallia county on there knowing that I do not technically live in Gallia county because this would be falsifying information. In addition, if this glitch cannot be fixed, I do not feel that I should be penalized because I have to use the paper renewal and be charged an extra \$40. Thank you for your consideration with this matter. I am hoping that by sending this now, in May, that a solution can be reached well before our next renewal date in October. Thank you for your time.

I am writing to register my protest to the proposed fee increase for RN License renewal. I feel that this is an exorbitant increase in fees compared to the 6 other states in which I have been licensed as an RN! I also feel that it is not my responsibility to provide treatment for individuals who cannot, or will not, control their own behaviors--if they are not capable of performing their duties as a Registered Nurse, for whatever reason, they should not be allowed to practice and other nurses should not be held liable to pay for their treatment!

As an "old timer", I resent having to be responsible for others who no longer honor the commitment and oath of service that they took when they first sought to be a nurse!

I have repeatedly seen concerns expressed that there are not enough nurses to meet the current need in the State of West Virginia, and no one seems to know why. I can give a very good reason for this lack of nurses: pay scales (I am earning 50% less and doing more since I returned to W.V than I was working in Ohio, Maryland, Florida, Arkansas, Missouri or Indiana)--if I still had children to raise, I could not have afforded to move back to WV in 2007. Adding such exorbitant license fees to already low pay scales will drive even more nurses out of the state! I will not be renewing my license this year, or in the future--with the increased fees and no pay increase, I can clear more working in another field.

It is of no surprise that a license fee increase is necessary to support the administration cost increases. Despite the claim of many legislators, inflation is quite real as it can easily be spotted in the grocery store and in the scrub shop. Unfortunately, many of West Virginia's nurses have not seen a reflection of the increased dollar signs on their direct deposit slips. We have nursing schools pumping out nurses much faster than many markets can absorb. The combination of a shoddy economy, increased regulations at the federal level and the push for ACOs, unknown future Meaningful Use requirements, Value-Based Purchasing, etc. helps to keep GN hiring low and wages stagnant. Many of WV's nurses are un or under-employed and there's a proposal to increase licensing fees by a whopping 90%!?! Perhaps the goal is \$50 for a renewal fee and we're being shocked by \$65 so that \$50 doesn't seem so bad.

"Approximately 15% of nurses have a Substance Use Disorder." (West Virginia Nurse) As I understand this statement, 85% of WV's registered nurses will have to pay for the 15% that have a substance abuse disorder??? How about we just call this a "Registered Nurse tax." As an individual that has many mistakes in his past, I am not one to judge the actions of another. However, I've never asked for another to pay for my poor judgement and situations.



I would like to comment on the proposed fee increase that would be used to fund nurse health programs for treatment of RNs with substance use disorders and mental health disorders that may affect their ability to safely practice nursing.

I have read Senate Bill 379 and House Bill 4241 and did not find information that indicates the cost of these programs be covered by increasing the cost of licensure. I am interested in why the Board has chosen to increase the cost of licensure in order to fund these programs. The information in our newsletter indicates that this increase is required in order to establish this program as well as continue Board operations. These appear to be two separate and distinct issues and I don't feel they should have been "lumped together" when informing licensees of the fee increase.

I am not opposed to an increase in the fee in order to continue Board operations. I was also not opposed to the 2005 increase for the West Virginia Center for Nursing. I am, however, opposed to the fee increase for the establishment of the nurse health program. What is the projected income from these increases and what percentage of that income goes to Board operations versus establishment of nurse health programs? Are there other state boards of nursing that use license fees for this purpose?

I firmly believe that I should not have to pay for treatment of a condition (as in the case of substance abuse) which results from immoral, illegal, and unethical behavior. Frankly, I am incredulous at being asked to fund this program for this purpose. Without researching this statement, I feel comfortable in saying that programs are available for this type of treatment that are either taxpayer funded or available through medical insurance coverage.

The lack of accountability is becoming very pervasive in our society. This fee increase for the funding of nurse health programs is yet another example of the fact that personal accountability has become a foreign concept to many and has been replaced by a "it's not my fault and you need to fix it" mentality.

Please reconsider the use of increasing licensure fees to be used for this purpose.

### Dear Board,

I am responding to the news item concerning possible licensure increases for those nurses needing substance abuse and mental health treatments. I object!! To increase license fees by nearly 100% for this reason is ridiculous. A reasonable fee due to normal cost-of-living would be understandable, but to pay for rehab (which I truly believe it would be more this reason than just mental health issues) is very unfair. This is a slap in the face to many of us who have been dedicated, hardworking, ethical nurses, fully aware of our responsibilities from the day we graduated from school, not allowing any substance to jeopardize our jobs. I DO understand the needs of the mentally ill as I have worked 20 years in that aspect of nursing. I also FIRMLY believe a nurse KNOWS what he/she is doing when he/she makes a decision to use a substance and therefore, do not agree it is a "mental illness". Stealing a patient's medication, false documentation, or using on the job are some examples of crossing legality issues and deserve little mercy.

It is my observation that a nurse may receive treatment at his/her respective facility when needed and often more than one chance is afforded that nurse. By "allowing nurses to voluntarily enter into a program before there are effects on their nursing practice and without disciplinary action", as stated in the WV Nurse publication, is telling them "since you have not gotten caught yet", you may get help. Any willful, wrong action by such a nurse is illegal and that person should be disciplined according to the law. Those with "true" mental health issues are most often able to obtain the medication, hospitalization, and therapy they need.
