12 state rulemaking requirements by accepting comments on  
13 proposed revisions to rule 45CSR25 - *Control of Air*  
14 *Pollution from Hazardous Waste Treatment, Storage and*  
15 *Disposal Facilities*. This rule establishes and adopts  
16 emission standards for the treatment, storage and disposal  
17 of hazardous waste promulgated by the EPA pursuant to the  
18 Resource Conservation and Recovery Act. Promulgation of  
19 this rule will enable the Department of Environmental  
20 Protection to continue to be the primary enforcement  
21 authority for the Hazardous Waste Management System in West  
22 Virginia. Revisions to the rule included annual  
23 incorporation by reference updates.

#### **RESPONSE TO COMMENTS**

On June 5, 2015, the Division of Air Quality (DAQ) commenced a thirty day public comment period and subsequently held a public hearing on July 6, 2015 to accept oral comments on proposed revisions to legislative rule 45CSR25. Written comments were also accepted through 6:00 PM on Monday, July 6, 2015. No commenter submitted written comments regarding proposed revisions to rule 45CSR25, and no commenter provided relevant verbal comment.
