

## PROCEEDINGS

MS. JENNINGS: This public hearing will now come to order on this 1st day of August, 2016, at the West Virginia Department of Environmental Protection Headquarters. Comments and testimony will be accepted until the close of this hearing and will be made part of the rulemaking record. Any relevant question regarding revisions to the rules will be included with your comments, and any such question will be addressed as part of the response to comments in the rulemaking record.

The purpose of this public hearing is to accept comments on proposed revisions to rule 45CSR34 - Emission Standards for Hazardous Air Pollutants.

This rule incorporates and adopts national emission standards for hazardous air pollutants and other regulatory requirements promulgated by the EPA pursuant to the Federal Clean Air Act. Promulgation of this rule is necessary for the State to fulfill its responsibilities under the Clean Air Act, and will enable the Department of Environmental Protection to continue to be the primary enforcement authority for such national emission standards promulgated by EPA. Revisions to the rule include annual incorporation of Federal counterpart regulations. The rule

Proceedings incorporates by reference the national emission standards for hazardous air pollutants promulgated by EPA under 40 CFR Part 63, effective June 1, 2016.

The floor is now open for comments.
