This rule changes the number of hours necessary to obtain a barber/cosmetologist cross-over license. It also allows military barbers to obtain licensure in WV with their DD214 paperwork. It also creates a tiered barber license: 1200 barber (without chemical services) and a 1500 barber (with chemical services). The changes are necessary to conform to the changes to W. Va. Code 30-27-1 et seq. as set forth in Senate Bill 524.

LEGISLATIVE RULES
BOARD OF BARBERS AND COSMETOLOGISTS

SERIES 1
PROCEDURES, CRITERIA AND CURRICULA FOR EXAMINATION AND
LICENSURE OF BARBERS, COSMETOLOGISTS, NAIL TECHNICIANS, AESTHETICIANS,
AND HAIR STYLISTS

§ 3-1-1. General.

1.1. Scope. -- This legislative rule establishes the minimum licensing and curriculum requirements for barbers, cosmetologists, hair stylists, aestheticians, and manicurists.

1.2. Authority. -- W. Va. Code §§ 30-27-5 and 30-27-6.

1.3. Filing Date. -- ~~May 16, 2013.~~

1.4. Effective Date. -- ~~June 1, 2013.~~

1.5. Sunset Date. – Ten (10) years after effective date.

§ 3-1-2. License Requirement.

2.1. It is unlawful for any person to practice or offer to practice barbering, ~~beauty culture,~~ cosmetology, hair styling, manicuring, or aesthetics in this state without first obtaining a license for that purpose from the Board.

2.2. A person and student practicing barbering, cosmetology, hair styling, manicuring or aesthetics shall display his or her license or license renewal at the workstation the individual is currently working and shall exhibit the license to the board or its authorized representative.

2.3. In addition to the license that must be displayed ~~as provided for in Subsection 3.2, of this section,~~ every person practicing barbering, cosmetology, hair styling, manicuring or aesthetics in this state shall possess a ~~poCKET~~ government issued identification card containing the licensee's photograph.

§ 3-1-3. Qualification for Licensure.

3.1. An applicant for licensure shall present satisfactory evidence to the Board that he or she:

3.1.a. Is at least 18 years of age;

3.1.b. Is of good moral character and temperate habits;

3.1.c. Has completed at least the twelfth grade of public school or its equivalent, or has passed an ability to benefit test approved by the U.S. Dept. Of Education;

3.1.d. Has graduated from a school of barbering, hair styling, or cosmetology approved by the ~~Board,~~ WV Council for Community & Technical college Education (CCTCE), Department of Education in conjunction with CCTCE or Department of Education in conjunction with the Department of Corrections; or in the case of a manicurist or aesthetician, has successfully completed an approved course in manicuring or aesthetics in a school of cosmetology or graduated from a school of aesthetics or nail technology/manicuring;

- 3.1.e. Has passed the appropriate examination;
- 3.1.f. Has transmitted the appropriate application to the Board with the respective fee;
- and
- 3.1.g. Has presented a certificate of health from a licensed physician to the Board.
- 3.1.h. Is a citizen of the United State or is eligible for employment in the United States;
- 3.1.i. Has fulfilled any other requirement specified by the board.

§ 3-1-4. Minimum Curriculum for Barbers.

4.1. A barber student shall complete a course of study consisting of 1200 clock hours divided as specified in Table 3-1A of this rule to obtain a barber license.

4.2. A barber student shall complete a course of study consisting of 1500 clock hours divided as specified in Table 3-1B of this rule to obtain a barber license with chemical services.

4.23. All barber students shall have 250 clock hours before working on the general public in a licensed school.

§ 3-1-5. Minimum Curriculum for Cosmetologists.

5.1. A student shall complete a course of study consisting of a minimum of 1,800 clock hours divided as specified in Table 3-1BC of this rule to become licensed as a cosmetologist; and

5.2. A cosmetology student shall have at least 300 clock hours before working on the general public in a licensed school.

§ 3-1-6. Minimum Curriculum for Manicurists.

6.1. A student shall complete a course of study consisting of a minimum of 400 clock hours divided as specified in Table 3-1ED of this rule to become a licensed manicurist.

6.2. A manicuring student shall have at least 150 clock hours before working on the general public in a licensed school.

§ 3-1-7. Minimum Curriculum for Barbers to Obtain a Cross-Over Cosmetologist's License.

7.1. A barber student who has completed 1200 hours or a licensed barber, without chemical services, wishing to obtain a cross-over cosmetologist's license must complete ~~300~~ 200 clock hours consisting of the nail technology (~~Table 3-1C~~) and ~~500~~ 400 clock hours consisting of aesthetics (~~Table 3-1E~~) curriculums and ~~400~~ 300 clock hours of the "chemicals" course of cosmetology (Table 3-1BE) in this rule.

7.2. A barber student who has completed 1500 hours or a licensed barber, with chemical services, wishing to obtain a cross-over cosmetologist's license must complete 200 clock hours consisting of the nail technology and 400 clock hours consisting of aesthetics curriculums (Table 3-1E) in this rule.

7.23. The cross-over curriculum from barbering to cosmetology shall be taught in all approved West Virginia schools of cosmetology.

§ 3-1-8. Minimum Curriculum for Cosmetologists to Obtain a cross-Over Barber License.

8.1. A cosmetology student who has completed 1,800 hours of cosmetology or a licensed cosmetologist wishing to obtain a cross-over barber's license must complete a ~~100~~300 clock hour course specializing in just clipper cuts, shaving, and facial hair trimming.

8.2. The cross-over curriculum from cosmetology to barbering shall be taught in all approved West Virginia schools of barbering.

§ 3-1-9. Minimum Curriculum for Aestheticians.

9.1. A student shall complete a course of study consisting of a minimum of 600 clock hours divided as specified in Table 3-1EF of this rule to become a licensed aesthetician.

9.2. An aesthetic student shall have at least 200 clock hours before working on the general public in a licensed school.

§ 3-1-10. Minimum Curriculum for Hair Stylist.

10.1. A student shall complete a course of study consisting of a minimum of 1,000 clock hours divided as specified in Table 3-1FG of this rule to become a licensed hair stylist.

10.2. A hair stylist student shall have at least 250 clock hours before working on the general public in a licensed school.

§ 3-1-11. Reciprocity

11.1. A student who has previously attended school, or who has graduated from a school of barbering or cosmetology in another state, may receive credit towards the 1800 for cosmetologists, 1500 for barbering with chemical services, or 1200 for barbering clock requirement for graduation in this state if, on entrance into a school in this state, the student requests credit for hours obtained in another state and subsequently presents to the in-state school manager, credentials showing subjects studied and the hours of credit received, duly signed and certified by the manager of the school previously attended. The Board may also award credit to those applicants who can demonstrate work experience. The amount of credit awarded shall be 25 hours credit for each month or 300 hours credit for 1 year, not to exceed a total award of 50% of West Virginia's hour requirements.

11.2. The Board shall recognize reciprocity for military barbers with a DD214 and passage of the WV State Law exam.

§ 3-1-12. Administrative Due Process

12.1. A person adversely affected by the enforcement of this rule has the right to request a contested case hearing consistent with the provisions of W. Va. Code § 30-27-1 et seq. and § 29A-5-1 et seq.
