16 Be it enacted by the Legislature of West Virginia:

20 thirty-one-a (eight-b) (five), to read as follows:

21 ARTICLE 2. EXECUTIVE AGENCY AUTHORIZATION TO PROMULGATE
22 LEGISLATIVE RULES.

24 The legislative rules filed in the state register on the
25 seventh day of November, one thousand nine hundred eighty-six,
26 modified by the commissioner of banking to meet the objections of

1 the legislative rule-making review committee and refiled in the
2 state register on the eleventh day of December, one thousand nine
3 hundred eighty-six, relating to the commissioner of banking
4 (implementing the West Virginia community reinvestment act) are
5 authorized.

Senate Bill No. 379

(By Senator Tucker)

[Introduced February 5, 1987; referred to the Committee on BANKING AND INSURANCE ; then to the Committee on the Judiciary.]

A BILL to amend article two, chapter sixty-four of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section designated section thirty-one-a (eight-b) (five), relating to authorizing the commissioner of banking to promulgate legislative rules implementing the West Virginia community reinvestment act.

Be it enacted by the Legislature of West Virginia:

That article two, chapter sixty-two of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, designated section thirty-one-a (eight-b) (five), to read as follows:

ARTICLE 2. EXECUTIVE AGENCY AUTHORIZATION TO PROMULGATE LEGISLATIVE RULES.

§64-2-31a(8b)(5). Commissioner of banking.

The legislative rules filed in the state register on the seventh day of November, one thousand nine hundred eighty-six, modified by the commissioner of banking to meet the objections of

2 state register on the eleventh day of December, one thousand nine

5 authorized.
