Summary of Proposed Rule 1CSR1 Board Rules and Rules of Professional Conduct

The attached ***Board Rules and Rules of Professional Conduct*** were proposed as a result of changes in the Accountancy Law (W.Va. §30-9) earlier this year. The Rule adds definitions, modifies requirements and application procedures for examination and certification, includes an ethics course requirement for examination and continuing professional education, details reciprocal certificate requirements, reduces accounting corporation firm ownership requirements from sixty percent to a simple majority, and increases various certification, authorization and firm permit fees.

**3. Explanation of above estimates (including long-range effect):**

Please include any increase or decrease in fees in your estimated total revenues.

The Board of Accountancy has not increased its licensing fees since 1996. We have been able to sustain with this fee structure due to the increase in the number of substantial equivalency practitioners over the last few years. However, with the passage of the new Accountancy Law, the Board will no longer receive substantial equivalency practitioner fees - leaving a deficit of approximately \$25,000 annually. Our estimated total revenues for the next period included an increase in certificate application and renewal fees, firm permit and renewal fees, and authorizations to perform attest and compilation services and renewal fees with an estimated \$41,000 increase in fees. The \$41,000 increase minus the \$25,000 deficit from the previous year leaves us with an overall budget gain of \$16,000. However, within the next year, the Board will need to replace two computers that are aging, as well as contract for programming and implementation of a new licensee record keeping system. The software used by the current system is no longer supported by the provider and has no updates; therefore it will not interface with a new operating system. We estimate the new equipment, software, and data programming costs at a conservative \$40,000. This purchase would leave us \$24,000 in the red for the next fiscal period.

§1-1-1. General.

- 1.1. Scope. -- This Legislative rule establishes general rules for the regulation of certification, registration, authorization permitting and licensure of certified public accountants, ~~and the registration, and licensure, and authorization~~ of public accountants, and for the authorization and permitting of firms.
- 1.2. Authority. -- W. Va. Code §§29A-3 et. seq., 30-9-4(8) and 30-9-5.
- 1.3. Filing Date. -- ~~April 30, 2004.~~
- 1.4. Effective Date. -- ~~April 30, 2004.~~

§1-1-2. Definitions.

As used in this Rule, the following words and terms have the following meanings, unless the context clearly indicates otherwise:

- 2.1. "Accredited ~~school~~ college or university" means any ~~four-year, degree-granting college or university~~ institution accredited at the time of an applicant's degree or attendance by the:
  - a. Middle States Association of Colleges and Secondary Schools;
  - b. New England Association of Schools and Colleges;
  - c. North Central Association of Colleges and ~~Secondary~~ Schools;
  - d. Northwest ~~Association of Schools and Colleges~~ Commission on Colleges and Universities;
  - e. Southern Association of Colleges and Schools; or
  - f. Western Association of Schools and Colleges;
- 2.2. "Act" means the provisions of W. Va. Code §§30-9-1 et. seq.;
- 2.3. "AICPA" means the American Institute of Certified Public

Accountants or any successor organization as determined by the Board.

- 2.4. "Audit" means ~~an audit or other engagement that expresses~~ expressing an opinion about the fairness of presentation of financial statements ~~that is performed~~ in accordance with the Statements on Auditing Standards published by the AICPA or any applicable successor statement on standards published by the AICPA.
- 2.5. "Compilation services" means providing a service performed in accordance with the Statement on Standards for Accounting and Review Services published by the AICPA or any applicable successor statement on standards published by the AICPA, (i) that presents, in the form of a financial statement, information that is the representation of management without an expression of assurance on the statement ~~and (ii) that is performed in accordance with the Statements on Standards for Accounting and Review Services published by the AICPA or any applicable successor statement on standards published by the AICPA.~~ Provided, That this definition does not apply to the use of the term "compilation" in W. Va. Code §30-9-31.
- 2.6. "Examination," when used with reference to prospective financial statements, means ~~an engagement that expresses~~ expressing an opinion about the fairness of presentation of financial information in accordance with the ~~SSAE~~ Statement on Standards for Attestation Engagements published by the AICPA or any applicable successor statement on standards published by the AICPA.
- 2.7. "NASBA" means the National Association of State Boards of Accountancy or any successor organization as determined by the Board;
- 2.8. "NQAS" means the National Qualification Appraisal Service operated by NASBA or any successor or comparable service as determined by the Board.
- ~~2.9. "Out of state certificate" means a valid certificate as a certified public accountant or equivalent designation issued or renewed under the laws of another state. Provided, That "out of state certificate" does not include any certificate as a certified public accountant or equivalent designation that was issued or renewed solely by virtue of a holder's prior status as a public accountant or its equivalent in the state of issuance and not by virtue of the holder's having met the certification requirements of the state of issuance.~~
- 2.9. "Reciprocal certificate" means a certificate issued under reciprocal regulations of prior law or under Section 5 of this Rule to a certificate holder of another jurisdiction who

is either a resident of this state, has an office in this state, or is an employee of a firm or business entity in this state.

- 2.10. "Registrant" means a person registered pursuant to the Act and this Rule.
- 2.11. "Review" means a review of a financial statement that is performed in accordance with the Standards for Accounting and Review Services published by the AICPA or any applicable successor statement on standards published by the AICPA.
- 2.12. ~~An examination "Window" refers to a three-month period in which candidates have an opportunity to take the CPA examination during at least (comprised of two of the three months in which the examination is available to be taken and the remaining time one month in which the examination will not be offered while routine maintenance is performed and the item bank is refreshed). Thus, candidates will be able to test a minimum of two out of the three months within an examination window.~~

### **§1-1-3. Board Organization and Proceedings.**

- 3.1. At its first meeting after July 1 of each year, the Board shall elect a president, a vice president, a secretary, and an assistant secretary from among its members. All officers shall be elected for a term of one (1) year and each shall continue in office until his or her successor has been elected and qualified or until his or her term as a member of the Board expires.
- 3.2. The Board shall meet in Charleston or elsewhere in West Virginia as it may elect, at least twice each year, and shall remain in session as long as necessary in order to transact its business. Meetings shall be held upon notice by the president of the Board or by joint call of any three (3) of its members and may be held at any reasonable time or place designated in the notice of the meeting.
- 3.3. A majority of the Board constitutes a quorum for the transaction of business.
- 3.4. The Board shall establish an office in West Virginia, if it is considered necessary and desirable, to transact the day-to-day business of the Board and for the maintenance of its files and records. The Board shall designate one (1) of its principal officers or any other person as the executive officer in charge of its office and shall arrange his or her compensation in the form of a per diem allowance or as a salary. The executive officer, with the approval of the

Board, may employ such assistance as may be necessary for efficient performance of his or her duties.

- 3.5. The Board shall designate and cause to have prepared those forms it considers necessary or expedient to the discharge of its duties, the convenience of applicants for licensure, and the compilation of proper records. As soon as practicable after July 1 of each year the Board shall publish a roster showing the names and addresses of all holders of certificates, registrations, permits and authorizations during the fiscal year beginning on that date.

### §1-1-4. Certification.

- 4.1. The Board shall issue a certificate to any applicant of good moral character who satisfies ~~each of the requirements of this section.~~ A certificate will only be issued when all of the education, examination, and experience requirements listed in this ~~sSection~~ are met by the applicant.

a. ~~4.2. Good moral character.~~ ~~An applicant for certification shall have fiscal integrity and no history of acts involving dishonesty or acts which would constitute a violation of this Rule. The Board may deny certification upon a finding supported by clear and convincing evidence of a lack of good moral character.~~ Education -- The satisfactory completion of one hundred fifty semester hours or their equivalent conferred by an accredited college or university, the total education program to include an accounting concentration or its equivalent.

b. Examination - Passage of the uniform certified public accountant examination published by the American Institute of Certified Public Accountants or its successor and any additional examination required by the Board by rule that tests the applicant's knowledge of subjects related to the practice of accounting: Provided, That before applying for the examination required by this subsection, an applicant is required to have met the baccalaureate degree requirement but not the one hundred fifty semester hour requirement of 4.1.a. of this Rule.

~~(a) If the initial application for examination is made prior to February 15, 2000, the obtainment of a baccalaureate or equivalent degree conferred by an accredited school with a concentration in accounting or its equivalent. A qualified candidate shall submit an application on Board approved forms with the required documentation.~~

~~(b) If the initial application for examination is made on or~~

~~after February 15, 2000, the satisfactory completion of one hundred fifty (150) semester hours or their equivalent at an accredited school, including the obtainment of baccalaureate or higher degree.~~

~~(i)1.~~ Specific course requirements - As part of the required ~~one hundred fifty semester~~ hours to sit for the ~~, an examination,~~ an applicant shall have completed the following credit hours at the upper-division baccalaureate and/or graduate levels at an accredited college or university:

~~(A.)~~ at least twenty-seven (27) credit hours or equivalent quarter hours in accounting, excluding introductory accounting courses covering the principles of accounting components, including the minimum requirements in each of the following subject areas:

~~(1.)~~ six (6) credit hours in financial or intermediate accounting;

Experience - An applicant shall demonstrate at least one year of experience in the four-year period immediately preceding the application in providing any type of relevant service or advice involving the use of accounting, attest, compilation, management advisory, financial advisory, tax or consulting skills. The experience requirement may be satisfied by employment in private practice, government, industry, a not-for-profit organization, academia or public practice and must be verified by the holder of an active West Virginia certificate, a West Virginia registered public accountant or an out-of-state certificate.

~~4.4. An applicant shall satisfactorily complete the examination provided for in section 7 of this Rule.~~

~~4.5. An applicant shall demonstrate that he or she has one year of experience in the four year period immediately preceding his or her application in providing any type of service or advice involving the use of accounting, attestation, compilation, management advisory, financial advisory, tax or consulting skills.~~

~~(a)1. Experience may include private, government, industry, or public practice, as well as experience~~

~~in academia.~~ In evaluating the experience of the applicant, the Board shall consider the complexity and diversity of the work performed as well as any other factor the Board may consider relevant.

~~(b) The applicant shall have his or her experience verified to the Board by the holding of a certificate, registration or out of state certificate.~~

~~(i)2.~~ Any person who has been requested by the applicant to provide evidence of the applicant's experience shall comply with the request. Any person who refuses to provide evidence shall, upon request of the Board, explain in writing or in person the basis for his or her refusal.

**§1-1-5. Reciprocal Certificate Requirements Not Substantially Equivalent Certificate Requirements.**

5.1. Certified public accountants or their equivalent from other jurisdictions who intend to perform accounting services in this state and are either (1) a resident of this state, (2) have established a business in this state, or (3) are an employee of a firm or business entity in this state shall first make application for a reciprocal certificate and meet the applicable qualifications below:

a. Reciprocal Certificate Requirements for Substantial Equivalency Practitioners. The Board shall issue a reciprocal certificate to an applicant of good moral character who holds a valid out-of-state certificate if the state of issuance has certified public accountant certification requirements that are substantially

equivalent or the individual has qualifications substantially equivalent to the certified public accountant certification requirements of the Uniform Accountancy Act.

b. Reciprocal Certificate Requirements for Not Substantially Equivalent Practitioners. ~~5.1.~~ The Board shall issue a reciprocal certificate to an applicant of good moral character who holds a valid out-of-state certificate but who does not qualify for a certificate under the provision of W. Va. Code §30-9-9, if the applicant meets the following education, experience, examination and continuing education requirements:

~~(a)~~ 1. The applicant passed the examination required for issuance of the applicant's certificate with grades that would have been passing grades at the time in this state;

~~(b)~~ 2. Within the ten year period immediately preceding the application and after passing the examination upon which the applicant's certificate in the other state was based, the applicant has had one year of experience outside of this state of the type described in W. Va. Code §30-9-8(~~c~~3) and/or subdivision section 4.5 4.1.c. of this Rule; and

~~(c)~~ 3. If the applicant's out-of-state certificate was issued more than four years prior to the application for issuance of a certificate under this ~~s~~Section, that the applicant has fulfilled the continuing professional education requirements that would have been applicable under W. Va. Code §30-9-12(b) and subsection 87.3. of this Rule.

~~§1-1-6.~~ c. Reciprocal Certificate Requirements for Foreign Designations ~~Certificate Requirements.~~ ~~6.1.~~ The Board shall issue a reciprocal certificate to an applicant of good moral character who holds a foreign designation in public accountancy if:

~~(a)~~ 1. the foreign authority which granted the designation makes similar provision to allow a person who holds a valid certificate issued by this State to obtain such foreign authority's comparable designation;

~~(b)~~ 2. the foreign designation:

## §1-1-2019. Rules of Professional Conduct.

## 2019.1. Independence, Integrity, and Objectivity.

- (a.) A licensee or substantial equivalency practitioner shall be independent in the performance of professional services.
- (b.) In the performance of any professional service, a licensee or substantial equivalency practitioner shall maintain objectivity and integrity, shall be free of conflicts of interest, and shall not knowingly misrepresent facts or subordinate his or her judgment to others.

## 2019.2. General Standards; Accounting Principles.

- (a.) A licensee or substantial equivalency practitioner shall:
  - (1.) Undertake only those professional services that the licensee or substantial equivalency practitioner can reasonably expect to be completed with professional competence;
  - (2.) Exercise due professional care in the performance of professional services;
  - (3.) Adequately plan and supervise the performance of professional services; and
  - (4.) Obtain sufficient relevant data to afford a reasonable basis for conclusions or recommendations in relation to any professional services performed.
- (b.) A licensee or substantial equivalency practitioner who performs auditing, review, compilation, management advisory, tax, or other professional services shall comply with the recognized professional standards applicable to the services.
- (c.) A licensee or substantial equivalency practitioner shall not (1) express an opinion or state affirmatively that the financial statements or other financial data of any entity are presented in conformity with generally accepted accounting ~~principals~~principles or (2) state that he or she is not aware of any material modifications that should be made to the statements or data in order for them to be in conformity with generally accepted accounting principles, if the statements or data contain any departure from any accounting principle promulgated by bodies designated to establish the principles that has material effect on the statements or data taken as a whole. If, however, the statements or data contain a

departure and the licensee or substantial equivalency practitioner can demonstrate that due to unusual circumstances the financial statements or data would otherwise have been misleading, the licensee or substantial equivalency practitioner can comply with the Rule by describing the departure, and its approximate effects with the principle would result in a misleading statement.

### 2019.3. Responsibilities to Clients.

(a.) Except as provided in ~~s~~Section ~~1715~~ of this Rule, a licensee or substantial equivalency practitioner shall not disclose any confidential client information without the specific consent of the client. Members of a recognized investigative or disciplinary body and professional practice reviewers shall not use to their own advantage or disclose any licensee's or substantial equivalency practitioner's confidential client information that comes to their attention in carrying out their official responsibilities. However, this prohibition shall not restrict the exchange of information with a recognized investigative or disciplinary body or affect, in any way, compliance with a validly issued and enforceable subpoena or summons.

### 2019.4. Responsibilities to Colleagues [RESERVED]

### 2019.5. Other Responsibilities and Practices.

(a.) A licensee or substantial equivalency practitioner shall not commit an act that discredits the public accounting profession.

(b.) A licensee or substantial equivalency practitioner shall not seek to obtain clients by advertising or other forms of solicitation that are false, misleading, or deceptive. Solicitation by the use of coercion, over-reaching, or harassing conduct is prohibited.

~~(c) A licensee may practice public accounting only in the form of a proprietorship, a partnership, or a professional~~

~~corporation whose characteristics conform to this Rule. A licensee shall not practice public accounting under a firm name that is misleading. Names of one or more past partners or shareholders may be included in the firm name of a successor partnership or corporation. Also, a partner or shareholder surviving the death or withdrawal of all other partners or shareholders may continue to practice under a name which includes the name of past partners or shareholders for up to two years after becoming a sole practitioner.~~

I would like to address the proposed change to §1-1-7 paragraph 7.3 relating to continuing education.

Specifically I would like to offer opposition to the addition of two hours of ethics education to be required annually.

I currently hold a CPA certificate from Florida in addition to holding a CPA certificate from West Virginia.

Florida requires four hours of ethics CPE every two years.

Since Florida instituted the ethics CPE requirement I have taken the four hour ethics CPE twice. The first time it was somewhat informative. The second time it was truly a waste of time. I can only guess that when I have to take it in the future it will not be productive use of time.

My feeling is that during Enron and the other major accounting misdeeds several years ago there was a knee-jerk reaction to do something. Some states mandated ethics education for CPAs. I was very impressed that West Virginia did not jump on that bandwagon.

A person is basically ethical or unethical. A short CPE course will not change that.

Your rules provide that if someone performs unethical deeds he will lose his CPA certificate. A two hour CPE course will not instill ethics in an individual that he does not already have.

I also personally have a related concern. If the ethics CPE rule is adopted will I have to travel to West Virginia every year to take two hours of West Virginia ethics CPE in addition to the four hours of Florida ethics CPE I have to have every two years? This could be a burden for all licensees who live out of the state of West Virginia.

In response to the Notice re changes to the BOA Rules and Rules of Professional Conduct I do have a couple of thoughts. I like the addition of the mandatory ethics course requirements to sit for the CPA examination. I am very conservative and thorough when preparing any work to go "out-the-door". I take pride in being meticulous. If I do work for a client, I try to apply thorough thought, research and care for it to be done as *properly* as possible. We recently bought a house and have had a few contractors doing repairs and renovations. Some contractors are slack, they cut corners, the end product is so-so, or the walls get dirty while the sink is being fixed. They leave without cleaning up. Some contractors do the job perfectly - using levels, suggesting options, and leaving the place looking and working as it should. That's the difference. CPAs should be held to this higher standard - ethically and through their product. Lack of ethics I believe sometimes can temp a CPA to "just get the job done" so we can bill the client or because of a time crunch, or to "give the client what he wants", even if the final result is not kosher. Ethics...the discipline dealing with what is good and bad and with moral duty and obligation. Definitely, I like the additional ethics course requirement for those entering the profession so they may start on right path into our profession.

As for those who are and have been in the profession, they know better. I think for the most part, if their doing something unethical, they are just are willing to risk the chance of NOT getting caught..."Cost vs. Benefit". I do not think the additional courses will change how established CPAs chose to practice. This being said, I do not support the annual two-hour CPE ethics requirement. Further as a sole proprietor/tax preparer, this two hours could be spent on something that does change...tax law. I spoke with Barbara today (thank you Barbara for taking the time to speak with me), and Barbara informed me that the ethics course goes hand-in-hand with mobility. I realize surrounding states do require ethics courses, i.e. Ohio. Therefore, if CPE ethics hours are needed for mobility then I can see this, maybe just not so many. How about 2 hours every three years?

I started my business last year. Frankly, I love it. But the expense of getting started was hefty. There was the usual costs associated with office equipment and supplies. Another cost, a lost perk of switching from an employee to a sole proprietor, I now have to pay for my own CPE and AICPA/WWSCPAs/WVBOA/Huntington Chapter of the WWSCPAs dues. Also, I had to pay for my firm permit, LLC application fee and firm insurance. As my business grows I may begin preparing financial statements again, as I did when I was employed for years by two local firms. If I go that route, there is the additional cost of higher insurance, the Authorization to Perform Attest and/or Compilation Services, and peer review. Okay, so my point is this...it's expensive. So now, if the rates are increased on license renewals, firms permits, LLC applications, authorizations to perform attest and/or compilation services, it's even more expensive. The bigger firms may think the annual fees are just a drop in the bucket. Given that, is there any way to give the sole proprietor's a break with lower rate?

Those are my thoughts. Thank you for considering them.

Dear Sir or Madam,

I don't normally comment on items such as this. I have genuine confidence that those that take the time to serve generally have all of our best interests in mind and their opinions are of greater value than those of us that do not take the time to serve, and therefore, I don't usually complain or comment on items of change. Unfortunately, I must take exception with the proposed changes to section 7.3 of the Rules of Professional Conduct. I find the 2 hour per year ethics course a bit ridiculous. For those in large firms (that offer in-house CPE) or those in larger urban areas of the state (where most WV Society courses are held), meeting this requirements is rather easy since courses and sites are very accessible. An in-house firm CPE class can simply just reclassify part of their annual tax and or accounting CPE courses to meet the requirement. Small affordable lunch type CPE courses will be held in the larger cities which won't put a big time constraint on fulfilling the requirement to those that practice in the localities. However, for those of us that live and practice outside the large areas where courses are held or are members of small firms or sole practitioners that don't have access to in-house CPE, this puts an unfair burden on us.

The fact that we are unable to police our member's ethics as we have in the past is embarrassing. Our profession used to be one of high honor and integrity, but as you might imagine just by watching the business channels, we have sunk to the levels in public opinion of that of Lawyers. What a shame we have been reduced to that level. Who has created this problem for our profession? It is hard to argue with me in saying it is the larger firms. Who, due to in-house CPE manipulation, are least effected by this new rule change both financially and by time. Those of us out there trying to do the work that our profession has done in the same manner for generations that have had no part of the perceived ethic problems will be affected the most both in time and money.

If we must have ethic classes, why not make them on the same three year rolling period of CPE. Make it 2 hours ever three years instead of annually. Ethics are not an evolving subject that requires an annual interpretation. One could argue that every three years is still to frequent, but at least it would coincide with regular CPE reporting requirements.

- New section 7.1 - Certificant is spelled incorrectly as cerificant.
- New section 7.3 – Requiring two hours of annual ethics CPE seems unwarranted unless perhaps the license holder has been found to be in violation of the code of ethics or some specific ethical standard. In addition, it just results in requiring every license holder to carve out a small and unnecessary portion of his/her annual minimum CPE requirements for this specific topic/subject. It is already difficult enough to find relevant CPE hours locally without trying to find 2 hours related to ethics.
- New section 18 (b), (c) and (d) – Fees increases in general and, in particular, late fees seem excessively high.

Re: Annual Two-Hour Ethics CPE Requirement for CPA License Renewal (*See Attached*)

Gentlemen:

We object to the proposed rule change which will require a minimum of two hours of CPE ethics on an annual basis.

We object because we believe we do not need this requirement for our Firm.

We also believe that this requirement is not necessary for our professionals in West Virginia. Board member Jack Bodkin advises that there are about 2,000 CPAs in West Virginia and the Board only has about 15 ethics violations reported on an annual basis. That being the case, we believe such a rule is "overkill."

We further believe that this is a waste of valuable time, not to mention financial resources. Let's do the math: For 2,000 CPAs at two hours each, that equals 4,000 hours per year in perpetuity. If only 1% of these hours would be required—do the math and measure the waste of valuable time. Moreover, while the accounting rules and tax laws change constantly, the ethics requirements are fairly constant. So this further supports no annual CPE ethics requirement.

Let me also add that it is abundantly clear that we are already subject to ethical requirements through the Rules of the Board, AICPA, and the West Virginia Society of CPAs. If the Board still feels that there is a need that requires satisfaction, perhaps an educational effort by the Board in this regard might be appropriate.

We, therefore, respectfully request that you withdraw this proposed regulation.

However, I do not believe that the annual two-hour ethics requirement for CPE credit should be implemented. Considering the work load of a typical Accountant, it is sometimes difficult to ensure that the regular 40 hour CPE requirements are met. The annual two-hour CPE credit for ethics would not be as beneficial to the field as the class requirement for CPA candidates.

Clarification of the requirements for a reciprocal certificate would be appreciated.

I understand that an increase in licensing fees may be necessary, please keep in mind that some of the licensees are also state workers.

I hope these comments aid the Board in their decisions.


I offer the following comments on the proposed requirement that continuing education shall include at least two hours of ethics on an *annual* basis:

While I applaud the requirement for ethics education to be required on a regular basis I suggest that the burden on licensees would be significantly lessened and the intent of the proposed changes would still be met if the requirement for ethics education were able to be satisfied once in a rolling three-year period, similar to the existing requirement for 120 hours of continuing education in a three-year period, rather than annually. The Board might wish to increase the number of hours of ethics education required during this three-year period to ensure its objectives have been met.

The reasons for the above suggestion include the fact that I am currently living and working out of state and anticipate having to purchase continuing ethics education specifically to meet the proposed requirement. Since the proposal requires that ethics education include state-specific statutes, it would appear that this requirement would preclude acceptance by the Board of ethics education that might be required by any other states in which I am licensed as their requirements for continuing ethics education content likely include statutes specific to their states.

I appreciate the opportunity to comment on the proposed requirements.

I don't normally comment on items such as this. I have genuine confidence that those that take the time to serve generally have all of our best interests in mind and their opinions are of greater value than those of us that do not take the time to serve, and therefore, I don't usually complain or comment on items of change. Unfortunately, I must take exception with the proposed changes to section 7.3 of the Rules of Professional Conduct. I find the 2 hour per year ethics course a bit ridiculous. For those in large firms (that offer in-house CPE) or those in larger urban areas of the state (where most WV Society courses are held), meeting this requirements is rather easy since courses and sites are very accessible. An in-house firm CPE class can simply just reclassify part of their annual tax and or accounting CPE courses to meet the requirement. Small affordable lunch type CPE courses will be held in the larger cities which won't put a big time constraint on fulfilling the requirement to those that practice in the localities. However, for those of us that live and practice outside the large areas where courses are held or are members of small firms or sole practitioners that don't have access to in-house CPE, this puts an unfair burden on us.

The fact that we are unable to police our member's ethics as we have in the past is embarrassing. Our profession used to be one of high honor and integrity, but as you might imagine just by watching the business channels, we have sunk to the levels in public opinion of that of Lawyers. What a shame we have been reduced to that level. Who has created this problem for our profession? It is hard to argue with me in saying it is the larger firms. Who, due to in-house CPE manipulation, are least effected by this new rule change both financially and by time. Those of us out there trying to do the work that our profession has done in the same manner for generations that have had no part of the perceived ethic problems will be affected the most both in time and money.

If we must have ethic classes, why not make them on the same three year rolling period of CPE. Make it 2 hours ever three years instead of annually. Ethics are not an evolving subject that requires an annual interpretation. One could argue that every three

In response to the Notice re changes to the BOA Rules and Rules of Professional Conduct I do have a couple of thoughts. I like the addition of the mandatory ethics course requirements to sit for the CPA examination. I am very conservative and thorough when preparing any work to go "out-the-door". I take pride in being meticulous. If I do work for a client, I try to apply thorough thought, research and care for it to be done as *properly* as possible. We recently bought a house and have had a few contractors doing repairs and renovations. Some contractors are slack, they cut corners, the end product is so-so, or the walls get dirty while the sink is being fixed. They leave without cleaning up. Some contractors do the job perfectly - using levels, suggesting options, and leaving the place looking and working as it should. That's the difference. CPAs should be held to this higher standard - ethically and through their product. Lack of ethics I believe sometimes can temp a CPA to "just get the job done" so we can bill the client or because of a time crunch, or to "give the client what he wants", even if the final result is not kosher. Ethics...the discipline dealing with what is good and bad and with moral duty and obligation. Definitely, I like the additional ethics course requirement for those entering the profession so they may start on right path into our profession.

As for those who are and have been in the profession, they know better. I think for the most part, if their doing something unethical, they are just are willing to risk the chance of NOT getting caught..."Cost vs. Benefit". I do not think the additional courses will change how established CPAs chose to practice. This being said, I do not support the annual two-hour CPE ethics requirement. Further as a sole proprietor/tax preparer, this two hours could be spent on something that does change...tax law. I spoke with Barbara today (thank you Barbara for taking the time to speak with me), and Barbara informed me that the ethics course goes hand-in-hand with mobility. I realize surrounding states do require ethics courses, i.e. Ohio. Therefore, if CPE ethics hours are needed for mobility then I can see this, maybe just not so many. How about 2 hours every three years?

I started my business last year. Frankly, I love it. But the expense of getting started was hefty. There was the usual costs associated with office equipment and supplies. Another cost, a lost perk of switching from and employee to a sole

proprietor, I now have to pay for my own CPE and AICPA/WWSCPAs/WWBOA/Huntington Chapter of the WWSCPAs dues. Also, I had to pay for my firm permit, LLC application fee and firm insurance. As my business grows I may begin preparing financial statements again, as I did when I was employed for years by two local firms. If I go that route, there is the additional cost of higher insurance, the Authorization to Perform Attest and/or Compilation Services, and peer review. Okay, so my point is this...it's expensive. So now, if the rates are increased on license renewals, firms permits, LLC applications, authorizations to perform attest and/or compilation services, it's even more expensive. The bigger firms may think the annual fees are just a drop in the bucket. Given that, is there any way to give the sole proprietor's a break with lower rate?

Those are my thoughts. Thank you for considering them.

Regarding the proposed rule changes:

- New section 7.1 - Certificant is spelled incorrectly as cerificant.
- New section 7.3 - Requiring two hours of annual ethics CPE seems unwarranted unless perhaps the license holder has been found to be in violation of the code of ethics or some specific ethical standard. In addition, it just results in requiring every license holder to carve out a small and unnecessary portion of his/her annual minimum CPE requirements for this specific topic/subject. It is already difficult enough to find relevant CPE hours locally without trying to find 2 hours related to ethics.

However, I do not believe that the annual two-hour ethics requirement for CPE credit should be implemented. Considering the work load of a typical Accountant, it is sometimes difficult to ensure that the regular 40 hour CPE requirements are met. The annual two-hour CPE credit for ethics would not be as beneficial to the field as the class requirement for CPA candidates.

Clarification of the requirements for a reciprocal certificate would be appreciated.

I understand that an increase in licensing fees may be necessary, please keep in mind that some of the licensees are also state workers.

I hope these comments aid the Board in their decisions.

**AMENDMENTS TO THE PROPOSED RULE**

Board members held a teleconference on Tuesday, August 26, 2008 to consider comments received during the Proposed Rule Comment Period. As a result, the Board amended the Rules as follows:

1. The Board changed the CPE Ethics requirement to four hours in a rolling three year period.
2. The Board added clarifying language regarding the peer reviews requirement.

**REASONS FOR THE AMENDMENTS**

1. The Board considered all comments regarding the CPE ethics requirement and determined, that in order for the West Virginia Board of Accountancy to maintain its substantial equivalency status, it would be beneficial to adopt an CPE Ethics requirement.
2. Due to non-compliance with the Board's Peer Review requirement, the Board amended the language to clarify the Board's position.
3. It was brought to the attention of the Board that 1CSR 1.12.2.3 and 12.3.3. in the current Rules required the Board to accept applications for authorization from applicants who had been denied, suspended, revoked, on probation or censured. The Board changed the language to provide discretion when considering these applications.
