- 1. The Board would not be able to monitor relief veterinarian permits and since the Board has streamlined the application process and the ease of getting a license, temporary permits have been eliminate.

I don't care for the elimination of temp licenses, there should be something for temp licenses for relief veterinarians. I understand the initial intent of the clause and elimination of it Something as simple as license in good standing in home state, practicing for no more than X number of days consecutively at Y facility. Perhaps a \$50 relief license fee? Many states have similar clauses. We have a lot of neighboring states that we can potentially get relief doctors from, but it is often economically infeasible for them to attain a full license for a short relief stint. This would allow for a greater pool of relief veterinarians, allow hospitals to remain open caring for their patients, generating income and tax revenue. Perhaps it may attract more of them to attain full licensing and stay on at those hospitals.
