



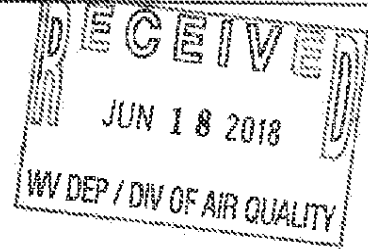

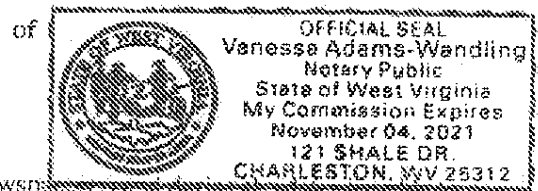

Military garrison in Brooklyn calls ICE agents on pizza delivery man

BYRON YORK — He went from delivering pizzas to being doled out by immigration officers. An immigration officer at a restaurant was calling a delivery man to an Army garrison in Brooklyn, where he was detained June 1 after a routine background check of the gate revealed there was a warrant for his arrest for immigration law violations, officials said.

Now, Felix Wittenberg is in immigration and Customs Enforcement custody pending removal from the country, ICE spokeswoman Rachael Young said.

Wittenberg's wife, Stefanie Choo, said he went to deliver pizza to Fort Hamilton last week and was asked for identification by the guard who released him. Wittenberg, who was spotted at Nixon Delish's pizzeria, an hour away by car in Queens, just

crossed a city identification card, but the official said he wanted to see a state driver's license.

An Army spokeswoman told The New York Times that it was unclear how long a return identification card, they have to get a pass that requires a background check. The check at Wittenberg's showed there was an ICE warrant on file, which would be confirmed by military police, said Fort Hamilton spokeswoman Catherine Samanterra.

"This is unfortunate," Choo said during a phone interview. "He was not committing any crime. He is a father who is working for his daughters. They are our daughters and my only thing that is not coming home."

Gen. Andrew Casano, commander, Wittenberg's detention, said he was in good luck against everything we believe in."

3 accept comments on proposed Rule 45CSR43, Cross-State Air
4 Pollution Rule to control annual nitrogen oxide
5 emissions, annual sulfur dioxide emissions, and ozone
6 season nitrogen oxide emissions. This is a new rule that
7 incorporates by reference the federal Cross-State Air
8 Pollution Rule, CSAPR, limiting emissions of nitrogen
9 oxides, NOx, and sulfur dioxide, SO2, through three
10 emissions trading programs. The trading programs
11 including the CSAPR Nox Annual Trading Program set forth
12 under 40 CFR part 97, subpart AAAAA. The CSAPR NOx Ozone
13 season group two trading program set forth under 40 CFR
14 part 97 subpart EEEEE and the CSAPRT SO2 Group One
15 Trading Program set forth under CFR - 40 CFR part 97,
16 subpart CCCCC.

17 This rule codifies general procedures and
18 criteria to implement these trading programs and adopts
19 and incorporates by reference these standards. Upon
20 authorization and promulgation of 45CSR43, the rule will
21 be submitted to the EPA as a revision to the State
22 Implementation Plan, or SIP, pursuant to the Federal
23 Clean Air Act.

24 The floor is now open for comments.
