

## West Virginia Sports Wagering Rule (Title 179 CSR Series 9)

**INTRODUCTION:** The following non-substantive changes have been made to establish consistency in the use of terms between this rule, the Sports Wagering Act, the State Lottery Act (W. Va. Code §§ 29-22-1 *et seq.*), and the State Lottery Rules (Title 179 CSR Series 1); to define previously undefined terms; to correct grammar mistakes; and to clarify certain sentences.
