§19-12-1. General.

1.1. Scope. -- This legislative Rule establishes the fees to be charged by the board for services rendered and the supplemental fee for the West Virginia center for nursing.

1.2. Authority. -- W. Va. §§ 30-7-4, 30-7-8a and 30-1-4.

1.3. Filing Date. -- ~~May 13, 2013~~

1.4. Effective Date. -- ~~June 12, 2013~~.

1.5. Sunset Date. – This rule will terminate and have no further force or effect upon the expiration of ten years from its effective date.
