This rule establishes the fees to be charged by the Board.

SUMMARIZE IN A CLEAR AND CONCISE MANNER CONTENTS OF CHANGES IN THE RULE AND A STATEMENT OF CIRCUMSTANCES REQUIRING THE RULE:

The purpose of the Rule change is to update the Rule and to be in compliance with W. Va. Code §26-3-1 Registration of Veterinary Technicians revisions and §30-1-22.3.d. Waiver of initial licensing fees for certain individuals.

Added definitions for low income and military families. Added veterinary technician inactive license fee. Added veterinary technician inactive license reactivation fee. Add performing euthanasia for euthanasia inspections that require inspections. Reduced the cost from \$300 to \$200 for facility inspection fee for ambulatory inspections. Modified Practice Act Booklet fee so there is no longer a fee if done online. Added waiver of fees for low income. Added waiver of fees for military families.

SUMMARIZE IN A CLEAR AND CONCISE MANNER THE OVERALL ECONOMIC IMPACT OF THE PROPOSED RULE:

A. ECONOMIC IMPACT ON REVENUES OF STATE GOVERNMENT:

It is difficult to calculate the expected revenue reduction because we have never collected income nor military information. Estimated total for low income and military = \$6200 CAETs 10 = \$3800 ; RVTs 9 = \$900; Veterinarians Military 5 = \$1500

Estimated total of ambulatory inspections reduced from \$300 to \$200 (50 Inspections) = \$5000

Estimated total of Registered Veterinary Technicians inactive status 10 renewals = \$550 Reduction of \$55 for each inactive status instead of \$80 renewals.

Total of all estimated reduced revenue = \$11,750

SCHEDULE OF FEES

§26-6-1. General.

1.1. Scope. -- This rule establishes the fees to be charged by the Board.

1.2. Authority. -- W. Va. Code §30-1-22. and W. Va. Code §30-10-6.

1.3. Filing Date. -- ~~April 23, 2018~~

1.4. Effective Date. -- ~~July 1, 2018.~~

1.5. Sunset Provision. -- This rule shall terminate and have no further force ~~on July 1, 2028.~~ or effect upon the expiration of 10 years from its effective date.

§26-6-2. Definitions.

2.1. "Initial" means obtaining a license in West Virginia for the practice of veterinary medicine, veterinary technology, or animal euthanasia technology for the first time.

2.2 "Local labor market" means every county in West Virginia, and any county outside of West Virginia if any portion of that county is within fifty miles of the border of West Virginia, pursuant to W.Va. Code §21-1C-2.

2.3. "Low-income individual" means an individual in the local labor market as defined in W. Va. Code §21-1C-2, whose household adjusted gross income is below 130 percent of the federal poverty line. This term also includes any person enrolled in a state or federal public assistance program including, but not limited to, the Temporary Assistance for Needy Families Program (TANF), Medicaid, or the Supplemental Nutrition Assistance Program (SNAP).

2.4. "Military families" means any person who serves as an active member of the armed forces of the United States, the National Guard, or a reserve component as described in 38 U. S. C. §101, honorably discharged veterans of those forces, and their spouses. This term also includes surviving spouses of deceased service members who have not remarried.

~~23.214.~~ All fees shall be payable to the West Virginia Board of Veterinary Medicine by check, cashier's check, money order, credit card or electronic transfer, if and when such credit card or electronic transfer services are available.

~~23.225.~~ All fees not received by the due date shall be assessed, a penalty, to be determined by the Board, not to exceed 25% of the original fee required.

~~2.23.~~ Upon approval of a waiver request, the Board shall waive fees for:

~~2.23.a.~~ Renewals of licenses, registrations or certifications for a military veteran, and their accompanying spouse, during their qualified deployment;

~~2.23.b.~~ Licensing, registration or certification for a military veteran and their accompanying spouse, for one year following their discharge from active duty;

~~2.23.c.~~ Inspection of a veterinary facility solely owned by a military veteran and/or their accompanying spouse, during their qualified deployment; and

~~2.23.d.~~ Inspection of a veterinary facility solely owned by a military veteran and/or their accompanying spouse, for one year following their discharge from active duty.

§26-6-4. Application for Waiver of Fees.

4.1. The Board may issue a license to an applicant who meets the requirements of W. Va. Code §30-31-1 et seq. and the rules promulgated by the Board, and the Board shall waive the initial licensure fee if the applicant qualifies as a "low-income individual" or as a member of one or more "military families" as defined in this rule.

4.2. Low-income individuals, as defined in this rule, may seek a waiver of the initial licensure, registration, or certification fee by submitting with their complete application a low-income waiver of initial licensure fee form, provided by the Board, and all required verification documents as prescribed by the Board. The Board shall review the application and issue a decision within 30 days of receipt of the complete application.

4.3. Military families, as defined in this rule, may seek a waiver of the initial or renewals of licensure, registration, or certification fee by submitting by submitting with their complete application a military service verification form, provided by the Board, and all required verification documents as prescribed by the Board. The Board shall review the application and issue a decision within 30 days of receipt of the complete application.

4.4. Military families, as defined in this rule, may seek a waiver of inspection fee of a veterinary facility solely owned by the licensee or registrant, by submitting by submitting with their complete application a military service verification form, provided by the Board, and all required verification documents as prescribed by the Board. The Board shall review the application and issue a decision within 30 days of receipt of the complete application.
