RE: Repeal of Series 21, 28, 32, 37, 39, 54, and 55 of Title 36; and Series 6 of Title 48 of the Code of State Rules

The Board of Coal Mine Health and Safety (hereinafter, the "Board") organized under the West Virginia Department of Commerce has voted to authorize the repeal of **SERIES 21, 28, 32, 37, 39, 54, 55 OF TITLE 36 AND SERIES 6 OF TITLE 48 OF THE CODE OF STATE RULES** pursuant to the regulatory review and reform initiatives established in West Virginia Code §29A-3-20 (2016) and Executive Order No. 3-18. The Board has determined that Series 21, 28, 32, 37, 39, 54, 55 of Title 36 and Series 6 of Title 48 of the Code of State Rules are outmoded, unnecessary and duplicative of the West Virginia Code.


