This rule regulates all pari-mutuel wagering occurring in West Virginia. The rule is expressly required by WV Code 19-23-6. The agency seeks to extend the sunset date for 5 years without any amendments to the rule at this time.

SUMMARIZE IN A CLEAR AND CONCISE MANNER THE REASONS FOR REQUESTING A SUNSET PROVISION EXTENSION:

The rule is set to expire on August 1, 2022 and needs to be extended inasmuch as WV Code 19-23-6 requires this rule.

SUMMARIZE IN A CLEAR AND CONCISE MANNER THE OVERALL ECONOMIC IMPACT OF THE RULE:

A. ECONOMIC IMPACT ON REVENUES OF STATE GOVERNMENT:

This rule has no impact on revenues to state government inasmuch as it merely regulates the types of pari-mutuel wagers that can be conducted. The statute authorizing pari-mutuel wagering in WV has been in existence in WV since the 1930s.
