- **repealed effective August 16, 2021, 126CSR163, Policy 5301, College Hours or Comparable Training in a Trade of Vocational School**, filed April 11, 2013, and effective May 13, 2013. Relevant portions of Policy 5301 have been incorporated into 126CSR146, Policy 5314, Service Personnel Classification, Competency Testing, and Professional Learning, filed July 15, 2021, and effective August 16, 2021.
