Welcome to the virtual public hearing on the West Virginia's proposed Legislative Rule 33C.S.R.1B – Standards for the Disposal of Coal Combustion Residuals in Landfills and Surface Impoundments.

This Legislative Rule adopts 40 CFR Part 257 Subpart D, Standards for the Disposal of Coal Combustion Residuals in Landfills and Surface Impoundments, by reference. This subpart applies to owners and operators of new and existing landfills and surface impoundments, including any lateral expansions of such units that dispose or otherwise engage in solid waste management of CCR generated from the combustion of coal at electric utilities and independent power producers. Unless otherwise provided in this subpart, these requirements also apply to disposal units located off-site of the electric utility or independent power producer. This subpart also applies to any practice that does not meet the definition of a beneficial use of CCR.

Except as otherwise provided, the regulations of the United States Environmental Protection Agency set forth in Subpart D of 40 CFR Part 257, promulgated as of October 4, 2016, wherein they exclusively relate to standards for the disposal of coal combustion residuals in

landfills and surface impoundments, are hereby incorporated as part of the West Virginia Solid Waste Management Regulations

West Virginia Rivers Coalition (WV Rivers), on behalf of our members, respectfully submit the following comments on the Legislative Rule 33 CSR 1B: Standards for the Disposal of Coal Combustion Residuals (CCR) in Landfills and Surface Impoundments.

Coal Ash ponds continue to pollute groundwater with cancer causing toxins in a state with the third highest cancer deaths rates in the country. This rule affects 7 facilities in WV, Mount Storm, Fort Martin, Harrison Power Station, Mitchell Plant, Pleasants Power Station, Mountaineer Plant and the John E. Amos Plant. With a combined total of 169 million cubic yards of coal ash waste, all seven facilities have found statistically significant increases in groundwater contaminants or previous impacts to surface water. Five of the facilities have unlined coal ash disposal ponds and three of the facilities have detected groundwater pollutants that are above state and/or federal standards including contaminants such as arsenic, barium, fluoride, molybdenum, lithium, and radium 226 and 228 that puts public health at risk.

These facilities are a threat to West Virginian's access to clean drinking water. The Mitchell Plant in Marshall County which has already been found to harm aquatic life, contains an unlined bottom ash pond that is located within the drinking water protection area for Sistersville Municipal water. The Mountaineer Plant which has an unlined bottom ash pond that is contributing to elevated levels of lithium in the groundwater is within the New Haven

Water department wellhead protection area. Additionally, the Pleasants Power Plant in Pleasants county contains an unlined coal ash disposal impoundment that is contaminating the groundwater with arsenic barium, fluoride lithium and Radium 226 and 228 and is located within the drinking water protection area for the City of Parkersburg. These facilities have known contamination issues that are posing unnecessary risks to drinking water supplies. DEP must provide adequate oversight of the CCR Rule to protect drinking water. It is inexcusable to allow these facilities to continue polluting water resources.

Additionally, we question whether WVDEP DWWM has adequate resources to manage the CCR program. WVDEP resources are already stretched thin; taking on oversight of the CCR program should come with additional funds to staff it. We appreciate your thorough consideration of these comments.

Additionally, we question whether WVDEP DWWM has adequate resources to manage the CCR program. WVDEP resources are already stretched thin; taking on oversight of the CCR program should come with additional funds to staff it. We appreciate your thorough consideration of these comments.

Response:

This Legislative Rule (33-1B) adopts the federally mandated 40 CFR Part 257 Subpart D, which is required to obtain closure and permitting primacy for the Coal Combustion Residual (CCR) program. With this primacy, the Agency is not intending to issue any additional permits for already permitted facilities. However, the Agency will modify/reissue the current permits and will incorporate appropriate new CCR requirements. At this moment, the Agency is not looking for new resource to implement the CCR program. In the future if it is determined that additional resources are necessary, the Agency will take appropriate steps to obtain the resources.
