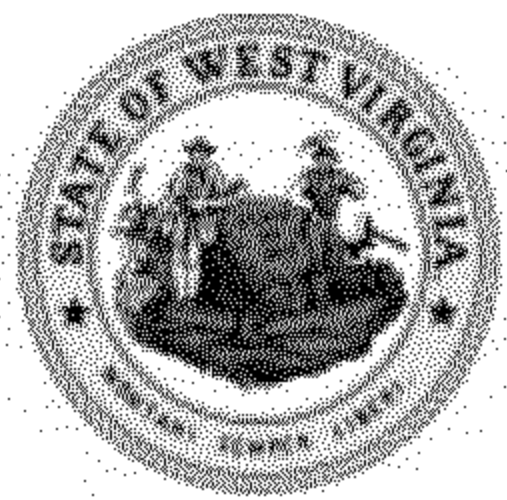

The rule implements the provisions of §17-2A-24 allowing the Division of Highways to implement its own merit based personnel system. There are no proposed changes.

SUMMARIZE IN A CLEAR AND CONCISE MANNER THE REASONS FOR REQUESTING A SUNSET PROVISION EXTENSION:

This rule is the basis of the DOH personnel system. We are proposing a new rule that will provide a merit based system for all DOT agencies. The enabling legislation goes into effect 1/1/22; the rule, 217CSR1, will be considered by the Legislature this session. The DOH rule needs to be in place until the DOT rule is approved.
