FEES FOR SERVICES RENDERED BY THE BOARD

§19-12-1. General.

1.1. Scope. -- This legislative Rule establishes the fees to be charged by the board for services rendered.

1.2. Authority. -- W. Va. §§ 30-7-4, 30-7-8a and 30-1-4.

1.3. Filing Date. -- ~~April 18, 2023.~~

1.4. Effective Date. -- ~~April 24, 2023.~~

1.5. Sunset Date. -- This rule will terminate and have no further force or effect upon August 1, 2033~~4~~.
