COURT REPORTER: I'm ready.

CHAIR: I've called to the order of the West Virginia State Fire Commission, the public hearing for 87CSR1. Roll call, please, I guess.

MS. BURNS: Commissioner Shriver?

1                   COMMISSIONER SHRIVER: Here.

2                   MS. BURNS: Commissioner White? Marshall  
3 Tyree?

4                   MR. TYREE: Present.

5                   MS. BURNS: And then in addition, we have  
6 counsel Bramlin, Felden, Ernest and Field Deputy Mark  
7 Stewart.

8                   COMMISSIONER SHRIVER:

9                   Okay. So as noted, this is the public  
10 hearing for 87CSR1 State Fire Code consideration of  
11 comments. Marshall Tyree or council?

12                   MR. TYREE: I think up until this point,  
13 unless there's someone else here, we've received public  
14 comments through Counselor Ernest, and other than that, I  
15 think the public hearing is set for anyone that wants to  
16 be present to make public comment. And I think the public  
17 comment period will close today at 5:00 p.m.

18                   And based on that, if no comments are  
19 received here, we'll have comments to present to the  
20 Commission next Tuesday, the 25th. And I'll note that  
21 we've received a couple public comments, so I've  
22 submitted one and there was another submitted, but other  
23 than that.

24                   COMMISSIONER SHRIVER: No one else is

1 present to submit a public comment in person. I presume  
2 that is an option, but no one.

3 MR. TYREE: Yes, yes. it is. I guess you  
4 can ask them on the line, make sure that they don't have  
5 any.

6 COMMISSIONER SHRIVER: Have anyone on the  
7 line have any comments relative to the State Fire Code  
8 being submitted?

9 COMMISSIONER GEORGE: Commissioner George  
10 has none.

11 COMMISSIONER EASTHAM: Commissioner  
12 Eastham has none.

13 COMMISSIONER SHRIVER: Kathryn, we only  
14 had two online.

15 MS. BURNS: Oh, no. There also online was  
16 Commissioner Jones, Commissioner George, Commissioner  
17 Eastham and Commissioner Keefer.

18 COMMISSIONER KEEFER: Commissioner Kiefer  
19 has no comments.

20 COMMISSIONER GEORGE: Kathryn, this is  
21 Commissioner George. Is there a separate phone line for  
22 members of the public or is this the phone line that  
23 everyone is on?

24 MS. BURNS: There is only the phone line

1 for the commissioners. There is no phone line for the  
2 public.

3 COMMISSIONER GEORGE: Thank you.

4 COMMISSIONER SHRIVER: Anyone wishing to  
5 speak would need to be here now.

6 MR. TYREE: And they were made aware of  
7 that.

8 COMMISSIONER SHRIVER: And all the  
9 stakeholders were made aware of that as well as on the  
10 Secretary of State's website.

11 MS. BURNS: Yes. I did speak to  
12 Appalachian Fire today and I believe that they plan on  
13 attending the special meeting. But they were aware of.

14 COURT REPORTER: Meaning the meeting right  
15 now?

16 MS. BURNS: No, the special meeting that  
17 we're having to discuss the comments for the special  
18 hearing. On the 25th.

19 COURT REPORTER: All the public comment  
20 periods will be closed then?

21 MS. BURNS: Uh-huh (yes).

22 MR. TYREE: Just go ahead to the next  
23 item.

24 COMMISSIONER SHRIVER: Consideration of

2 MR. TYREE: Yeah.

15 already received a notice, but the public notice is on  
16 the Secretary of State's website already. And the agenda  
17 will be set and put out as well.

18 COMMISSIONER SHRIVER: So as noted, we are  
19 adjourned.

20 MS. BURNS: Thank you.


