This rule establishes the fees to be charged by the Board. The only change is the sunset date.

The board operates only on the revenue collected by charging fees for registration. It receives no appropriated funds from the General Revenue Fund.

The fees collected are considered Special Revenue. The board generally operates close to a balanced budget annually, so the impact is minimal.

Fees have not changed in 20 years other than the addition of one fee and the addition of waivers for military families and low income applicants.
